### (a) 2010 Treasurer's Report

Treasurer Gowan presented a verbal report. Income for 2010 was \$5,632.19 while expenses were \$5,463.81.87 for a profit of \$168.38. However \$1,915.00 is outstanding from teams and will need to be paid as soon as possible. The bank balance stands at \$3,822.76.

# (b) Ontario Baseball Assn. Update

President Kinghan noted Secretary Anderson and him attended a meeting of senior teams with OBA in January. For provincial championships, another division has been created and division names changed. AAA is former A, AA is former B, A is former C, B is former D, and C is a new category.

Each Association will be permitted to only send two teams as each tournament will be capped at 12 teams, although additional teams may be permitted if spots need to be filled. The NDBL is part of York-Simcoe Association, and therefore play downs may be required as scheduled by York-Simcoe to determine representatives.

Champions and Finalists in classifications A and lower will be required to move up to the next level the following year.

# 5. BY-LAWS

It was MOVED by Past President Brownridge, THAT Article 24 be amended to read "When an altercation occurs involving an umpire and a player, coach, or manager, and in the umpire's decision, the behaviour of that person or persons warrants more than just a one game suspension, then the home plate umpire must contact the Statistician within twenty-four hours of the altercation. The League Executive shall then notify all parties involved, who shall be given twenty-four hours to discuss/defend the altercation with the League Executive. The League Executive shall make a decision not later than seventy-two hours from the initial report to the Statistician. There shall be no appeal to the Executive decision.", SECONDED by Fred Flood (Midland), CARRIED.

It was MOVED by Past President Brownridge, THAT Article 22 be suspended for the 2011 year to allow all senior teams wishing to apply for O.B.A. Playoffs to do so, SECONDED by Jesse McIntyre (New Lowell), CARRIED.

The Executive noted Article 8 will be strongly enforced this year regarding payment of League fees prior to first game of teams.
