### Discussions by area:

- September 16, 2014 meeting minutes Motion to approve by GHYLA Treasurer, Seconded by GHYLA US Lacrosse Representative for the Houston Chapter. Motion carried and the meeting minutes approved.
- Membership:
  - o West Houston <u>West Houston is an upstart program which will primarily feed Westside High School. There is one Katy ISD elementary school in the zone, Wolfe Elementary, which will feed Katy Taylor High School. The attached exhibit depicts the boundaries for West Houston.</u>
    - They will play at West Briar Middle School and Paul Revere Middle School.
    - They currently have 2 possibly 3 coaches available.
    - Working with the Westside High School program.

- The final number of teams entered into GHYLA is under review. They anticipate entering a team at 5<sup>th</sup>/6<sup>th</sup>, 7<sup>th</sup>/8<sup>th</sup>, and possible 4U.
- Motion by Sienna to accept West Houston as a provisional member, Seconded by Richmond. Motion carried and West Houston will be a provisional member for 2015.

Motion #1 – Motion to incorporate (4) conferences by Katy, seconded by Richmond. Motion carried and there will be (4) conferences for 2015.

Motion #2 – Motion to accept the proposed conferences noted above by Katy, seconded by Sienna. Motion carried and the above conferences will be used for 2015.

#### • Schedulina:

- o Clubs shall submit contact information to GHYLA for person(s) responsible for scheduling regular season games.
- Clubs shall develop regular season games prior to the scheduling meeting. The scheduling meeting will only confirm the schedule and fill in minor scheduling holes.
- o The scheduling meeting will be on January 8, 2015 at 6:00. The location is yet to be determined.
- o Playoff eligible teams must be declared prior to January 6, 2015.
- o Playoff eligible teams cannot be added or removed after the January scheduling meeting.

#### Uniforms:

- o Jerseys must include numbers on the front and back
- o Jersey colors must be close in color for players on the same team
- o Different helmet colors are acceptable

- Memorial Herman Sponsorship Memorial Herman has offered to sponsor GHYLA. This
  conflicts with the present arrangement for HYLAX at the South Campus. HYLAX will
  discuss with Methodist.
- Playoff location will continue at the South Campus fields.
- Clarification for 4U Rules 2U and 4U will play on a 40' x 80' field while playing 8 on 8; goalie, (2) defensemen, (3) middies, and (2) attack with will only require (1) official per game. The 4U field boundary lines, if not drawn completely on the field, should be augmented with flat cones to fill in any missing boundary lines.
   Motion by Richmond to accept the proposal above, seconded by Katy. The motion carried with 2U and 4U playing 8 on 8 on the reduced field of 40' wide x 80' long. Refer to the attached diagram for clarification.
- Preliminary regular season rosters shall be submitted to the Vice President for that level by January 16, 2015. The rosters shall include:
  - o Player name
  - o Address
  - o Current School
  - o Zoned High School
  - o Designated if the player received a waiver to play for that team
- Boundary exceptions for a player who lives in one recruiting boundary to play for a club
  in a different recruiting boundary still requires a waiver signed by the club president of
  both affected clubs.
- Rule Discussion:
  - o <u>Faceoffs will be modified</u>. The official will hold the ball, communicate down, place the ball, communicate set, then blow the whistle.
  - o Team certification will occur at the same time for both teams.
  - o Take-out checks will be a minimum 2 minute non-releasable penalty.
  - o Goalies will serve the penalty. The in-home will only serve a team penalty.
  - o The NOCSAE helmet issue was discussed. The officials will only ask the coaches once before the game to certify that their players are properly equipped, including the new helmet specifications.
- Items to discuss at the end of the season:
  - o Waivers for 6<sup>th</sup> grade and under
  - o Exception that goalies may play for two playoff eligible teams.
