



LIABILITY WAIVER, RELEASE, & INDEMNITY AGREEMENT

In consideration of being allowed to participate in any way in the GHYLA End of Season Tournament on HYLAX Lacrosse Fields at South Campus, the undersigned acknowledges, appreciates, and agrees that:

1. Each participant will be engaged in activities that involve risk of serious injury, including permanent disability or death, and severe social and economic losses resulting from (a) his/her own action, inaction, or negligence; (b) the action, inaction, or negligence of others; (c) the rules of play; (d) the condition of the premises; (e) the condition of any equipment used; or (f) other risks not known to us or not reasonably foreseeable at the time.
2. Each participant assumes all the foregoing risk and accepts personal responsibility for the damages following such injury, permanent disability, or death.

Any injury, permanent disability, death, and severe economic loss that may occur will not be the responsibility of SOUTH CAMPUS SPORTS ASSOCIATION, HOUSTON YOUTH LACROSSE ASSOCIATION, GREATER HOUSTON YOUTH LACROSSE ASSOCIATION, ST. CATHERINE'S MONTESSORI SCHOOL, U.S. LACROSSE, OFFICIALS AND ANY OFFICIALS ORGANIZATION, THEIR AFFILIATED CLUBS, their administrators, officers, directors, staff, coaches, agents, organizers, volunteers, and parents volunteers, OTHER PARTICIPANTS, SPONSORING AGENCIES, SPONSORS, ADVERTISERS, AND, IF APPLICABLE, OWNERS AND LESSORS OF THE PREMISES USED TO CONDUCT THE EVENT.

On behalf of my child and myself and for good and valuable consideration, including this writing and my child's participation in the GHYLA End of Season Tournament on HYLAX Lacrosse Fields at South Campus, the sufficiency of which consideration is acknowledged, **I HEREBY (A) RELEASE AND FOREVER DISCHARGE AND (B) AGREE TO DEFEND, INDEMNIFY, AND HOLD HARMLESS THE SOUTH CAMPUS SPORTS ASSOCIATION, HOUSTON YOUTH LACROSSE ASSOCIATION, ST. CATHERINE'S MONTESSORI SCHOOL, GREATER HOUSTON YOUTH LACROSSE ASSOCIATION, U.S. LACROSSE, OFFICIALS AND ANY OFFICIALS ORGANIZATION, THEIR AFFILIATED CLUBS THEIR ADMINISTRATORS OFFICERS, DIRECTORS, STAFF, COACHES, AGENTS, ORGANIZERS, VOLUNTEERS, AND PARENTS VOLUNTEERS, OTHER PARTICIPANTS, SPONSORING AGENCIES, SPONSORS, ADVERTISERS, AND, IF APPLICABLE, OWNERS AND LESSORS OF THE PREMISES USED TO CONDUCT THE EVENT, ALL OF WHICH ARE HEREINAFTER REFERRED TO AS "RELEASEES", FROM ANY AND ALL CLAIMS, DEMANDS, ACTIONS, LAWSUITS, DAMAGES, COSTS, EXPENSES, ATTORNEY'S FEES AND OTHER LIABILITIES ARISING FROM ANY AND ALL LIABILITY TO EACH OF THE UNDERSIGNED, HIS OR HER HEIRS AND NEXT OF KIN FOR ANY AND ALL CLAIMS, DEMANDS, LOSSES OR DAMAGES ON ACCOUNT OF INJURY, DEATH, OR DAMAGE TO PROPERTY, CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.**

The undersigned further hereby permits and authorizes the Releasees and others acting on their behalf, to use, reproduce and/or publish photographs and/or video that may pertain to the above-named child/children, including their image, likeness and/or voice, without compensation for advertising purposes.
6. This release and indemnity agreement shall be governed and construed under the laws of the State of Texas.
