C. WEIGHT CLASSES

The approximately 15 weight classes are set but may be changed as needed to fill as many rosters as possible. They shall be set proportionately and such that most teams can fill the weight classes.

In the event that we need to, a conference call will be held in order to make sure all rosters are full. The goal is to have as few forfeits as possible. If wrestlers have to be moved to a lower weight class or the weight class has to be changed to accommodate filling a hole in a roster, it will be done. In the event of moving a wrestler down and a

team have two wrestlers to choose from, the weaker of the two will be moved. Wrestlers moved down should not be more than 1 or 2 pounds away. Coaches will discuss and determine what's best for the league.

D. DESIGNATED FORFEIT

All forfeits shall be scored

The designated forfeit has been eliminated.

Thus teams have 3 choices:

1. Put someone out
2. Forfeit
3. Make arrangements with other coach to wrestle a scored match.

E. MATCH LENGTH

Match length for 2015 season will be 2-1-1 for all Dual Meets.

F. ROSTER AND RECORDS DATABASE

Chelmsford will be Roster Database Manager for the 2014-2015 Season. NO LATER THAN JANUARY 8, 2015, initial rosters must be submitted on the electronic form sent out by Scott McQuaide <mailto:scott.mcquaide@nationalgrid.com>

H. 2014-2015 SANCTIONED WEIGH-INS

Weigh-ins shall take place before the first meet on January 18, 2015 at North Andover High School. Exact times shall be sent prior to the event. Wrestlers must wear singlet or shorts on the scale.

February 1 is Super Bowl Sunday and every effort is being made to move this time ahead. Steve Lopilato will update as soon as he knows but he is confident that he can get in earlier.

It will also be incumbent on teams to show up early to help set up so that we can be in and out as efficiently as possible.

J. MVC QUAD MEETS (2)

All 8 Teams will wrestle (3 or 4) meets on two different dates (above) at North Andover High School. There will be 5 Mats wrestling in total for the duration of the meets. Four mats will be dedicated to the Duals meets and the 5th mat will be dedicated to JV bouts that will run concurrently with varsity meets. If a meet finishes early and teams are waiting for next opponent, those mats will be used for JV bouts also. Coaches are encouraged to use varsity wrestlers in JV bouts in order to assure that every kid gets a bout.

****Each team is required to provide table scorers for each meet.**

****Each team is required to provide a coach or parent to organize and pair up JV wrestlers.**

****At the conclusion of each team's last match the 2 teams on that mat are responsible for rolling and moving mats to North Andover's desired location.**

K. DUAL MEET LEAGUE CHAMPIONSHIP AWARDS

Championship team will receive t-shirts and a team banner that will be awarded at the conclusion of the last meet on February 1st. Team champion will receive thirty t-shirts and, at their own cost, can order additional shirts directly from vendor.

Pat Coughlin (Lowell) will be responsible for ordering Tee Shirts and Banner.

L. END OF YEAR TOURNAMENT

It was voted that there be no end of year Tourney.

M. WEBSITE POSTINGS

N. REFEREES

We agree to get our referees from Brian Bufagna to the extent that he can provide them on each requested date. We've agreed that we will pay the referees \$150 per event per Referee, based on 4 hours, but if goes a little under/over, same deal.
