Standing Rules Schedule B:

Tri-Town Boys Club Yearly Awards

Reviewed 03/24/2016 by the General Membership Meeting

This revision shall supersede all previous versions.

I. Basic Requirement

A. Fundraising

No awards will be given to any athlete who does not sell the required amount of fund-raising or pay the buy-out, which shall be set forth by the Ways & Means Director and the Executive Board. Each year there will be two (2) mandatory fundraisers. The first fundraiser will begin at initial registration. Late registrations will result in an automatic buy-out of the first mandatory fundraiser.

B. Code of Conduct

Throughout the season, athletes must adhere to Code of Conduct. If a player is removed from the squad due to misconduct, they will forfeit all awards for that season.

C. Attendance

Throughout the season, athletes must have adhered to the requirements outlined in Standing Rules Schedule A. In addition, athletes must be at 90% of the practices and games to qualify for awards unless they are excused by the head coach.

D. Equipment Return

Athletes must have returned equipment by the announced equipment return date or paid for any missing and damaged equipment before receiving awards. The equipment return policy is outlined in the Parent Handbook and in Standing Rules Schedule A.

II. Football Participation Awards

A. Awards shall only be provided, as outlined in the By-Laws and approved by the Executive Board.

B. Smurf Award

Each candidate participating in the Smurf Program will be awarded a Tri-Town Boys Club patch bearing the Smurf name and a medal neck medallion.

C. One Season Award

Each candidate completing their first season as a member of a Rink-Pony-Midget squad shall be awarded a Tri-Town Boys Club patch bearing the Rink-Pony-Midget name respectively.

D. Completion Award

Each candidate completing their second season for Rink-Pony-Midget squad shall be awarded a completion award, whose specifications have been approved by the Executive Board. Any midget qualifying for their fifth, sixth, or seventh Season Award will receive their Season Award in place of the Completion Award.

E. Sixth Season Award

Each candidate, who started in 2009 as a Second Year Smurf, that completes SIX (6) years in the Tri-Town Boys Club Program shall receive a special 6th year Completion trophy, whose specifications have been approved by the Executive Board.(Note: This is to accommodate the addition of the Smurf's Squad.)

F. Seventh Season Award

Each candidate, who started in 2009 or after as a First Year Smurf, that completes SEVEN (7) years in the Tri-Town Boys Club Program shall receive a special 7th, year Completion trophy, whose specifications have been approved by the Executive Board.

III. Cheerleading Participation Awards

A. Awards shall only be provided, as outlined in the By-Laws and approved by the Executive Board.

B. One Season Award

Each candidate completing their first season as a member of a Smurf-Rink-Pony-Midget squad shall be awarded a Tri-Town Boys Club patch bearing the Smurf-Rink-Pony-Midget name, respectively.

C. Two Season Award-Smurf-Midget

Each candidate completing their second season as a member of a Smurf or Midget squad shall be awarded a medal neck medallion.

D. Squad Completion Award

Each candidate completing their last season as a member of a Smurf-Rink-Pony-Midget squad shall be awarded a completion trophy, whose specifications have been approved by the Executive Board. Eligibility for a squad completion award may only be earned by completing all prior eligibility requirements. Any midget qualifying for their seventh eighth, ninth, or tenth Season Award will receive their Season Award in place of the Squad Completion Award.

E. Eighth Season Award

Each candidate, who started in 2009 but before 2013 as a First Year Smurf, that completes EIGHT (8) years in the Tri-Town Boys Club Program shall receive a special 8th, year Completion trophy, whose specifications have been approved by the Executive Board.

F. Ninth Season Award

Each candidate, who started in 2013 as a 5 year old Smurf, that completes NINE (9) years in the Tri-Town Boys Club Program shall receive a special 9th, year Completion trophy, whose specifications have been approved by the Executive Board.

G. Tenth Season Award

Each candidate, who started in 2013 or after as a 4 year old Smurf, that completes TEN (10) years in the Tri-Town Boys Club Program shall receive a special 10th, year Completion trophy, whose specifications have been approved by the Executive Board.

IV. Coaches Season Award

A. End of Season Coaches Participation Award

Coaches shall be awarded a plaque, whose specifications have been approved by the Executive Board.

V. Athlete's Jacket Awards

This award shall consist of a choice of a wool or nylon jacket, blue in color, bearing the Tri-Town name across the back. To earn the Jacket, athletes must have completed at least 4 years in the Tri-Town Boys Club Program or with documentation of participation in an equivalent program; of those four years, at least 1 of the years must have been on the Midget Squad.

VI. Football Championship Awards

A. Playoff Qualifier Trophy

This award is given to the JV/Varsity squad who qualifies for the playoffs, but doesn't make the championship game. Each player on the applicable JV/Varsity squad will receive a playoff qualifier trophy, whose specifications have been approved by the Executive Board.

B. League Championship

This award is given to the JV/Varsity squad who wins the Championship. Each player will receive a Championship Jacket appropriately embossed, whose specifications have been approved by the Executive Board. Coaches have the option to purchase a Championship Jacket. (Note: A runner-up trophy will be awarded to each player, if the championship game is not won.)

VII. Tri-Town Boy's Club Regular Season Cheerleading Awards

A. Cheerleading First Place Competition Award

When a Rink-Pony-Midget Cheerleading Squad participates in a Competition and takes first (1st) place, in which they defeat one or more other squads, the athletes shall receive a special cheerleading competition jacket, whose specifications have been approved by the Executive Board. Coaches have the option to purchase a Championship Jacket.

B. Cheerleading Smurf First Place Competition Award

When a Smurf Cheerleading Squad participates in a Competition and takes first (1st) place, in which they defeat one or more other squads, the athletes shall receive a medal neck medallion, whose specifications have been approved by the Executive Board.

VIII. Awards for Executive Officers, Directors, and Coaches

A. 4th Year Award:

After completing 4 years of service as an Executive Officer, Director, or Coach will be presented with a nylon or wool jacket, blue in color, with the Tri-Town name across the back.

B. 10th Year Award:

After completing 10 years of service an Executive Officer, Director, or Coach will be presented with a gift whose exact specifications and ordering instructions are determined by the Executive Board.

C. 15th Year Award:

After completing 15 years of service an Executive Officers, Director, or Coach will be presented with a wool jacket, blue in color, with gold sleeves, and the Tri-Town name across the back.

D. 20th Year Award:

After completing 20 years of service an Executive Officer, Director, or Coach will be presented with a ring, containing a blue stone, whose exact specifications and ordering instructions are held by the Treasurer.

IX. Special Awards

A. Greg Paules Award

The Greg Paules Award shall be awarded to the Head Varsity Football Coach with the most regular season and playoff victories combined. In the event of a tie, the Head Varsity Football Coach with the fewest points scored against him/her in regular season and playoff games shall receive this award. The original Greg Paules trophy will remain in the possession of the Club President and shall be engraved each year with the year and receiving Coach's name. The qualifying Coach will receive a miniature version of the original Greg Paules award.

B. League Sportsmanship Award

One candidate from the Smurf-Rink-Pony-Midget football squads shall be elected for the League Sportsmanship Award by the coaching staff of that respective squad. These candidates will be presented at the October General Membership meeting for voting on the one candidate to represent Tri-Town Boys Club for the League. Applications for nominated, eligible candidates shall be submitted to the Football AD prior to the October General Membership meeting.

C. Tri-Town Cheerleading Sportsmanship Award

One candidate from the Smurf-Rink-Pony-Midget cheerleading squads shall be elected for the Tri-Town Cheerleading Sportsmanship Award by the coaching staff of that respective squad. These candidates will be presented at the October General Membership meeting for voting. Applications for nominated, eligible candidates shall be submitted to the Cheerleading AD prior to the October General Membership meeting. The Award shall be presented to the winning candidate at the annual awards banquet.

D. Tri-Town Football Sportsmanship Award

The Tri-Town football player receiving the League Sportsmanship Award shall be recognized at the annual awards banquet and shall also receive a Club award whose specifications have been determined by the Executive Board.

X. Appeals:

In the event of a disagreement concerning an award, the Executive Board shall make the final determination by majority vote.

XI. Special Exceptions

Special Exception shall be granted to Athletes who have registered with Tri-Town Boys Club, but because of medical reasons they cannot

complete the season. The Executive Board shall determine the appropriate award in size and proportion.
