- 4. Please make sure all referees/umpires are getting paid the amount that was agreed upon. This has become a major obstacle and we need to make sure there is consistency.
- 5. All paperwork **must** be submitted within **30 days** of season ending. No payments will be processed past this time period, which will result in non payment of your services.
