### **AA EXPOS INCIDENT:**

- Board heard matter regarding incident involving the alleged action and conduct of the AA Expos Manager Paul Meinster during and proceeding AA Expos game on October 4, 2016.

# **MOTION:**

Proposed by David Allen and second by Mark Crawford to remove Kimberly Fergus from proceeding due to her position as the Expos, score keeper.

Board Vote: Approved unanimously; 8 of 11 members present.

- > STATEMENTS: Steve Ruley, Steve's minor son, Eve Paliotta.
- STATEMENTS: Paul Meinster, Paul's minor son, Gene Stunkel, Clint and Tina Weaver.
  - Copy of text message from October 5, 2016 between Paul Meinster and Steve Ruley is on file with SNLL Board of Directors.
  - Board advised Steve Ruley that allegation re: Paul pushing Steve's minor son, if he so chooses, would have to further be filed with Las Vegas Metro Police Department and/or as Civil Complaint.

## **BOARD DELIBERATION:**

Above actions took place after Paul's resignation to Nevada District 4 Little League representative Mike Aker and a number of board members on Oct. 6, 2016.

- Proposed to suspend Paul Meinster as a Coach/Manager for the remainder of Fall season 2016 based on manager's application, his actions post game Oct. 4, 2016, and actions occurring on Oct. 8, 2016, after his resignation on Oct. 6, 2016. Proposed motion does not effect his son's eligibility to play remainder of Fall season 2016. Paul Meinster is eligible to apply as a manager Spring 2017 and may be evaluated as a manager under regular manager review process.

Board Vote: Approved unanimously; 8 of 11 members present.

### **OLD BUSINESS:**

**Website:** Courtney Lane and Mark Crawford caught David Allen up to speed on meeting with software vendor and former SNLL President. David Allen is to contact vendor to schedule meeting time and demo for the entire board.
