

#### Dear friends in Christ,

What a whirlwind these past three months have been. So far I've been working on settling in and getting to know everyone. James and I thank all of you for welcoming us so warmly.

The Session and I have begun evaluating where we are, planning for the future, and taking care of some business left over from last year. This annual report and to-day's meeting are part of the last item. Normally, the report would have been finished and the meeting held sometime near the end of January or at the very latest, the first of February.

While we aren't far behind schedule, we are in the midst of one of the busiest times in the Christian year. From the earliest days of Christianity, the period from Ash Wednesday to Easter has stood as the pivot point for the rest of the church year. It has traditionally been a time for study and reflection on Jesus' last days before the crucifixion and on his resurrection. This year, we have been doing two things – completing last year's business and looking forward to Easter.

Despite the extra work involved in compressing two seasons of the congregation's life into one, things are going well. The nominating committee under Tywllah's leadership has put together a stellar slate of nominees for the vacancies on the Board of Deacons, the Session, and the Members-at-Large for the 2010 Nominating Committee. The Session members and Pat Erlewine, the 2009 Moderator of the Board of Deacons, have prepared annual reports for their areas of responsibility. We've also received a report from the Board of Deacons. Vicky Bair, our Stated Clerk, has devoted an extraordinary amount of time editing and compiling the Annual Report.

In the midst of all of this, the Personnel Committee, moderated by Peni Lloyd has hired a new church secretary, Len Stuzba. Len will begin working with us this Monday. He and his wife will be introduced to everyone next week during worship.

Even as I've been working with you to get the church's "house in order", I've been keenly aware of the particular tasks connected to interim ministry. Rev. Shinkle went over these with us at our February Fellowship Night.

#### They are:

- 1) Coming to terms with history
- 2) Discovering a new congregational identity
- 3) Facilitating shifts in lay leadership and changes in congregational power structures
- 4) Rethinking and renewing denominational linkages
- 5) Preparing for new pastoral leadership and a new future.

In the year ahead we will be exploring what these tasks entail. Please remember that we will often be working on several of the tasks at the same time. Most of all, remember that the tasks will take as long as they take, in other words, we can't rush

them. What we have to do is relax and trust that the Spirit will let us know where we are and what needs to happen next.

You might be wondering if we've done any work at all on completing the interim tasks. YES, we have. In 2009, the Session conducted a search for an interim pastor and to my great delight found one. As I've already mentioned, Rev. Shinkle held a question and answer session about Interim Ministry at our February Fellowship Meeting. February was a busy month for Interim work. Pat Erlewine served as our Commissioned Elder at Presbytery and several others attended all or part of that meeting, supporting me as I became a member of the Presbytery of Arkansas. Also, in February, I successfully completed the first week of Interim/Transitional Ministry training. Rest assured we are right on track.

I thank all of you for your openness, patience, humor and love.

Our church started with 86 active members. We gained 2 new members, lost 2 members by death and 16 members by other means which brings the active membership to 70. There are 7 inactive members, 19 baptized members which brings the total adherents to 93. There are 48 active women members. Leadership: Session (2 males, 4 females) and Deacons (1 male, 8 females).

Over the past year we saw many changes within the church, and these changes also affected the budget. Staff salaries were under budget since the secretary resigned, but when we hired a temporary secretary, these wages went into office since they were not included in payroll taxes and reporting, which caused office to go over budget. Pastoral went over budget due to the need for pulpit supply (guest ministers). Many areas also used "designated monies" to meet their expenses and thus keep the general expenses down. Property was down due to a decrease in insurance expenses and a drop in utility expense (propane).

The Presbytery of Arkansas, this year, sent a thank you letter for our contributions (on a monthly basis) to the Mission Benevolence fund. This is part of "Missions" as shown above.

The monthly financials are posted on the bulletin board in the office each month after session, and the previous month's reports are left up also. Please feel free at any time to read these reports and ask any questions of the financial committee you might have.

MISSION ENDOWMENT FUND
HIGHER EDUCATION SCHOLARSHIP FUND

These funds are administered in accordance with the overall financial objectives of the Church and implemented by the Finance Committee with recommendations and with final approval by the Session.

#### **Deacons Annual Report to Session for 2009**

We, the Board of Deacons believe we have faithfully fulfilled the responsibilities of the Deacons as outlined in the Book of Order. Acting as Guardian Angels to our church members and friends during 2009 we made 3600 contacts as follows:

Personal visits to the sick or ailing in the hospital, nursing homes, and shut-ins or others in need. (383)

Angels on Wheels assisted those in need of transportation. (75)

Made telephone calls to let our church family know we were there for them or to offer assistance. (1426)

Sent personal notes or cards on Birthdays, Anniversaries and most importantly to those who were sick or who had lost loved ones. (1540)

Sent "We Care Cards" signed by the congregation to those in nursing homes, shut-ins, on the "Special Prayers" list and those who were sick or disabled or had lost loved ones. Cards were sent to those serving in the military three times. (186)

Note cards were mailed to visitors and new members. A personal note was sent each week to our sister churches on the prayer list. Worship folders were sent each week to church members and friends missing Sunday church service.

The telephone prayer chain is administered by the Deacons. We are known as a "Praying Church" with the Prayer Chain being activated approximately 25 times during 2009. These prayers were both for church family members and others outside the church family.

When the family of a deceased member or friend request, the Deacons prepare a "Celebration of Life" gathering following the service. Most of these require the preparation and serving of food and coffee. (3 requested for Bill Lyons, Vi Sass and Dorie Black)

The Home Maintenance Angel deacon assisted those members who may need help with minor home maintenance repairs. (0)

A supply of soups or casseroles is available and delivered to members who cannot cook for themselves due to illness or released from the hospital, etc.

Deacons assist the Pastor in providing Communion to shut-ins and those in nursing homes or assisted care. (49)

At Christmas time, trays of cookies, candy and fruit were prepared and delivered to assisted living residents and to shut-ins. We delivered ten trays this year.

The annual Golden Opportunity Days were held in May. We selected as our local mission outreach project "The Food Pantry of Bull Shoals". We collected huge amount of groceries and paper products. A check for \$130 was also presented.

Our tasks are many and we are grateful for all the assistance, the support and the generosity received during the year from our church family.

In closing, I would like to thank all the Deacons for all their work they have done this year.

#### PRESBYTERIAN WOMEN

Presbyterian Women hold monthly meetings on the first Tuesday of the month. Every woman *(member, friend or visitor of our church)* is invited to attend. Fellowship includes special music, a devotional along with a short business meeting. Refreshments are served.

At our meetings, we collected for the following:

#### Birthday Offering - \$86.54

This is an offering to celebrate the blessings in the lives of Presbyterian Women. The offering funds up to five projects which are not included in ongoing General Assembly mission support, such as agricultural development, child care, community organization, criminal justice, drug counseling, economic justice, elderly care, employment training, homelessness, literacy, violence and women's concerns.

#### The Fellowship of the Least Coin (FLC) - \$79.55

This is an ecumenical prayer movement focused on peace, justice and reconciliation. These coins join many others from all parts of the world to advance the causes of justice, peace and reconciliation and to support a variety of projects that help women and children achieve a better life.

#### Cents-Ability - \$100.90

This is a small first step in the battle against hunger and poverty. These few cents personally given is an expression of thanks for what we have received. It is also a commitment to share with others in response to Jesus' command "You give them something to eat."

Our ladies were very busy in 2009.

Hosted a Spring luncheon & Fashion Show on April 27, 2009 and invited all the ladies from the surrounding churches to attend.

Held the following fundraisers:

Bake-less Bake Sale in March Ice Cream Social in May Baked Potato Bash in October

Participated in a weekly women's Bible Study. This year's Bible Study is taught by Rev. Terry Hart and is held immediately after Thursday Morning Community Coffee.

Contributed \$2875.47 toward Mission projects. Also hand-made hats, scarfs, quilts, pillows, baby hats, aprons, communion tray covers and favors for our luncheon worth over \$2000.00.

Our ladies also coordinate the annual Christmas gifts for the Flippin Headstart. Each child receives a package of undershirts, a package of underwear and a book. Extra goodies maybe included in their wrapped gift. Vicky Bair played elf and delivered gifts for 20 children *(9 boys & 11 girls)* worth \$390.47 just before Christmas vacation started.

Presbyterian Women are looking forward to a great year! Future activities include an "SWING Into SPRING" ladies' luncheon, Ice Cream Social, Baked Potato Bash and providing a Spaghetti Dinner for September's "Family Night" which will include a "Free Will" offering. Money donated will support our missions.
