Northeast Indiana Foundation, Inc. continued to work on the Vision 2020 initiative, whose goal is to align Northeast Indiana's economic development efforts around five key areas: 21st century talent, competitive business climate, entrepreneurship, infrastructure and quality of life. A major accomplishment for 2015 was the establishment of the Road to One Million Plan, which is a public-private partnership awarded by the State of Indiana that arose from collaboration from partners throughout Northeast Indiana. Because of the collective efforts from all partners, Northeast Indiana was awarded \$42 million for quality of life projects (amenities and attractions that will attract and retain young talent) to be implemented in the next four years.
