- There will be 1" all around canopy for sign to fit between canopy and roof of wall section
- Face on section 2 to overlap frame on section 1 for best seaming of sections, Sections secured together in field at time of install with mechanical fasteners to hold seam tight



Center Between End of Wall and Start of Door Way




