
**OWNER:** 36 N Water Realty Trust

**OVERVIEW:** The applicant, who is a new tenant to the building, is seeking to install signage to the front of the building.

**EXISTING CONDITIONS:** The Burroughs & Cushman Store was constructed c. 1820–1835 as a dry goods store run by Henry J.



**PROPOSAL:** The applicant is seeking to utilize the existing sign bracket and replace the current blade sign with an image of their business logo. The sign is proposed to be two sided, constructed of 1" thick PVC with high performance vinyl graphics. The size and shape of the proposed sign will remain the same as the existing sign and there is no associated lighting. **Refer to attached sign specifications.** 

**STATEMENT OF APPLICABLE GUIDELINES:** *The Bedford Landing District Design Guidelines* state the following relative to this proposal:

<u>SIGNAGE:</u> Signs should complement the architecture or site where they are placed as well as make a positive contribution to the District. The overall goal is to create signage which complements the architecture without creating visual clutter and which reflects the historic use of signage in the District.


- All signs shall be installed in such a manner as to ensure that the installation does not create damage or loss of historic fabric and that the installation is temporary or reversible.
- The size and shape of the sign should be proportionate with the scale of the structure.
- Sign materials should be chosen to complement the property that the sign identifies.



**STAFF RECOMMENDATION:** The proposed signage meets the design standards of the district and is appropriate and compatible to the property. Staff recommends the approval of the application and the issuance of a Certificate of Appropriateness.
