



MESSAGE FROM OUR CHIEF

In 2014, the Hobart Police Department put an emphasis on Code Enforcement Services for the city. Sgt. Ron Russo leads the way with his dedication to code complaints, as well as, a number of other responsibilities to the department. Sgt. Russo was involved in 607 new cases for the 2014 calendar year, 525 of which were reported by our citizens. Leo Finnerty assists in code enforcement due to the large volume of cases. In the summer, the cases per day skyrocket due to tall grass complaints. Usually tall grass complaints tend to accompany several other code violations that need addressed. We do assign patrol officers to assist in that area outside of their normal patrol responsibilities.

Of those cases, they obtained compliance in 325 of the cases, and 117 were determined to be unfounded. An unfounded result could be determined if, for instance, the condition was fixed prior to arrival. An unfounded result could also occur if a complaint did not necessarily violate a city ordinance. Of all the cases, 84 resulted in an enforcement action with a total of 121 different charges. Some were charged with more than 1 offense of the Hobart Municipal Code. There are some open cases still working their way through the Hobart City Court.

The ultimate goal of Code Enforcement Services is compliance with the city code. We prefer to get that cooperation by explaining the violation, the code that it violates, and how to correct the problem. Often times, this comes in the way of a private consultation with an officer and the property owner, and a written notice explaining the corrective measures needed. When compliance is not gained, we spend more time and resources taking enforcement action. Code violations can be expensive to the violator and may require a mandatory court appearance. In addition, some actions taken by the city to correct the violation for the property owner come with liens on the property for reimbursement of city expenses.

Code Enforcement does try to use community service workers to assist in the clean ups of abandoned properties. These are workers who have been sentenced to community service for committing a misdemeanor in Hobart City Court. Code Services with the assistance of the Hobart City Court organizes the work force, provides them with basic protective gear, and supervises their manual labor. The goal is to make the property look better for the neighborhood. We plan to expand their use in 2015.

The bulk of Code Services work comes from your complaints. We encourage you to let us know when violations occur. While you may have your own pet peeve, Sgt. Russo does try to advertise common complaints and solutions in his segment of this newsletter. You can reach him at (219) 942-1125 ext.1085. IC 9-21-8-59

Use of telecommunica- tions device while operating a moving motor vehicle

A person may not use a telecommunica-
tions device to:

- (1) type a text message or an electronic mail message;
 - (2) transmit a text message or an electronic mail message; or
 - (3) read a text message or an electronic mail message;
- while operating a moving motor vehicle unless the device is used in conjunction with hands free or voice operated technology, or unless the device is used to call 911 to report a bona fide emergency.

*All persons under the age of 18 are now banned from using any telecommunications device while operating a moving vehicle. Texting, talking, or even hands free, is not permitted.



Watch Out for Fake Gmail Messages in Your Inbox

Have a Gmail account? Watch out for scam emails posing as messages from Google. They may look like official notices about your account, but they carry malware.

How the Scam Works:

You receive an email that appears to be a message about your Google or Gmail account. One version of this scam informs you that “you have exceeded your email limit quota.” Another tells you that “you have a deferred email.” The text is hyperlinked in both, implying that you should click for more information. Don’t do it! Clicking on the link will download malware to your computer. Once on your machine, it can hunt through your files for personal and banking information. This opens you up to the possibility of ID theft. These scam emails are particularly tricky because they look so real. They have details like Google’s address in the footer. One version actually has a link to “unsubscribe” and “change my notification settings.” Be sure not to click these links because they also may contain malware.

How to Spot a Scam Email:

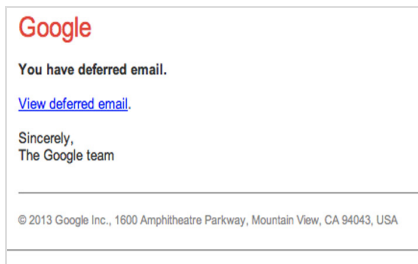
Check out the “From” field: Scammers have the ability to mask email addresses, making the message appear to come from a legitimate source. But they don’t always use it. In this scam, the “Google” emails aren’t actually from a @google.com address.

Watch for typos, strange phrasing and bad grammar. Scammers can easily copy a brand’s logo and email format, but awkward wording and poor grammar are typically a give away that the message is a scam. In the example above, the phrases “limit quota” and “deferred email” are a sign that something’s not right.

Hover over URLs to reveal their true destination. Typically, the hyperlinked text will say one thing, but the link will point somewhere else. Scammers either set up fake websites or hack into third-party sites and use them to host malware.

Watch for look alike URLs. Be wary of sites that have the brand name as a sub domain of another URL (i.e. brandname.scamwebsite.com) or part of a longer URL (i.e.companynamcustomersupport.com).

NIPSCO Warns of Bill Payment Scam

NIPSCO warns customers of a scam involving bill payments. Impersonators claiming to be NIPSCO employees call customers, tell them their bills are delinquent and request immediate payment to avoid a service disconnection.

Never give personal information, including Social Security numbers and banking information, to unconfirmed sources. NIPSCO only asks for a Social Security number when a customer is applying for new service or to validate an account holder when a customer calls to obtain account information, complete a transaction or service-related request over the phone.

NIPSCO officials stress customers should call the utility company’s 24-hour customer service center at 1-800-4NIPSCO (1-800-464-7726) with any questions about emails, phone calls, programs or other offers. Customers can also check the information printed on their most recent billing statement, call to speak with a customer service representative or register and view their bill on NIPSCO’s secure website. If you believe you’ve been the victim of a scam, notify your local authorities and financial institution immediately.

10 Ways to Avoid Tow Truck Scams

Imagine your car breaking down and being hauled by a tow truck to a repair shop, and then you get a bill for hundreds of dollars, maybe even \$1,000 before work even starts on your vehicle. It has happened. It's part of a growing scam involving unscrupulous tow truck operators and repair shops. In fact, according to the most recently available statistics covering 2010, the incidence of inflated towing bills almost doubled in a single year. These tow truck mavericks are opportunists who patrol freeways and other major highways and tune in to police alerts to learn about accidents and breakdowns. They turn up, often much to the relief of the car owner, and offer to take the vehicle in for repair. And before you know what's happened, you've signed an authorization form and get slapped with that huge bill. Scam tow truck operators are also likely in league with a local repair shop and collect a kickback when they bring in your car.

Here are seven tips to avoid becoming involved with these crooks:

1. If a tow truck operator arrives unsolicited on the scene (often they say they just happened to be passing) don't let him take your vehicle.
2. If police are on the scene, seek and follow their advice on towing.
3. Don't give your insurance details to a towing operator.
4. Also, don't give them any information about anyone who holds a lien on the vehicle.
5. Check tow truck signage against what appears on any documentation they provide.
6. If the truck doesn't have any signage, ask the driver to confirm the identity of the company.
7. If in doubt or if you feel threatened, call the police.
8. Make sure you know in advance what your insurance company says it will cover with regard to towing.
9. Get a price quote in writing before you let anyone tow your vehicle.
10. If you're not already a member of an emergency roadside assistance program, consider joining, especially before a long trip or travel in unfamiliar territory.
