On Monday, 03-30-15, at approximately 11:03 am I, Officer James Kipness of the Oak Ridge North PD, was dispatched to a Robbery Past. The reportee/victim advised MCSO Dispatch that she was driving north on IH-45 near Woodlands Pkwy. and her ex-boyfriend forcefully took \$20.00 from her. When she pulled over onto the shoulder of the main lanes, the actor then removed the key from the ignition and threw it out the window. She was able to retrieve the key and continue driving. The actor left on foot northbound on the IH-45 N/B frontage road. The reportee then exited the freeway and pulled into the parking lot of King Fuels located at IH-45 and Tamina Rd.

I arrived at the victim's location and observed a bleeding wound on her right wrist. I asked her how she got the wound and she advised that she wasn't sure, but it was possibly caused by her trying to retrieve her money back from the actor. I took photographs of the wound, which are included with this report. She identified herself as Camp, Kalleighia Miesha, B/F, dob /////, TX DL # //////. Ms. Camp advised that the actor is her ex-boyfriend named Travis Durst. She described him as a light skinned black male, muscular build, wearing a white shirt and white basketball shorts and heavily tattooed. She also advised that he might be armed with a handgun. I ran Mr. Durst on my MDT and he showed to have an address of 9062 Tamina Rd. His DL information showed TX DL # ///////, ///////. The information on Mr. Durst was aired and multiple units searched the area. Sgt. Mark Brockhoeft, (2810) of the Shenandoah Police Department, located Mr. Durst standing in front of an abandoned mobile home on Easley at Tamina. Sgt. Brockhoeft made contact with Mr. Durst and conducted a pat down due to the possibility of him being armed. Sgt. Brockhoeft detected a strong odor of marijuana on Mr. Durst's person and asked him if he had any contraband on his person. Mr. Durst replied that he had a couple of small bags of marijuana in his left front pocket. Sgt. Brockhoeft then detained him and retrieved two small bags of marijuana. Officer M. Teske, of the Oak Ridge North Police Department, placed Mr. Durst in his patrol car and transported him to King Fuels.

MCHD Medic 22 arrived on location and treated Ms. Camp's wound on her right wrist. I contacted the Montgomery County DA's intake office and spoke with ADA Jason Larman about the situation. He advised that robbery charges would be accepted and Mr. Durst was transported to MCSO South County Jail. Durst was very agitated and asked why he was being charged with robbery and that it was his money. Upon arrival, he advised the detention officer that he would not answer any of his questions. The detention officer then requested that Mr. Durst be transported to MCSO male booking in Conroe. I arrived at MCSO male booking

and Mr. Durst then agreed to answer questions for the booking paperwork. While conducting an inventory of Mr. Durst's property, I found \$58.80 in U.S. currency, but was unable to determine if any of it belonged to Ms. Camp. While at the jail, I filled out an Emergency Protective Order at the request of Ms. Camp. She advised that she works at the Lumber Liquidators kiosk at The Woodlands Mall and Mr. Durst works at PretzelMaker, which is in close proximity. I returned to service and weighed the two small bags marijuana using an Ohaus Dial-o-gram scale. The weight showed to be 5.5 grams. The marijuana was then packaged, labeled, and placed in the ORNPD evidence locker. End of narrative.

On 4/2/15 at 0250 hrs. I, Off. J. Walden #2734, was dispatched to a single motor vehicle crash at 26819 Westwood Dr. I arrived and observed a black BMW, bearing TX LP DRB7054, had driven through the fence of the residence and crashed into a tree in the back yard. The vehicle had extensive front end and front windshield damage, as well as air bag deployment. I observed tire tracks in the front yard of the residence which showed that the vehicle appeared as though it had been traveling westbound on Ridgewood Dr., failed to stop at the posted stop sign at Ridgewood and Westwood, and continued straight through the front yard of 26819 Westwood, going through the fence along the south side of the residence, before crashing into a tree in the back yard. A separate crash report (case #15P000290) will also be completed on the incident.

As I approached the vehicle, I could see that the driver was still seated in the driver's seat. Medic 22, who also arrived on scene, began to access the driver and her injuries. The driver was then identified by TN DL as Courtney Frazier, b/f, DOB //////. Frazier was incoherent and was not able to answer any of my or the EMS medics questions. As I attempted to speak to Frazier, she stated only that she had two other occupants in the vehicle with her at the time of the crash and was concerned for their whereabouts and safety. No other occupants of the vehicle were located. Frazier also stated she had consumed a glass of wine earlier in the night. As EMS attempted to work on Frazier, they stated they could detect an odor of alcohol emitting from Frazier's person. The vehicle also had a strong odor of alcohol throughout the interior. Frazier was then removed from the vehicle by EMS, placed on a stretcher, and transported to Memorial Hermann in The Woodlands for an evaluation with unknown injuries. Frazier's vehicle was towed from the scene by Milstead Automotive to 29707 West Hawthorne, Spring, TX 77386.

I contacted my supervisor, Sgt. Straight #2714, by telephone. Sgt. Straight told me to complete a crash report, as well as a DWI report, and that Frazier's blood records from the hospital could later be subpoenaed to determine her BAC and determine if charges of driving while intoxicated would be filed at a later time. Case will be forwarded to ORNPD Detectives for follow up.

On 04/04/2015 at approximately 0151 hours I, Officer Stafford, was dispatched by MCSO to a wreck located at 27100 IH 45 North. While driving to the location, I was advised that the reportee was sitting on the outside shoulder of the freeway. I was further advised that the other vehicle involved in the accident had fled the scene northbound on IH 45 about 6 minutes ago. Upon arriving to the location, I met with a white male identified as Robert Hernandez, from his Texas driver's license. Robert stated that he was driving in the lane to the right of the fast lane and just after passing under the overpass at Robinson, a vehicle hit him on the left rear quarter panel of the vehicle. Robert stated that when the vehicle hit him it caused him to swerve. He then pulled over to the outside shoulder and observed the other vehicle leave the scene. Robert stated that the vehicle was a Hyundai unknown model. He also believed that the vehicle was gray in color and he didn't get the license plate of the vehicle. After receiving this information, I then had MCSO dispatch issue a case number for the accident and provided Robert with the case number. A crash report was also completed and filed.

On 04/04/15 at 0300 hrs. I, Off. J. Walden #2734, was on routine patrol in the 26700 block of the IH 45 North Feeder Road when I observed two subjects walking northbound along the right hand side of the roadway. Both subjects were staggering as they walked, occasionally walking out into the path of traffic. I stopped and approached the subjects who were then identified as Nemesio Lopez, w/m, DOB ///// and Antonio Ortiz, w/m, DOB ////. Both men stated they were from out of state and in town to find construction work and that they were walking to their hotel on IH 45 and Hwy. 242. They said they were coming from the Taqueria Arandas Bar on Rayford Rd. As both Lopez and Ortiz spoke and attempted to answer my questions, I detected a strong odor of an alcoholic

beverage emitting from their breath and persons. Both subjects had slurred speech, glassy eyes, and unsteady balance. I determined that both subjects were a danger to themselves due to their level of intoxication and placed both subjects under arrest for public intoxication. Both subjects were then transported to the MCSO South County Jail where they were cited (ORNPD citation numbers: Lopez - 66400 and Ortiz - 66398) and booked for public intoxication.

On 04/06/2015 at approximately 1037 hours I, Officer Teske, observed a blue Volvo, displaying TX LP # CTP4519, traveling north on the IH 45 North Feeder Road near Woodlands Pkwy. A check of the license plate on my MDT revealed the registration expired January 2015 and the insurance was Unconfirmed - Not Available. I caught up to the vehicle on IH 45 North Feeder Road near Research Forest, and stopped the vehicle when the vehicle turned south onto IH 45 South Feeder Road. The vehicle came to a stop south of Research Forest in the parking lot of 9200 Pinecroft/Medical Plaza 3. The driver was identified by TX ID card # //// as Tyrhonda Buck, b/f, dob /////. She stated that she had a driver's license but it was expired. I asked if it was just expired or if it was suspended and she stated that it was just expired. She was unable to locate or provide me with an insurance card or any insurance information. A check on my MDT and through MCSO Dispatch revealed that her driver's license expired in 2006 and was currently suspended. Because of the suspension and lack of vehicle liability insurance, she was later issued citation 70639 through Montgomery County Court at Law #4 for the offense of Driving While License Invalid - enhanced with No Insurance. The court appearance date and time for this offense was April 29, 2015 at 9:00 AM. While I spoke with Buck, I observed what appeared to be a marijuana seed in the rubber window trim on the inside of the driver door. I had Buck step from the vehicle and asked her about the seed. She advised me that she does smoke marijuana. I asked if there was anything illegal in the vehicle and she stated there was not. I asked for consent to search the vehicle and she stated that I could do what I needed to do, and provided verbal consent to search the vehicle. I then had the passengers step from the vehicle. The front right passenger was identified by TDL # //// as Kewanna Jones, b/f, dob ////, and the back left passenger was Jones's 16 year old son. I then began a search of the vehicle. I located a black purse on the center hump of the rear floorboard that contained the following:

Two clear plastic bags that contained marijuana.

One clear plastic bag contained marijuana, two blue pills marked G3721 (Alprazolam/Xanax), and one yellow pill marked 3601 (Hydrocodone 325/10). I then showed Buck the black purse (that contained the marijuana and pills) and asked if the purse was hers, and she shook her head yes. I then placed Buck under arrest and had her sit in the rear of my patrol car. I advised Buck about the marijuana and the pills and she stated that she had a prescription for the pills that were in the purse. I was unable to locate a prescription inside the vehicle for any of the pills that I found in the purse. The vehicle was then released to Kewanna Jones. I began to transport Buck to the MCSO Female Intake for booking and Buck began talking about the marijuana and pills. I then read Buck the Miranda Warning and asked if she understood her rights. She stated, "yes, sir." I asked her if she wanted to talk to me and she asked, "about?" I advised her that I wanted to talk with her about the pills and weed/marijuana. She then stated, "I smoke weed," and something about "prescribed the pills to me. I need it." I asked her if she was going to take the pills and smoke the weed and she replied, "yes, sir," and stated something about that the ones that were separated. She then told me that she didn't realize that was in there, that it was supposed to be at home. She then ended with, "yeah, I smoke."

I transported Buck to female booking and she was booked on the charge of Possession of Marijuana, Possession of a Controlled Substance Penalty Group 3 (Alprazolam/Xanax), and Possession of a Controlled Substance Penalty Group 3 (Hydrocodone). Buck was issued ORNPD citation 105405 for the offenses of Display Expired License Plates (Reg) and Fail to Maintain Financial Responsibility.

After leaving the jail, I took the marijuana and pills to the ORNPD. I weighed the marijuana and pills using an Ohaus Dial O Gram scale. The marijuana weighed 24.1 grams. The two blue Alprazolam/Xanax pills weighed 0.1 grams. The one yellow Hydrocodone pill weighed 0.3 grams. The marijuana and pills were marked, tagged, and placed into evidence at the ORNPD.

On 04/06/2015 at approx. 1520 hrs. I, Detective Harrell, met with Aron Lozano at the Oak Ridge North Police Dept. in reference to a theft that had occurred approx. 45 min prior to her coming in to the Police Department to report the theft. Lozano advised that she was at the Teddy Bear park located in Oak Ridge North at 27207 Robinson Rd. from approx. 1300 hrs to 1445 hrs. and while she was inside

the fenced in children's park, an unknown individual took, without her permission or knowledge, a small bag from her purse that contained her medication. Lozano stated that while in the park, her son called her to him and away from the table she was sitting at. She left her purse at the table unattended at this time and was attending her son for approx. 15 - 20 minutes. During this time Lozano stated that there were about 6 children and 4 adults inside the park as well as a couple of teens on bikes that were in the parking lot area. The items taken consisted of a pink and purple striped bag that contained prescription medications including, Flexiril (10 mg), Zyprexa, and Vistaril (50 mg). Lozano stated that she realized the bag was missing from her purse after she left the park and was in her vehicle on her way home in Oak Ridge North at 27202 Wells Ln, Conroe, TX. 77385. Lozano checked her house for the bag of prescriptions once she arrived but they weren't at her house and her husband advised that she did in fact put them in her purse and take them with her.

On Monday, 04-06-15 at approximately 11:53 am I, Officer James Kipness of the Oak Ridge North Police Department, was dispatched to 322 Heather Ln. in reference to a Burglary in Progress. The residence is a two story red and white brick home at the southwest corner of Heather Ln. and N. Harlan Ln. and is uninhabited. Myself and Lt. Tom Libby proceeded to the scene with emergency lights and sirens activated. MSCO Dispatch advised that the reportee (Frank Norris) was an inspector for the mortgage company that owns the house and periodically checks the residence. He observed several backpacks in the back yard and entered the house through the back door. He then heard voices and what he thought were sounds of vandalism. Mr. Norris exited the home and called 911. While he was waiting for Police to arrive, he observed several teenaged males exit the front door of the residence and run west on Heather Ln. toward Patsy Ln. Myself and Lt. Libby arrived on Heather Ln. at approximately 12:00 pm and Lt. Libby located three teenaged males on Heather Ln. just east of Patsy Ln. I arrived at his location a short time later and instructed the individuals to sit down on the curb.

The three males were identified as JUVENILE 1, w/m, dob 12-02-99, TX DL # XXXXXXX, 15 years old; JUVENILE 2, h/m, dob 08-23-98, TX ID # XXXXXXX, 16 years old; and JUVENILE 3, w/m, dob XXXXX (No DL or ID), 14 years old. I asked them if there was anybody else who had been with them and they advised an individual named Juan Herrera had been with them, but they did not know where he was at that time. I contacted Officer Ken Rademacher with the Conroe ISD Police

Department who is assigned to Oak Ridge High School and advised him of the situation. I asked him if he would be able to provide information on JUVENILE 4, who I was informed attends the Oak Ridge Ninth Grade Campus. Officer Rademacher advised that JUVENILE 4's dob is 02-03-99, 16 years of age, and resides at XXXXX Big Holly Ln., Conroe, TX. 77385.

Detective Jim Ford of the Oak Ridge North Police Department took several photographs of the inside of the house and observed extensive damage to the interior. Mr. Norris provided a written statement to Lt. Kent Hubbard indicating that he observed damage to all rooms of the home. He concluded, based on his professional experience, that the extent of the damage was approximately \$50,000.00.

All three males were taken into custody and were transported to Montgomery County JP 3, Edie Connelly's office at 1520 Lake Front Cir. to be magistrated. Judge Connelly was unavailable, so the subjects were then transported to Montgomery County JP 2, Trey Spikes's office at 2241 N. 1st St. in Conroe. All three were magistrated by Judge Spikes, but only two provided a written statement. JUVENILE 2 exercised his 5th amendment right and did not provide a statement. JUVENILE 1 indicated in his statement that he was told by a friend named JUVENILE 5 that he and some friends had trashed a house and that he should go and see it. JUVENILE 1 then told JUVENILES 2,3 AND 4 about the house and they decided to check out the damage. They entered through the back door, which was unlocked, and went upstairs. They then saw a man who was talking on the phone staring at them. They exited the house, ran down the street, and stopped when they saw a Police car. JUVENILE 3'S written statement is similar to JUVENILE 1'S but does not mention JUVENILE 5. I contacted Officer Ken Rademacher in reference to JUVENILE 5. He informed me that JUVENILE 5'S dob is 03-26-98, 17 years old, and is a 10th grader at Oak Ridge High School. His address is XXXXX Prelude Springs Ln., Spring, TX. 77386.

The individual's were then transported to the Montgomery County Juvenile Detention Center and were released to detention officers. On Tuesday 4-7-15, I faxed copies of the law enforcement student arrest notification for each subect to the Conroe ISD Police Department. End of narrative.

On 04-05-2015 at approximately 0110 hours I, Officer McGrew, was working an approved extra job in full Oak Ridge North Police Department uniform at Main Event, located at 19441 IH 45. Main Event is an arcade, bowling alley, laser tag, billiards, and restaurant event center. I was working with Officer Helton with the

Oak Ridge North Police Department. While outside of the entrance conducting security checks of the parking lot, I observed two Main Event employees walk past me and into Main Event via the front entrance. I know the employees to be James Sheffield, Texas driver's license number XXXX, and Sara Swann, Texas driver's license number XXXXX, from my years of working at Main Event and previous experiences with Swann's ex-boyfriend XXXXXX, Texas driver's license number XXXXXX. As Sheffield and Swann walked by Officer Helton and I, I could detect a strong odor of raw marijuana coming from Sheffield's person. I observed by Officer Helton's physical facial features and statements that he also detected the marijuana odor. I observed that Sheffield had his shirt untucked and appeared to be getting ready to go home from work. At this time, I made contact with the General Manager of Main Event, "Charles", and advised him of the employee. As I spoke with Charles in the northwest corner of the parking lot, I observed Sheffield driving through the parking lot towards us in a blue Chevrolet Silverado pickup, bearing Texas license plate number AF77700. I flagged Sheffield down as he pulled closer. Sheffield stopped the blue Chevrolet a few feet from us. I walked over to talk with Sheffield and investigate the strong odor of raw marijuana I detected on his person.

As I approached Sheffield's vehicle, I observed Sheffield roll the driver's side window down. Sheffield was the only occupant in the truck. As Sheffield rolled the window down, I could detect a strong odor of raw marijuana now coming from his vehicle. I asked Sheffield if he had been smoking marijuana or had marijuana in his possession and he advised that he had not and did not. Sheffield appeared very nervous at this time. I could see Sheffield's heart visibly beating through his shirt. Due to the strong odor of raw marijuana coming from Sheffield's vehicle, I asked Sheffield to exit the vehicle for Officer safety and to conduct a further investigation into the marijuana odor. Sheffield complied and walked to the rear of his truck. While walking with Sheffield to the rear of his truck, I asked him again about the marijuana odor. Sheffield laughed nervously and then patted me on the back, stating that he did not have any marijuana with him. I advised Sheffield that I could smell the strong odor of marijuana coming from his person when he walked past me at the entrance to Main Event, and that I could smell the same strong odor of marijuana now coming from his vehicle. Sheffield looked at me and began to stammer his words. Officer Helton then called out to me from Sheffield's vehicle that he could see marijuana debris on the driver's side interior of Sheffield's vehicle, in plain view, from outside the truck. I advised Sheffield that based on the marijuana debris in his truck and

marijuana odors both on his person and in his vehicle, we were going to search his vehicle for marijuana. Sheffield then advised me that he had marijuana in the truck. Sheffield was not in custody at this time. I asked Sheffield where the marijuana was located and he stated that he had marijuana in a bag, in the center console of the truck. At this time, based on the odor, debris, and Sheffield's admission that he was in possession of marijuana; I detained him in hand restraints and advised him to sit down on the tail gate of his truck. Officer Helton then began a search of the truck for marijuana.

While searching the truck, I observed Officer Helton remove a clear plastic bag from the center console area of the truck that contained a green leafy substance that I know to be raw marijuana, from my training and experience as a Police Officer. The marijuana was later field tested and tested positive for marijuana. Due to Sheffield being in possession of marijuana, I placed him in custody for that offense. Sheffield's vehicle was released to another employee on location per his request. While running Sheffield through the Montgomery County Sheriff's Office radio dispatch for a warrants check, dispatch advised that Sheffield had been previously handled for possession of marijuana in a drug free zone. Sheffield did not show to have any outstanding warrants. Sheffield was transported to the Montgomery County Sheriff' Office, South Montgomery County Jail, located in The Woodlands, Texas by Officer Stafford of the Oak Ridge North Police Department. The marijuana was weighed, using a digital scale, and later entered into the Oak Ridge North Police Department evidence locker. The marijuana showed to weigh 6.6 grams.

On 04/08/15 at approximately 1525 hours I, Officer Kennerly, observed a 2007 Chrysler 300, bearing Texas license plate number FCT0236, at IH 45 South Feeder Road/Lake Robbins. I checked the for stolen on my mobile data computer and the insurance came unconfirmed for more than 45 days. I stopped the vehicle at Timberloch/IH 45 South Feeder. I approached the vehicle and identified myself and told the driver why I stopped him. I asked the driver, later identified as, Lyman Jones, Texas driver's license number XXXXX, for driver's license and proof of insurance. Jones gave me what appeared to be a valid insurance card, with an expiration date of 05/01/15, but after later calling Geico insurance company to confirm, I was advised by a Geico employee that the insurance had lapsed on 02/14/15. Jones then told me he did not have his wallet with him, because he forgot it, but he did have a driver's license. I then asked him for his name and date of birth. He stated his name was Icie Jones Jr. with a date of birth of

11/02/72. I went and checked that name on my mobile data computer and found no return. I went back up to Jones' vehicle to verify all my information was correct and it was. I also asked Jones if he was licensed out of Texas or another state. Jones advised he was licensed out of Arizona. I went back to see if I could get any information on an Icie Jones Jr, but still no return. I even had Montgomery County Radio Dispatch check and still found nothing by that name. After much searching, I advised Jones that he going to detained and taken to CJC in Conroe to be fingerprinted, so we could so we could make sure he was who he said he was. After putting hand restraints on him and walking him to my patrol car, he finally advised his wallet was in the middle of the console of the car. At that point, I found a wallet with a driver's license in it belonging to a Lyman Jones, with a Texas driver's license number of XXXXXX. Jones was then placed in custody for fail to ID. I checked Jones through Dispatch and he came back showing to have a Montgomery County Failure To Appear warrant number 500237 and a Capias Pro Fine warrant number 441744. The warrants were confirmed and Jones was transported to South County Jail for booking. Due to Jones failing to identify himself and showing to have a warrants, his charge enhanced to Fail To ID Fugitive. The vehicle was towed by South County Wrecker and stored at 28075 Robinson Road. The passenger, Bridgette Thomas, black female, date of birth XX/XX/70 and her grandson, who were in the vehicle, were given a courtesy transport to Mission Wood Apartments at Borough Park/Valleywood Road, by Oak Ridge North Officer McGrew.

While on patrol at approximately 2157 hours I, Sgt. Straight observed a motorcycle approaching at a high rate of speed on IH-45 North main lanes in the far left lane (#1 lane) and was changing to the far right lane. As the motorcycle started to pass by my location, I confirmed motorcycle speed by Lidar to be approximately 147mph in a 65mph zone. I traveled northbound on the IH-45 North east service road to see if the motorcycle was going to exit Research Forest and observed the motorcycle was slowing down due to slower traffic. The motorcycle then started weaving in and out of vehicles at a unsafe distance and accelerated at a high rate of speed once again. I continued northbound on the IH-45 North east service road and entered onto IH-45 North main lanes at Research Forest/Tamina. I observed the motorcycle continue to make unsafe lane changes and forcing some vehicles to jam on their brakes as he changed lanes at a unsafe distance in front of vehicles. I continued on IH-45 North main lanes until I was able to catch up to the motorcycle at IH-45 North and north of SH-242 and as I

pulled in behind the motorcycle I activated my emergency lights. After I activated my emergency lights, the motorcycle pulled to the outside(right) shoulder and came to a complete stop. I observed the black motorcycle did not display a license plate and the driver appeared to be a white male wearing a grey shirt, grey shorts, and a black and white helmet. I made contact with the operator of the motorcycle and identified him as Christopher Joseph Pirkl W/M XX/1995 TXDL# XX, who later stated he wanted to see what his motorcycle could do, because he just bought the motorcycle a month ago. I ran the vehicle identification number JKAZXCF16AA001812 engraved on the fork and the motorcycle is registered to subject Pirkl. The license plate that is registered to the motorcycle and should be displayed is TXLP# 893D3J.I notified the ADA and charges for Reckless Driving (Texas Transportation Code 545.401). Subject Pirkl was taken into custody for reckless driver and taken to south county jail. The motorcycle was towed by Ronnie's Wrecker in fair condition to 9131 Hwy 242 Conroe TX 77385. Subject Pirkl was also issued citation# 423442 for speed 147/65, no license plate, and no motorcycle endorsement.

On 4-9-2015 at approximately 1805 hours I, Officer McGrew, was dispatched to a welfare check at 27234 Jimmy Ln., the Nance residence. The notes advised that a caller, who identified himself as Joseph Nance, called 911 advising that someone was en route to his residence to kill him. At some point during the call, Nance's mother spoke on the phone advising dispatch that her son is mentally ill and that there was no emergency.

Upon arrival to the location, I observed a white male who I know to be Nance from previous encounters, standing in the street. I parked my patrol vehicle just west of the residence, exited, and approached Nance on foot. I asked Nance what was going on. Nance advised that he needed someone to provide protection for his life. Nance said that he recently got the job and that he was now in fear for his life. I asked Nance about the job that he said he was given. Nance advised that President Barack Obama was giving him the presidency and that he was worried that someone would try to kill him now. I asked Nance if he had taken his medication and he advised that he had. I asked him if he had taken or consumed illegal drugs today and he advised that he had not. I asked Nance if he wanted to harm himself and he advised that he did not. I made contact with Nance's mother who said that Nance had called us. She said that she had just picked Nance up from jail. She stated that they had been home short while when Nance called 911.

I asked Mrs. Nance if anything else had taken place and she advised that there had not been any violence or threats of violence. I advised Nance not to call 911 unless of an emergency.

On 04-10-2015 at approximately 2000 hours, I Officer Helton, was dispatched to a found property call. I arrived on location at 26535 Hillside Dr. the Marilyn Edar park, I was waved down by a white male, by the basketball court. The male was identified as Sean Stahl white male date of birth XX/2002. Stahl stated that he found a black phone sitting on the wall by the trash can at the basket ball court. Stahl stated that he has been there for a few hours and the phone never rang and no one came to look for the phone.

I asked Stahl for the phone and I contacted The Montgomery County Sheriff Office dispatch and ran the serial number of the phone to check it for stolen. I was advised by dispatch that the phone was not stolen. The phone had a password lock on the screen and no service indicator. The phone is a HTC smart phone, black in color and in good condition, with no case on the phone. The model number is 0P90110 and the serial number is NM80P90110. Due to the phone being in a public place and there was no one at the location that knew who owed the phone, I took possession of the phone and placed the phone in the Oak Ridge North evidence locker for safe keeping.
