

On 06/28/2016 at approximately 0745 hours I, Officer H. Richard along with Officer Teske, arrived on scene at 3737 Watonga Blvd in Houston, Texas, to assist Sgt. Nation and Officer Rogers in the execution of a search warrant and arrest warrant at apartment #29. We were searching for Chenevial Montrice Gill, b/f, DOB xx. I made contact with the defendant's mother, Brenda Gill, b/f, DOB xx. In addition, Chenevial's vehicle, a silver Mercedes, displaying TX LP # GWR6617, was parked in the parking lot. With the help of Brenda, we discovered the whereabouts of Chenevial. We found her at 7637 Charlesmont Street in Houston, Texas, living with Carlys Cooper, b/m, DOB xx. We arrived at that location at 1036 hours and made contact with Chenevial in the driveway. She was detained and the Montgomery County Warrant Division confirmed the following warrant, #16-06-07379 for Fraudulent Use of Identifying Information. I placed Chenevial under arrest and placed her into the rear of my patrol car. I transported her back to 3737 Watonga Blvd for paperwork and then to the MCSO Female intake for booking. **(Chief's note: This was the follow up by Detectives on a case where a female stole/defrauded 12,000 dollars' worth of furniture from the Rooms to Go Store. Detectives identified the suspect and obtained the arrest and search warrant from her apartment. Detectives recovered all the stolen property and arrested the suspect.)**

On 06/30/2016 at approximately 2247 hours I, Officer Stafford (Unit 2723), was sitting in the 26400 block of the IH 45 North feeder. I observed a white Isuzu Rodeo, bearing Texas license plate GCK6734, pull out of the parking lot of a business just south of the City of Oak Ridge North city limits. As the vehicle passed my location, I observed that the vehicle had a defective license plate lamp. The vehicle then turned onto Spring Pines. I was able to catch up to the vehicle as it turned from Spring Pines onto Maplewood. When the vehicle got to Maplewood and Heatherwood, I activated my emergency lights and stopped the vehicle on Heatherwood just west of Maplewood.

I exited my patrol vehicle and made contact with a white male, identified as Samuel Ray Pangle (DOB xx) from his Texas driver's license. While speaking with the male, I could smell the odor of unburnt marijuana coming from the open driver's side window. I asked Pangle to exit the vehicle and stand at the front of my patrol vehicle. I asked if he had any marijuana in the vehicle and he stated that he didn't. I informed Pangle that I was going to search the vehicle, since I was able to smell the odor of unburnt marijuana.

Upon starting the search, I noticed two small pieces of marijuana just under the ash tray of the vehicle. I pulled out the ash tray and found a clear bag that contained a green leafy substance, that I was able to identify as marijuana from my training and experience as a Police Officer. After locating the marijuana, I placed Pangle under arrest and transported him to MCSO South County Jail without any further incident. Once we arrived at the jail, I issued Pangle an Oak Ridge North citation 805758 for no license plate light. Pangle's vehicle was towed by Towncenter Towing, chip # 74, to 28075 Robinson Road in poor condition. Pangle is aware of the tow location.

After placing Pangle in jail, I returned to the Oak Ridge North PD and weighed the marijuana using an Ohaus triple beam balance. The marijuana had a total weight of 1.5 grams. The marijuana was placed into the Oak Ridge North PD evidence locker.

End Report.

On 07/01/2016 at approximately 0043 hours I, Officer Stafford (Unit 2723), observed a red Dodge Ram Charger, bearing Texas license plate FCS5972, that had turned westbound onto Robinson Road from Hanna Road. I got behind the vehicle and ran the license plate through my on board computer. The return showed that the insurance had expired in 05/16.

I activated my emergency lights and stopped the vehicle at 145 Robinson Road in the Valero parking lot. I exited my patrol vehicle and made contact with a white male driver, identified as Matthew John Quigley (DOB xx) from his Texas Identification card. While speaking with Matthew, he stated that his license was suspended.

I returned to my patrol vehicle and ran Matthew through the database. I confirmed that his license was suspended for numerous driving while license invalid convictions. I notified MCSO Dispatch and had them check the subject for active warrants. I received a return from Dispatch that Matthew had an active warrant for his arrest through Montgomery County Precinct 3 for failure to appear, #576230, with a fine amount of \$410.00. After the warrant was

confirmed, Matthew was placed under arrest and transported to MCSO South County Jail without any further incident.

Matthew's vehicle was towed by Towncenter Towing, chip # 74, to 28075 Robinson Road in poor condition. After arriving at the jail, Matthew was issued a citation through Montgomery County Court of Law #5 for Driving While License Invalid, with previous convictions, with an appearance date of 07/27/2016 at 9:00 am.

On 07-01-2016 at approx. 0910 hours I, Officer R. E. Craig III, was on routine patrol when I was contacted on the radio by Lt. Libby, also with the Oak Ridge North PD. He stated that he had received a public service call about a Natural Death call at 231 Ridgewood Drive. The address of 231 Ridgewood, Oak Ridge North, Texas 77385 is a Hospice facility operating under the name of Ultimate Care Homes. The facility is operated by Deborah Thornton, W/F, DOB xx, who is the reportee in this report. She called to notify the Police that a Mrs. Patsy White, w/f, DOB xx, had passed away this morning of natural causes. When I arrived on scene, I met with the reportee who stated that the deceased is in the back bedroom in room #5. When I entered into this room, I observed the deceased female laying on her back as though she was sleeping. Her body was covered with a blanket and only her head was exposed. This female was identified as Patsy White, W/F, DOB xx, . The reportee explained to me that White has been in this facility for almost 3 years. White had been diagnosed with cardiac problems and advanced stages of Alzheimers. The reportee explained that Mrs. White had awoken early in the morning and come to the kitchen to eat breakfast at about 7:45 am. She was seated at the table, eating breakfast with some of the other individuals at the facility, when she passed away. I was advised that she had just slumped over at the table as though she had stopped breathing while she was eating. The reportee checked the pulse of Mrs. White and found that she did not have one. The reportee explained to me that Mrs. White has an active OUT OF HOSPITAL DO NOT RESUSCITATE ORDER that was signed on June 28, 2014 by her son, Eric Dunning. I asked the reportee how she got to the bedroom, if she passed away in the kitchen. She explained to me that the other patients were very upset about her passing away, so they decided to remove her from the kitchen and place her in her bedroom out of site from the other patients. There was also a registered nurse on location by the name of Susan Rogers. She was

called to the location by the reportee, Deborah Thornton. After RN Rogers arrived on location, RN Rogers logged the time of death as 0903 hours, which is when she arrived to view Mrs. White. Investigator Rogers arrived on scene with me and took several photographs of the deceased while she was in the bedroom.

RN Susan Rogers explained to me that Dr . Gummelt, who has been seeing Mrs White, would sign off on the Death certificate. I was also advised that the son had been notified of the passing of his mother. I asked to get the number for the son so I could speak with him for a moment. I called the son, Eric Dunning at (832)xx. The son advised me that Deborah White had called him and they already had arraignments for his mom to be picked up by A Cremations located at 2720 Hwy 66 East, Rockwell, TX. 75087, Tel # (xx).

I called Judge Edie Connelly at 10:10 am and made her aware of the natural death at this location. I also advised her that HOSPICE had been involved and her Dr. would sign off on the death certificate. The reportee advised me there were no medications to dispose of from this location. A copy of the DNR Order, list of old medications, and a resident contact sheet for Mrs White will be filed with this report.

On 07/04/2016 at approximately 2347 hours I, Officer Kennerly, was dispatched to a disturbance in progress at 27218 Kane Lane. Upon my arrival, I met with the actor, Bryant Gist, white male, date of birth xx, 19 years of age, in the front yard. Gist had his shirt off and appeared to be intoxicated. I asked him what was going on and how much he had been drinking. Gist told me, "I don't know, what's going on", in a sarcastic manner. It was very obvious to me that Gist was intoxicated. I asked Gist to turn around because I was going to detain him, but he started backing up and telling me no. Oak Ridge North Officer Helton went behind Gist, grabbed his left arm, and attempted to grab his right arm, but Gist began to resist. Oak Ridge North Officer Richard and I also grabbed Gist and took him to the ground. Gist still wouldn't put his right hand behind his back, so I drive stunned him with my taser, telling him to put his hands behind his back. He then complied and was placed into custody, for public intoxication, due to him being a danger to himself and others. Gist was issued citation number 962501 for Public Intoxication.

Jerry L. Perkins, w/m, DOB x, TX DL # x, wrote a voluntary statement.

"Bryant Gist (grandson) was destroying property at our residence cussin, everyone out and was out of control. He was drunk and had been going to different friends and coming home drunk - He bowed up to me and wanted to fight - I went into house. Wife woke me up and said I needed to call police because he was completely out of control and destroying everything on back patio. We have small children in house and do not want him around. I tried to reason with him - playing music too loud and disturbing neighbors and he continued and was screaming and cussing at everyone and threatening to hit my wife. We are in process of adopting our two youngest 11 & 12 yr old and we cannot have this going on. We also have a 2 yr old nephew that stays with us and don't want this going on. We do not allow alcohol or drugs in our house - But he continues to bring to house. He is not allowed back at our house."

Regina Hubbard Perkins, w/f, DOB x, TX DL #x also wrote a voluntary statement. "Started out side drinking and had been told several times to stop and turn it down We my husbard and self for the whole time just to go to bed he refused got real loud and we were unable to talk him down he just got worse trashing everything at house bowed up and began throwing things in drive still wouldn't stop and calm down had to call 911."

Jerry Perkins and Regina Perkins are the grandparents of Gist. They are also the owners of the residence at 27218 Kane Ln. They did not want to press charges on Gist, but just wanted him gone for the night.
