On 07/02/2017 at approximately 1025 hours I, Officer Stafford (Unit 2723) observed a black Porsche Cayenne that was traveling eastbound on Robinson passing Blueberry Hill. Upon seeing the vehicle, I noticed that the vehicle did not have a registration sticker on it. As the vehicle passed me, I was able to get the Texas license plate number of CT9V297. I ran the license plate through MCSO database from my on board computer and received a return that the plate came back to a 1991 Chevrolet that was red in color. Upon seeing the return, I turned around to catch up with the vehicle since the plate did not match the vehicle. I was able to catch up to the vehicle as is turned north on Elder from Robinson. I activated my emergency lights and the vehicle stopped a little ways down.

I exited my patrol vehicle and made contact with a white male identified as Jesse Ryan Nunez (DOB xx) from his Texas driver's license. While speaking with Jesse, I asked for the insurance to the vehicle and he handed me an insurance card that expired as of 03/10/2017. I asked for a current insurance card and Jesse said he did not have one. I asked about the license not going to the vehicle and Jesse stated that he was not sure where the plate came from and guessed that it was the one on the vehicle when he bought it as a repossession.

After speaking with Jesse, I returned to my patrol vehicle and ran him through MCSO database and discovered that his license was not eligible due to the following.

Upon seeing that the license was currently suspended, I contacted ADA on duty and advised them of the incident. ADA on duty accepted the charge of Driving While License Invalid due to Jesse having a previous suspensions for an alcohol related offense. At this time Jesse was placed under arrest and transported to MCSO South County Jail without any further incident. Upon arriving at MCSO South County Jail, I issued Jesse an Oak Ridge North citation #5200072 for Wrong, Altered, or Obscured Registration, and Fail to Maintain Financial Responsibility.

Jesse's vehicle was towed due to not having valid insurance and the license plate was removed since it did not belong to the vehicle. The vehicle was towed by Rickey's Wrecker Service, chip# 187, and was towed to 9131 Highway 242 (Conroe, TX) in fair condition and the owner is aware of the tow location.

On 07/02/2017 at approximately 1325 hours I, Officer Stafford (Unit 2723) observed a gold Honda Accord bearing Texas license plate, FWB1724 that was turning westbound onto Robinson from Hanna. Upon seeing the vehicle, I ran the license plate and discovered that the

registration was expired as of 05/2016. After seeing the registration was expired, I turned around and was trying to catch up to the vehicle when the driver of the vehicle turned into 145 Robinson at the Valero. Once the driver turned into Valero, I drove by and waited for the driver to drive back out of the parking lot. When the driver pulled back out of the parking lot he turned westbound. As the vehicle was driving over the overpass I pulled behind and activated my emergency lights and stopped the vehicle.

I exited my patrol vehicle and made contact with a Hispanic male identified as Andres Ramirez (DOB xx) from his verbal statement. While speaking with Andres, he stated that he had a gun sitting on the floor board at the front of the driver's seat. I had Andres exit the vehicle and stand at the front of my patrol vehicle. While Andres was exiting the vehicle I could smell the odor of unburnt marijuana emitting from inside the vehicle. I asked Andres if he had any marijuana in the vehicle and he stated that he had some in a baggy in his ball bag.

After speaking with Andres, I went to my patrol vehicle and discovered that Andres had two active warrants for his arrest. The active warrants were for Fail to Maintain Financial Responsibility; #CC6182, and No DL When Unlicensed; #CC6181. While waiting for MCSO dispatcher to confirm the warrants, I went and asked Andres where the marijuana was again and he stated in the front pocket of his ball bag. I went to the vehicle and located a usable amount of marijuana in a clear baggy. After recovering the marijuana, I went to the driver's side floor board and grabbed the pistol (FNH 5.7 x 28, serial #x, that contained 19 rounds with one in the chamber) that was in a black holster (Blackhawk) that I was advised of earlier by Andres. The gun was ran through MCSO dispatch to check to see if it was stolen but it was not. The marijuana was tested using a NIK test kit and had a positive test result for marijuana. I was then advised that the warrants were confirmed and I placed Andres under arrest. Once Andres was placed under arrest for the warrants, I contacted ADA on duty and advised her of the incident. ADA accepted the charges of Possession of Marijuana < 2 ounces, and Unlawful Carrying of a Weapon. Andres was then transported to MCSO South County Jail without any further incident. After arriving at the jail, I issued Andres an Oak Ridge North citation #5200073 for Display Expired Registration, and Fail to Obtain DL.

Andres's vehicle was towed by Papa's Towing, chip# 007, and was towed to 18901 Main Street (Conroe, TX) in fair condition and he was aware of the tow location. After placing Andres into MCSO custody, I returned to Oak Ridge North Pd and weighed the marijuana using an Ohaus triple beam balance and had a total weight of 5 grams. The marijuana, pistol, and drug paraphernalia were placed into evidence.

While on patrol at approx. 1:13 AM. on 07-03-2017 I, Sgt. Barry saw a black 2010 Kia North bound in the 27200 Blk of IH-45 E. Feeder. In this area of the Feeder Rd it is three lanes for North bound traffic that goes down to two lanes to allow for a exit lane off of IH-45 main lanes.. This vehicle was approaching my location, the vehicle had it's left blinker on and was already in the far left lane of traffic. The vehicle also had a

left headlight not working. I then saw the driver turn right across the three lanes of traffic in front of another vehicle that was in the middle lane and hit the curb on the right side of the roadway. The vehicle then passed my location and continued North bound. I pulled out and got behind the vehicle and saw a Texas paper plate 73M0672 that expired August of 2017, attached to the rear of the vehicle. As I followed the vehicle it was failing to maintain a single lane of traffic and kept changing lanes. The vehicle's front passenger tire was flat as she was driving. The driver came to a stop in the 19600 Blk of IH-45 E. Feeder Rd. I turned on my emergency red and blue lights and stopped behind her vehicle. As I approached the driver's door it opened and I could smell a strong odor of an alcoholic beverage coming from the vehicle. The driver and sole occupant of the vehicle had blood shot eyes and slurred speech. I asked for her driver's license and she stated her attorney was working on getting that back. She stated she had a identification card and looked in her purse to find it. I saw she was having a hard time removing the ID from her wallet as she fumbled with it in her hands. She gave me her ID that identified her as Maria T Lopez Romo DOB xx. I asked her to stay in the vehicle and went to run her to see if I could find her Drivers License. I found Texas DL. xx that belonged to her. I returned to Lopez Romo and asked her to exit her car. When Lopez Romo got out of her car I saw that she was unsteady on her feet and had the smell of an alcoholic beverage about her breath and person that got stronger as she spoke. Lopez Romo advised that she had some drinks at a birthday party, but she could not tell me where the party was. I then asked what city it was in and she stated Houston, and looked at me confused as I should have known that. I then asked her where she thought we were and she stated Houston and when asked where at she stated Beltway 8. Lopes Romo again looked confused when I asked where she was going after she left the party. Lopez Romo consented to field sobriety task when requested. The first was horizontal gaze nystagmus. Lopez Romo stated she was wearing contacts and she has never had any head injuries. I saw lack of smooth pursuit, distinct nystagmus at maximum deviation, onset of nystagmus prior to 45 degrees in both right and left eyes. I had a total of 6 clues for the HGN. I then asked her to do the walk and turn. Lopez Romo could not balance during the instructions, missed all heal to toe, stepped off line, used arms for balance, and stopped after the turn and

asked what to do now. I got 4 out of 8 clues. I then asked her to do the one leg stand. Lopez Romo started too soon and set her foot down as she lost her balance. Lopez Romo stated she could not do the test because if arthritis but would try. Lopez Romo asked if she could do it holding onto my shoulder, as she was holding on my shoulder to maintain balance. Lopez Romo tried again and lost her balance soon after she lifted her foot and then advised she could not do the test. I then asked her to do the Rhomberg task. Lopez Romo estimated 30 seconds at 17 seconds, she did not sway during the task. I advised her she was under arrest for driving while intoxicated at approx. 1:28 AM. and she was handcuffed and placed in the rear sear of my patrol vehicle. I read the DIC-24 to Lopez Romo and after she stated she would give a blood specimen and then stated she would not. I started a Oak Ridge North wrecker call. The vehicle was towed by Keith's Towing to 27714 Robinson Rd.

I contacted the ADA and advised him of the arrest and refusal for the blood specimen. The ADA advised he would accept DWI with refusal. Lopez Romo was transported to Female booking and charged with Driving while intoxicated. She was given a copy of the DIC-24 and DIC-25 in her property. Lopez Romo was issued Oak Ridge North Citation # 890394 for defective equipment, headlight and fail to maintain financial responsibility.

On 07-04-2017 at approximately 0830 hours I, Officer Helton, was dispatched to a Welfare Check, located at 27900 interstate highway 45 North feeder. The notes on the call advised that a black male without shoes and wearing mult colored pants walking North bound in the North bound lanes, in lane one. I arrived on location to assist Lt Libby (Unit 2701) with the Oak Ridge North Police Department, who arrived prior to me arriving. As I arrived on location with Lt Libby and Officer Teske (Unit 2712) with the Oak Ridge North Police Department. I observed a black male, who was later identified as Rodrick Sanders black male date of birth xx push away from the other two officers and began running on foot, in the North bound feeder of interstate highway 45 North feeder, crossing over two lanes of traffic and then back to the East side of the feeder Sanders was trying to stop a vehicle and even tried to jump on the back of the same vehicle as it passed. The Officers were in approved Oak Ridge North Police uniforms and were in marked Police units with red and blue emergency lights, that were on at the time of the incident. I attempted to pull in front of Sanders, using my patrol vehicle without success. I observed Officer Teske un

holstered his Oak Ridge North Police issued Taser and deployed the Taser. Sanders, still running North bound pulled the Taser probes out and kept running. I exited my patrol vehicle and yelled "Stop Police!" and began running North bound on East side of the feeder. I un holstered my Oak Ridge North police issued Taser and velled to Sanders "Stop or I'll Tase you!" Sanders was a threat to the public, because he kept running into the feeder road. Sanders did not comply and kept running North bound. I took aim with the Taser and deployed my Taser, I observed that the probes of the Taser spread and missed Sanders completely going over his right shoulder area. As I continued running after Sanders, I attempted to reload my Taser for a second shot and observed that the Sanders was slowing down and I was gaining on him, so I attempted to reach out and grab Sanders with no success. Sanders then ran across all three lanes of the North bound feeder and continued running in the number three and number two lane. I observed that Sgt Pullen (Unit 2820) with the Shenandoah Police Department was able to place her marked Police vehicle in front of Sanders and she exited the vehicle. Sgt. Pullen gave the command to Stop to Sanders and Sanders kept running at Sgt. Pullen. Sgt. Pullen un holstered her Police issued Taser and deployed the Taser with no complete contact on Sanders. Sgt. Pullen reloaded and deployed the Taser again, making contact and Sanders fell to the ground. As I approached, Sanders was still trying to get back up and I was giving the command for Sanders to stay on the ground and roll over, so I could place hand restraints on him. Sanders began to get back up on to his feet and Sgt. Pullen Tased Sanders again, after the second time Sanders rolled over on to his stomach and I was able to place the hand restraints on Sanders, without further incident. Sanders was placed in the patrol vehicle and there were four probes that were removed from Sanders back and one that was removed from his right shoulder and one that was removed from his right forearm. After the probes were removed, we moved to the Salt Grass Steak house parking lot, located in Shenandoah Texas. While talking to Sanders, I observed that Sanders was slurring his words and talking very slowly, I also observed that Sanders eyes were blood shot and dilated, I beleved that Sanders was intoxicated, possible on drugs and was a danger to himself and the public. When I asked Sanders if he took any drugs today, Sanders would look away and did not answer. Sanders did not give an explanation on why he ran from Officers. While running Sanders through the Montgomery County Sheriff Office Dispatch, I was advised that Sanders showed to be a missing person out of Harris County, which was confirmed. Medic 25 with the Montgomery County Hospital District arrived on location and evaluated Sanders, due to Sanders being Tased and Sanders refused transport to the hospital. I made contact with the on-duty ADA, who accepted the charge of Evading Arrest Detention (MA) and Public Intoxication (MC.) Sanders was issued citation number 243706 for Public Intoxication and Walked on Highway With Traffic No-Sidewalk. I transported Sanders to CJC in Conroe Texas and was advised that Sanders needed to be cleared by the hospital before being accepted to the jail. I transported Sanders to the Conroe Hospital where he was medically cleared and then transported to CJC in Conroe

Texas, without further incident. Once I returned to service, I placed the spent Taser cartage number C3105084C with the expiration date of 11-20-2021 in the evidence locker at the Oak Ridge North Police Department. A copy of this report was sent to the Montgomery County Sheriff Office Dispatch NCIC/TCIC so that Sanders would be taken out as a missing person, which was completed at 0914 hours by Z1028 Burcham. A copy of the confirmation paperwork from Harris county and a copy of the medical paperwork is with this report.

Sgt. Pullen advised the case number of 17M004423, for her report about the incident.

On 07/03/17 at approximately 1320 hours Officer Rogers and I, Sgt. Nation, checked out at 9430 Concourse Dr., # 1417, Houston, TX. 77036, in reference to a warrant service on Raul Alvarez Mairchal, w/m, dob x. We observed, from the back patio of the apartment looking through the sliding back glass door, two males and a female talking inside Mr. Alvarez's apartment. One male was identified to be the defendant, Mr. Alvarez Mairchal, from his TDL # x photo we had in our possession. I made contact with the defendant at his back door and he was immediately detained. Montgomery County Sheriff's Office Communications confirmed Felony Warrant # 17-05-06071, Fraud Use/Possession Identifying Information - Elderly Individual (\$10,000 Bond). We transported Mr. Alvarez to the South Montgomery County Jail. While in transit to the jail Judge Pattillo, via audio/video device, gave the defendant his Magistrate Warning. Upon our arrival to the jail, I booked the defendant into the Montgomery County Jail and released him to jail staff without incident.

On 07/05/2017 at approximately 1013 hours I, Officer Stafford (Unit 2723) while driving westbound on Robinson, I observed a green GMC Sierra that was traveling eastbound and had an expired registration sticker displaying 03/2017. Upon seeing the expired registration, I turned around and was able to catch up to the vehicle at Robinson and Hanna as the truck was turning northbound onto Hanna. Once I turned onto Hanna, I activated my emergency lights and stopped the vehicle in the 27400 block of Hanna.

I exited my patrol vehicle and made contact with a white male identified as Mark Alan Curzan (x) from his Texas driver's license. While speaking with Mark, I asked who put the sticker on the windshield since the license plate number did not match the plate on the vehicle. Mark stated that the sticker was from his mother's car and he was not able to get his truck to pass inspection and the cost of the repairs.

After speaking with Mark, I returned to my patrol vehicle and ran the license plate that was on the vehicle and the return showed that the plate expired 07/2015. I further noticed that Mark had an active warrant for his arrest out of Montgomery County Precinct 2 through Judge Trey Spikes. The warrant was for Display Expired License Plates; #CC15751. Upon seeing the active

warrant, I had MCSO dispatch confirm the warrant and while waiting for the warrant to be confirmed I issued Mark an Oak Ridge North citation #5200097 for Displaying Expired Registration. Once the warrant was confirmed, I placed Mark under arrest and transported him to MCSO South County without any further incident.

Mark's vehicle was towed by Rickey's Wrecker Service, chip# 187, and was towed to 9131 Highway 242 (Conroe, TX) in fair condition and the owner is aware of the tow location.

On 07/05/2017 at approximately 1340 hours I, Officer Stafford (Unit 2723) while doing routine patrol, I overheard Chief Walters stopped a white Honda Civic bearing Texas license plate, GTN2324 for expired registration (12/2016). Upon hearing this, I was informed that Chief Walters had stopped the vehicle at 26800 IH 45 South feeder in the Best Friends parking lot. I went to back Chief Walters and ran both subjects that were in the vehicle through MCSO database.

The driver was identified as white male by the name of Cameron Ryan Barrick (DOB x) from his Texas identification card. The front seat passenger was identified as a white male by the name of Austin Warren (DOB x) from his verbal statement. After running both subjects through MCSO, I was advised that Cameron had two active warrants for Failure to Maintain Financial Responsibility; #144805, and Failure to Maintain Financial Responsibility; #144806 through Justice of Peace Pct 5. Austin had a total of 10 active warrants for his arrest through several agencies. The warrants for Austin are from the following. Driving While License Invalid; #CC6386 out of Justice of Peace Pct. 2, Failure to Appear; #555255 out of Justice of Peace Pct. 3, Failure to Appear; #4CC0902AA out of Justice of Peace Pct. 4, Driving While License Invalid; #1CC18340 out of Justice of Peace Pct. 1, Failure to Appear; #1CC18340F out of Justice of Peace Pct. 1, Speeding; #1CC18341 out of Justice of Peace Pct. 1, Speeding; #CC6385 out of Justice of Peace Pct. 2, No Motorcycle Endorsement; #140322 out of Justice of Peace Pct. 5, Violate Promise to Appear; #140322A out of Justice of Peace Pct. 5, No Valid MVI Sticker; #140323 out of Justice of Peace Pct. 5.

Once the warrants were confirmed, I placed both subjects into custody and placed them into the rear seat of my patrol vehicle. I transported both subjects to the Oak Ridge North PD office to complete booking paperwork on them due to the number of warrants.

Once the booking paperwork was complete, both subjects were transported to MCSO South County Jail without any further incident. Upon arriving at MCSO South County Cameron was refused and both subjects were then transported to MCSO male booking. The vehicle that Cameron was driving was towed by A Plus, chip# 32 and was towed to 6317 Big Oaks (Conroe, TX) in fair condition and the owner is aware of the tow location.

On 07/08/2017 at approximately 1440 hours, I, Officer Teske, observed a blue Ford Explorer, displaying TXLP# HMT4431, traveling NB on IH 45 North Feeder Road near Woodlands Pkwy. I observed that the two lower rear brake lights on the right and left of the vehicle were not illuminating when the vehicle braked. The third brake light attached above the rear window was the only brake light that was working. A check of

the license plate on my MDT showed the registration expired June 2017 and the insurance was Unconfirmed. I stopped the vehicle in the 27900 block of IH 45 North Feeder Road. The driver was identified by TX ID# x as Christian Odaniel w/m dob x. Christian stated that his license was suspended, and he was unable to provide valid insurance for the vehicle. A check on my MDT confirmed that his TDL# x expired 06/26/2015 and was currently invalid due to Denied Renewal - FTA. A check on my MDT and with MCSO Dispatch showed that he was wanted out of Harris County for warrant# 2105341 for Misdemeanor Theft \$100-\$750 through Harris County CCL14. The warrant was confirmed and I placed Christian into handcuffs and placed him in the rear of my vehicle. A short while after placing him into the rear of my patrol car, Christian appeared to be breathing hard and hyper ventilating. I asked if anything was wrong and he would not answer me. I asked if he had any medical issues and he stated that he has seizures. Christian then appeared to have a seizure. ORNPD Officer Helton was on scene held Christian as he seized and I requested that dispatch send EMS. EMS Medic 21 arrived shortly thereafter and Christian had several more seizures. Medics advised he needed to be transported and Christian was transported to Herman Memorial The Woodlands for evaluation. I advised dispatch that Christian was no longer in custody and the warrants needed to be reactivated. Z1046/Tilley sent an administrative message to HCSO at 1635 hours to reactivate the warrants. The front passenger in the vehicle was identified by TDL# x as Justine Larsen w/f dob x. There were three small children in the rear seat identified as Isabella x w/f dob x, Zyllah x w/f dob x, and Weston x w/m dob x. A check on my MDT and with MCSO Dispatch showed a Child Protective Services (CPS) Child Safety Alert Check, OCA# 43049488, on Isabella Odaniel (daughter) and Justine Larsen (mother). The child safety alert was for medical neglect and showed that last contact was made with the child back on April 2017. I contacted the CPS Law Enforcement Hotline and spoke with caseworker Sabrina (ref#69120916) at 1445 hours. She advised that a local agent would call me back. I informed Justine of the child safety alert check. She stated that a case had been opened because Isabella has Leukemia and she missed two doctors appointments. Justine stated they had been robbed and then evicted from their residence and were having financial difficulties. She stated that CPS drug tests showed that she passed her most recent drug test but Christian showed evidence of THC on his recent drug test. She stated that she broke her phone and they had since moved from place to place and that was probably why CPS was unable to contact her. She stated that because she passed her drug test she thought she was ok. I contacted the CPS Hotline again at 1544 hours and spoke with Karen (ref#69121046). She informed me that a local agent would call me back. I received a call from the Houston CPS office at 1600 hours from caseworker Priscilla. She requested that I bring the three children to their office at 6300 Chimney Rock in Houston, Texas. I then informed her that I could not place the children in my marked patrol car with no chld seats and asked if there were any local agents, or agents from Houston, that could come pick up the children. She stated that there were no agents available and that I would need to bring the children to them as the children were not supposed to be alone with Justine. I then contacted Lt. Libby and informed him of the situation. He provided me with information for the on call CPS Agent for Montgomery County, Aaron Finchem. Finchem informed me that CPS Agent CarolAnn Kimbrough was en route to my location to continue the

investigation on Justine and Isabella. While waiting for Kimbrough's arrival, I asked Justine for consent to search the vehicle. She gave me verbal consent and I began a search of the vehicle. I located a small clear plastic bag that contained a small amount of marijuana debris (not a usable amount) inside a black metal box on the back right floorboard. Justine stated that she did not know who left the marijuana there but it was not hers. The vehicle was filled with clothing and other items. Trash was strewn throughout the vehicle and there were roaches and other unknown insects/bugs crawling throughout the vehicle. Agent Kimbrough arrived on location at approximately 1712 hours and Justine and the three children were released to her for the CPS investigation.

I then went to Memorial Hermann Hospital and met with Christian. While I was speaking with him at the hospital it appeared that he had several more seizures. Christian suffers from epileptic seizures but cannot afford to purchase the medication needed to control his seizures. Staff at the hospital informed me that he would not be leaving anytime soon. He was issued ORNPD citation 72250 for the offenses of No Insurance and Driving While License Invalid.
