On 01/21/2018 at approximately 1233 hours I, Officer Duenas, riding with Officer Teske, observed a black Dodge Ram pickup truck, displaying TX LP # BY85450, traveling east on Lane Ln at the intersection near Westwood Dr. The vehicle failed to signal a right turn within 100 feet of the intersection, when turning onto Westwood Dr. After turning south on Westwood, the vehicle made a left turn onto Ridgewood Dr and failed to use his turn signal. I stopped the vehicle in the 200 block of Ridgewood Dr. I made contact with the driver and advised him what he was stopped for. The driver advised that he did not have a driver's license and identified himself by Mexico ID card as Jose Pizano, w/m, dob x. A check through my MDT and with MCSO Dispatch showed that Pizano had an outstanding warrant, #CC5396, out of Montgomery County JP 2 for No Driver's License. I detained Pizano, awaiting confirmation from MCSO Dispatch. MCSO Dispatch advised the warrant was confirmed and I placed Pizano in custody for the warrant. I issued Pizano citation #52000708 for the offense of No Driver's License and the vehicle was released to his son. His son identified himself, by Mexico ID card, as Abel Pizano, w/m, dob x. Abel advised that he would wait on scene with the vehicle for a licensed driver, who would be coming from Ray's Nursery, just east of our location. I then transported Pizano to the South County Jail for booking.

On 01/22/2018 at approximately 2211 hours I, Officer Stafford (2723), observed a white Chevrolet Silverado, bearing Texas license plate KDG0180, that was traveling southbound on the IH 45 South Feeder. Upon getting behind the vehicle, I ran the license plate and discovered that the registration was expired as of 11/17. I activated my emergency lights and stopped the vehicle in the parking lot at Best Friends. I made contact with a black male, identified as Rudolph Whisenton Jr., (DOB x), from his Texas driver's license. After speaking with Rudolph, I returned to my patrol vehicle and ran Rudolph through the MCSO database. I discovered that he had an active warrant out of Missouri for Criminal Non-Support; warrant #W11149073. I notified MCSO Dispatch and had them confirm the active warrant. While waiting confirmation from Dispatch, I issued Rudolph an Oak Ridge North citation, #1100341, for Display Expired License Plates. MCSO Dispatch stated the warrant was confirmed and I placed Rudolph under arrest. Rudolph was transported to the MCSO South County Jail without any further incident. Rudolph's vehicle was left on location so that a friend could pick it up and return it to his work place, at Sudden Link on Hanna Road.

On 01/23/18 at approximately 1151 hours I, Officer Kennerly, was dispatched to an assault past, located at 27238 Woodson Road, at Kwik Serv. The reportee and victim, Tia Collins, black female, date of birth x, and the actor, Cynthia McCollough, black female, date of birth x, had both already left the scene. Collins called from her residence at 19563 Main. I went to Collins's residence where she wrote a statement and showed me the scratches on her forehead and left hand. Collins advised me that she went inside Kwik Serv and was at the checkout counter when McCollough came in, got right beside her, and purposely bumped into Collins. Collins then bumped into McCollough and some words were exchanged. Colllins told McCollough "Happy New Year" in a sarcastic manner and walked out the door. McCollough followed behind Collins and attacked her, scratching her, and hitting her. Collins advised she fought back only to defend herself. Collins advised that she wanted to pursue charges. Collins and McCollough know each other very well. Collins told me where McCollough lived, so I went to see if she was at home, at 9805 Simmons, #A. She was not there though. I went to Kwik Serv to try and see if there was any video of the assault. When I arrived at Kwik Serv, McCollough was on location. McCollough advised me that Collins pushed her first. She then pushed Collins and then they got into a fight. McCollough advised me that she did strike Collins first. A third party, who did not hang around, broke fight up. McCollough also provided a written statement. McCollough did cause bodily injury to Collins, but due to McCollough being the caretaker of her sister who is a special needs person, she was not placed in custody today. Photos were taken of Collins injuries and added to this report. Both statements are also available. While I was at Kwik Serv, I asked the cashier if she saw what happened. She advised McCollough pushed Collins first and was the aggressor. The cashier did not wish to get involved in any way. Surveillance video showed Collins being pushed first, but when the fight went outside, there was no good camera view.

On 01/23/2018 at approximately 2239 hours I, Officer Young, was patrolling the northbound feeder at Woodlands Pkwy and IH 45 when I observed a red Ford F-150, displaying TX LP #AP40869, traveling northbound in front of me. My MDT showed the vehicle to have unconfirmed insurance; last match not within 45 days. My MDT also showed the vehicle to have expired registration as of 08/17. I stopped the vehicle at Pine Manor and the IH-45 N Feeder where I made contact

with the driver, who was identified by TX DL #x as Jeffrey Flores (W/M; DOB x). Jeffrey advised he didn't have insurance or the money to get his tags up to date. Upon running Jeffrey's DL information through my MDT, it showed his DL to be expired (2015) and not up for renewal due to an FTA out of Diboll PD. The passenger in the vehicle was identified by TX DL #x as Kathleen Flores (W/F; DOB x). Kathleen's DL was not valid either as it expired in 2011. I informed Jeffrey that the vehicle would be towed for him not having a valid DL and for failing to maintain financial responsibility. Jeffrey's vehicle was towed by Quik Tow to 28075 Robinson Rd. Jeffrey was issued a citation (#52000716) for Displaying Expired License Plates (REG), Fail to Maintain Financial Responsibility, and for Driving While License Invalid. Jeffrey was also given a copy of the tow information at the scene.

On 01-24-2018 at approximately 0953 hours I, Officer Helton, was dispatched to a Welfare Check at 28256 Nancy Ln. I arrived on location and met with Amy Fisher, white female, date of birth x. Fisher said that she saw a black passenger car drive in through her bedroom and someone fired a gun and shot the bathroom door. Fisher has been handled for mental health problems in the past. Fisher requested to go to the hospital for help. We contacted EMS and also contacted a mental health Officer to check by. Deputy A. Booher, (Unit 8127) with Montgomery County Constable Precinct 1, arrived on location along with Medic 13, with the Montgomery County Hospital District. Deputy Booher took primary and Fisher was transported to the hospital for evaluation.

On 01/24/2018 at about 2250 hours I, Officer H. Richard, was patrolling in the 27500 block of the IH 45 North Feeder when I observed a black SUV bearing, TX LP number HZV8632. I checked the SUV's plates through my Mobile Data Computer (MDC). My MDC showed that the vehicle's registration was expired since 10/2017, and the vehicle also had unconfirmed insurance for more than 45 days. I turned on my red and blue emergency lights, making a traffic stop at Oak Ridge School Rd and the IH 45 North Feeder. I made contact with the driver and asked for his license and insurance. The driver was identified by his TX DL number x as

Thomas Lee Roach, DOB x, white male. I also observed there was a passenger and he was identified by TX DL number x as Charles Edward, DOB x, black male. Roach stated that he did not have insurance for his vehicle but handed me his driver's license. I returned to my patrol vehicle and checked Roach through my MDC. My MDC showed that Roach has an active warrant through the Angleton Police Department for Assault Family Violence, Causing Bodily Injury. I checked Roach through MCSO Dispatch and MCSO confirmed the warrant. MCSO stated that Angleton Police Department had a hard copy of the warrant and will extradite. Edward was released from the scene on foot. Roach's vehicle was towed by Milstead and stored at 29707 Hawthorne in poor condition. Roach was issue citation number 52000723 for Expired Operators License and Fail to Maintain Financial Responsibility. I placed Roach in custody at 2310 hours and transported him to Conroe for booking. A copy of the Angleton Police Department warrant will be attached to this report.

On 01/24/2018 at about 1940 hours I, Officer H. Richard, heard Deputy J. Pierce, (6P1019) with the Montgomery County Sheriff's Office, advised MCSO Channel 2 that he had a white pickup truck fleeing from him. Deputy Pierce advised the white pickup truck was headed toward the IH 45 South Feeder from the Mall parking lot. I was at Lake Woodlands and the IH 45 South Feeder. I advised Sgt. Straight, (2704) with the Oak Ridge North P.D., that I was the third unit in the pursuit. The white truck led Deputy Pierce on a high-speed chase traveling south on the IH 45 South Feeder at about 85 - 90 miles per hour, in a posted 45 mile per hour zone. The white truck got onto the IH 45 main lanes and exited East Hardy Toll Road. At that time Sgt. Straight asked me, "How many Units are in the pursuit now?" I advised there are about 5 to 6 Units. Sgt. Straight said to disengage the pursuit and return to the city. I made a u-turn at Hardy Toll Rd and FM 1960 and returned to the Oak Ridge North city limits.

On 01/26/2018 at approximately 1811 hours I, Officer Stafford (2723), was sitting at Birchwood and the IH 45 North Feeder waiting to turn north when I observed a purple Kia Sorento, bearing Texas license plate JDW9696, that was traveling northbound with no headlights on.

I pulled out and was able to get behind the vehicle in the 26700 block of the IH 45 North Feeder. I activated my emergency lights and the vehicle stopped in the parking lot of I-Fly, located at 26860 IH 45 North. I exited my patrol vehicle and made contact with a white female, identified as Lindsey Galloway (DOB x) from her Texas driver's license. While speaking with Lindsey, she advised that she didn't have her insurance card with her at this time. I returned to my patrol vehicle and ran her through the MCSO database. I discovered that she had three active warrants for her arrest through the Tomball PD. The warrants were for Speeding in School Zone, 47 MPH in 20 MPH zone - #B17009101; Fail to Maintain Financial Responsibility - #B17009102, and Violate Promise to Appear -#B170091V01. I contacted Tomball PD Dispatch and they confirmed the warrants. I aired for a fifteen-minute wrecker call and to have the wreckers stage at my location. Lindsey was then placed under arrest and placed in the rear seat of my patrol vehicle. Lindsey was also issued an Oak Ridge North citation, #1100353, for Drove without Headlights when Required and Fail to Maintain Financial Responsibility. Lindsey's vehicle was towed by Keith's Towing, chip # 159, to 27714 Robinson in fair condition. Lindsey is aware of the tow location. Lindsey was then transported to the Tomball PD without any further incident.

On 01/27/2018 at approximately 2239 hours I, Officer Stafford (2723), observed a silver Chevrolet Cobalt, bearing Texas license DG1M383, that was traveling westbound on Woodson at Harlan. I ran the license plate and noticed that the registration was expired as of 10/17. The insurance was also expired. As the vehicle turned northbound onto the IH 45 North Feeder, I activated my emergency lights and stopped the vehicle at 27900 IH 45 Feeder. I exited my patrol vehicle and made contact with a white female, identified as Danielle Benefield (DOB x) from her verbal statement. While speaking with Danielle, she stated that she didn't have a driver's license or valid insurance for the vehicle. I returned to my patrol vehicle and confirmed that she didn't have a driver's license. I went back to her vehicle and identified the male passenger as Keith Rosenbalm Jr (W/M; x) from his Texas Identification card. I ran him through the MCSO database and was advised that he had two active warrants out of Montgomery County Precinct 4. The warrants were for Fail to Display DL -

#229824 and Failure to Appear - #229824AA. I advised MCSO Dispatch to confirm the active warrants. While waiting for Keith's warrants to be confirmed, I issued Danielle an Oak Ridge citation for Fail to Obtain DL, Fail to Maintain Financial Responsibility, and Display Expired License Plates. Once I finished the citation, MCSO Dispatch advised that the warrants on Keith were confirmed. I went back to Danielle and Keith, advised Keith that he had two active warrants, and placed him under arrest. Danielle signed her citation and was released with the wrecker driver, who gave her a transport to the Exxon at Woodson and Hanna. The vehicle was towed by South County, chip # 24, to 28075 Robinson in poor condition.

On 01-28-2018 at approx. 4:40 AM Officer Stafford saw a male walking northbound in the 27000 block of the IH-45 E. Feeder. Officer Stafford saw the male staggering as he walked. Officer Stafford stopped to check his welfare. I, Sgt. Barry, checked by Officer Stafford's location. The male had blood shot eyes, slurred speech, and poor balance. He identified himself by Texas ID, x, as Alfonso Garcia Jr., DOB x, H/M. Upon a check of his name, Montgomery County Dispatch advised that he had 3 traffic warrants out of Montgomery County JP #2, which were later confirmed. Garcia was arrested and I transported Garcia to the South Montgomery County Jail.

On 01-28-2018 at approx. 1631 hours I, Officer R. E. Craig III, was leaving the Oak Ridge North Police Department after a quick restroom break. As I walked out of the back door of the Police Department, I observed a white male standing, facing to the south, with his back to me. He was near our patrol cars at this time. I asked him if there was something I could help him with. It was at this time that he turned around and I noticed he had a GO PRO strapped to his front chest and he was holding what looked to be an I-PHONE in his hand. He stated that he was just out taking pictures. I asked him if he needed assistance from the Police Department and he stated no. I asked him for his name but he refused to give it to me. I asked him to leave and he stated that it was public property. I asked him to leave again and he stated that he was an independent reporter and he was about to go into the front lobby. I advised him the office was closed. I asked him why he wanted to go in the office. He stated that he wanted a complaint form. I

advised him that he could come back on Monday and file a complaint if he wished to. I asked him for his name but he refused to give it and said I was unlawfully detaining him. He stated that he was leaving and he was going to stand in the front by the street and video some more. The male appeared to be in his mid 20's. He had a short buzz cut haircut. He also had black ink tattoos on both forearms. He was wearing a red short sleeved t-shirt with a pair of faded jeans and a pair of brown cowboy style boots. I did not see a vehicle parked in the back lot. I then drove to the front lot and noticed the unknown male was standing near the front driveway. I stopped at the front driveway and noticed this male was on the phone. I then rolled down my window to take a photograph of this male with my city cell phone. As soon as he noticed I was taking a photo, he put his hand up in front of him to block the view of his face. I then drove off to the west and pulled into the parking lot at 27326 Robinson Rd. I called MCSO Dispatch and notified them of the Suspicious Person that I was out on. I believe he was actually at the Police Department to incite a reaction from the Police Department. I asked MCSO Dispatch to notify other Units and Departments that this male was in the area. While I was stopped in this parking lot, I observed a blue 4 door passenger car pull out of the parking lot of the SOJOURN Academy and turned east onto Robinson Road. I then pulled out on the roadway and attempted to catch up to this vehicle. The vehicle then turned north on Hanna Rd. I was able to get behind the vehicle as it continued north onto Oak Ridge School Rd. Once behind the vehicle, I observed it was a blue Ford Escape 4 door, bearing Oklahoma LP # CPU128. I ran this LP and it came back registered to a Ronald Goforth at 508 Hilltop Pl, Muskogee, OK 74403-7515. The vehicle showed to have a lien with Exeter Finance Grp., PO BOX 166008, Irving, TX 7501-6008. The vehicle was driven by what appeared to be a white female. The unknown male who was at the Police Department was seated in the front passenger seat. The vehicle continued to drive on Oak Ridge School Road all the way around to the Oak Ridge Elementary School. The vehicle then turned to the west to get to the northbound feeder of IH-45 N. The vehicle was adhering to all traffic laws while I was behind the vehicle. Once the vehicle turned north on the feeder, I turned around and went to the Police Department to write up a guick incident report documenting my encounter with this unknown male.

On 01/28/2018 at approximately 2046 hours I, Officer Young, was dispatched to a disturbance in progress at a residence located at 26702 Eastwood Dr. Upon arriving to the residence, I was met out in the driveway by a female, identified by TX DL #x as Michelle Bryant (W/F; DOB x). When I made initial contact with Michelle, I observed redness and swelling around her left eye as well as a red circular mark on the left side of her nose. I asked Michelle what had happened for her eye to be swollen and red. Michelle advised me that her daughter, Cheyanne Henderson (W/F: DOB x) was at the house earlier that evening when a verbal argument occurred. The argument was over Cheyanne repeatedly refusing to take her grandmother to the store to get groceries earlier that evening. Michelles exhusband ended up taking the grandmother to the store. The argument continued until it turned physical when Cheyanne punched Michelle, with a closed fist, in the face twice; knocking Michelle's glasses off. Once Michelle was punched in the face she called the Police. Cheyanne left the house in a white Chrysler, unknown plate, model, or direction of travel before I got there. Michelle also advised that even though Cheyanne left before we got there, that she also lives at the address where the assault occurred. Michelle provided me with a voluntary statement of the events that led up to her being punched in the face; as well as a complaint wishing to pursue charges of assault against Cheyanne. The grandmother was in the room and witnessed the assault on Michelle by Cheyanne but refused to provide a written statement. The grandmother did verbally confirm that the statement Michelle provided about the assault was accurate. I took photos of Michelle's facial injuries and provided her with information for family violence victim assistance at 2135 hours.

On 01/28/2018 at approximately 0028 hours I, Officer Young, was conducting stationary traffic enforcement at 26710 IH-45 N Feeder, at the north entrance to Mattress Firm, when I observed a tan Toyota Camry traveling at a high rate of speed in the far right lane. My lidar was unable to pick up the vehicle's speed. I pulled out and paced the vehicle. I stopped the vehicle on the northbound Feeder just south of Oak Ridge School Road. I made contact with the driver, identified by Honduras Passport as Joel Paguada Almendares (W/M; DOB x). I had paced the vehicle just above 90 MPH in a 45mph posted zone. When I asked how fast he thought he was going, Joel advised he thought he was doing 90 MPH.

As I was checking Joel for any local returns, DPS Trooper Jackson (2596) arrived on scene to speak with the driver. After speaking to the driver, Trooper Jackson

performed SFST's on the driver. Trooper Jackson determined that Joel was impaired and shouldn't drive. Joel admitted to Trooper Jackson that he had been drinking that evening. I released Joel and the vehicle to Trooper Jackson for his investigation. I issued a citation (#52000746) to Joel for Speeding, Fail to Signal Lane Changes, Fail to Obtain a Driver's License. Trooper Jackson placed Joel in custody for DWI and towed the vehicle.

On 01/28/2018 at approximately 2157 hours I, Officer Stafford (2723), was dispatched to a Welfare Check, located at x Stark. I was advised by MCSO Dispatch that a female by the name of REPORTEE x (Phone # x), who lives out of state was calling in, stating that ACTOR x (DOB x; years of age) was wanting to hurt himself. Dispatch further stated that ACTOR had told REPORTEE that he was wanting to die and was thinking about using a knife or getting hit by a train. I arrived on scene and exited my patrol vehicle. I walked to the front door of the residence and had to knock several times. A young white male answered the door. I asked him for his name and he stated that it was ACTOR x. I asked ACTOR to come out and speak with me and my partner, Officer J. Young (2747). Once ACTOR was outside, he stated that he was playing Call of Duty on-line and was talking to REPORTEE. He stated that he told REPORTEE that he was wanting to hurt himself. Once ACTOR stated this, MCHD Medic 25 was called to the scene and was advised of what ACTOR said. ACTOR was then asked if he wanted to go to Tri-County and get some help. ACTOR said yes. I then made entry into the residence to locate his guardian. I had to knock on a bedroom door on the far west of the residence. After knocking, a male in the room asked who it was. I advised him that I was with the Oak Ridge North PD. The male opened the door and he was identified as FAMILY MEMBER (DOB x). I was informed that he was ACTOR's grandparent. FAMILY MEMBER said that he was not ACTOR's legal guardian but ACTOR does live at his residence. I advised FAMILY MEMBER that ACTOR was wanting to be transported to Tri-County because he was wanting to hurt himself. I told FAMILY MEMBER how to get to Tri-County. I returned to service as the grandparent was leaving the location to follow the ambulance to Tri-County.

On 01/29/2018 at approximately 1057 hours I, Officer Duenas, riding with Officer Teske, observed a red Chevrolet Impala, displaying TX LP # JGW9234, traveling north in the 26500 block of the IH 45 North Feeder at a high rate of speed. I checked the vehicle's speed using a Kustom Pro Laser 4 Infrared Lidar. The Lidar showed the vehicle traveling 65 mph. The highest posted speed is 45 mph. I stopped the vehicle in the 27100 block of the IH 45 North Feeder. I made contact with the driver, who identified himself by TX DL # X as Devon Christopher Childress, w/m, dob X. A check through my MDT and MCSO Dispatch showed Childress to have open warrants out of Montgomery County. I detained Childress and had MCSO Dispatch confirm the warrants. MCSO Dispatch advised the warrants were confirmed. I placed Childress in custody for Warrant # CC7208A for Failure to Appear out of Montgomery County JP #5, Warrant # 1CC19180 for Expired Registration out of Montgomery County JP #1, Warrant # 1CC19181 for Speeding Over Limit out of Montgomery County JP #1, and Warrant # 1CC19180F for Failure to Appear out of Montgomery County JP #1. The vehicle was released to a family member, who identified herself by TX DL # X as Kenya Lynn Turbeville, w/f, dob X. Childress was issued ORNPD citation # 52000751 for Speeding and Driving While License Invalid. I transported Childress to MCSO South County Jail.

On Monday, 01/29/2018, at approximately 2347 hours MCSO 2 Dispatch aired a welfare check at Cox and Hanna concerning a man who was lying unconscious in his vehicle. Sheriff's Deputy Berry (6P1012) responded to the call and I checked by with him since the call was near the Oak Ridge North city limits. The unconscious man turned out to be intoxicated and could only speak Spanish. He was identified by name and DOB as Apolinario Lopez-Tipaz, DOB X, h/m. Deputy Berry asked if I could translate for him so he could communicate with Lopez, and I did. Lopez was very intoxicated. When I attempted to ask him for his information, he could not remember his own name. Lopez's vehicle engine was running when I arrived to the scene. I asked him to turn it off but due to how intoxicated he was he could not turn off the engine. Lopez was asked to step out of the vehicle so that Deputy Berry could conduct SFST's on him. He cooperated but he was unable to maintain his balance and had to be helped several times to stand still. I assisted Deputy Berry with translating the SFST instructions to Lopez and making sure he understood what the test required of him. After SFST's were completed and the DIC was read to Lopez, I assisted Deputy Berry in advising Lopez if he would

consent to a blood draw. Lopez consented and he was then taken into custody by Deputy Berry for DWI and transported to Memorial Herman for a blood draw. This report is a supplement to Sheriff's Deputy Berry's (6P1012) report #18A028061. Deputy Berry had Lopez's vehicle, displaying LP # JMC3309, towed by Loveday Towing to 28075 Robinson Rd.

On 01/30/2018 at approximately 1605 hours I, Officer Duenas, riding with Officer Teske, observed a black Hyundai Elantra, displaying TX LP # GWL4059, traveling at a high rate of speed in the 26500 block of the IH 45 North Feeder. I checked the vehicle's speed using a Kustom Pro Laser 4 Infrared Lidar. The Lidar showed the vehicle traveling 64 mph. The highest posted speed limit is 45 mph. I stopped the vehicle in the 26800 block of the IH 45 North Feeder. I made contact with the driver, who identified himself by name and dob as Isaiah Williams, b/m, dob X. Williams stated that he did not have his driver's license with him at the time. A check through my MDT showed Williams has a valid driver's license, TX DL # X. I also confirmed his identity using DPS Image Retrieval.

As I was speaking to Williams, I could see marijuana debris all over the front passenger seat. Officer Teske observed the debris as well. I asked Williams if he had anything illegal inside the vehicle. He stated there might be a bowl (referring to a marijuana pipe) inside but it belonged to his mom. I asked Williams to step out of the vehicle. I asked Williams if I could search the vehicle and he gave me verbal consent to search the vehicle. While I was searching the vehicle I located, in the center console, 1 red and clear glass pipe, 1 blue and yellow glass pipe, 1 red yellow and green metal grinder that contained marijuana debris, and 1 package of JB rolling papers commonly used to smoke marijuana. Each of the glass pipes contained burnt marijuana debris. I did not find any other contraband inside of the vehicle. I seized the items that were found inside the center console and issued Williams ORNPD Citation # 52000765 for Speeding 64/45 and Possession of Drug Paraphernalia. I then took the seized contraband to the Oak Ridge North Police Department and placed the items into evidence.

On 01/30/2018 at 2200 hours I, Officer H. Richard, was patrolling at Woodson and Hanna Road when I observed a light blue passenger car, bearing TX LP number

FBX8027. I checked the license plate through my Mobile Data Computer (MDC). My MDC showed unconfirmed insurance for more than 45 days. I turned on my red and blue emergency lights, making a traffic stop at Main and Chateau Woods. I made contact with the driver. I asked the driver for her license and insurance. The driver stated that she did not have her license on her person but could provide me with her driver's license number. The driver gave driver's license number X and was identified as Heather Sweeney, DOB X, white female. I checked Sweeney through MCSO Dispatch and Dispatch stated that she was wanted through the Harris County Sheriff's Office. Dispatch confirmed NIC number W291212522 for Driving While Intoxicated, with a bond amount of \$5,000.00. I placed Sweeney in custody at 2219 hours. I asked Sweeney if she had someone close to pick up her vehicle. Sweeney was able to call a friend and the vehicle was released to Katricia Marie Bennett, DOB X, identified by her TX DL number X. I transported Sweeney to the Montgomery County Sheriff's Office in Conroe for booking. A copy of the Harris County Sheriff's Office warrant will be attached to this report.

On 01/31/2018 at approximately 1953 hours, I, Officer Young was dispatched to a MVA on the north bound main lanes of IH-45 just south of Woodlands Parkway. I arrived on scene to find a 2012 Black F-350 displaying TXLP#BW52570 facing East on the far-right main lane of IH-45 with damage to front right wheel, bumper, damage to the passenger door and all airbags deployed. I made contact with the driver identified by Texas DL#X as Jason McNew(W/M;DOB:X) pacing around the vehicle. I asked Jason what had happened that caused the accident. He advised he was in the HOV lane and tried to change lanes to the right and struck the back of a semi-truck. Jason advised he was tired and ready to get home and just made a bad move and hit the truck. I talked to witnesses of the accident say that Jason was weaving in and out of the HOV at high speeds, they advised he was just unable to maintain his lane and was very erratic in his driving behavior. While speaking to Jason I noticed that his eyes were blood shot and glossed over. I moved the crash scene off the main lanes to 27600 IH-45 N Feeder and transported Jason in my patrol vehicle as his truck was not drive-able. Upon checking to see how many airbags deployed in the vehicle, I observed an open Redd's Apple Ale beer bottle laying on the front passenger floor. While transporting Jason, I began to smell an odor of an alcoholic beverage coming from Jason in my vehicle. I asked Jason if he had anything to drink that day, Jason

advised he had 3 beers around 1800 hours as he was hog hunting earlier that day. I asked Jason if he had anything to eat when he was drinking and he advised he had a sandwich. Upon arriving to 27600 IH-45. The semi-truck that Jason struck was waiting in the parking lot of 27600 IH-45 N Feeder. The semi-truck that was struck by Jason was towing a flat-bed trailer fully load and you could see where the F-350 struck the driver side rear tire and corner of the trailer. I had several witnesses write voluntary statements saying what they saw leading up to the accident. I performed SFST's on Jason to determine if he may have been intoxicated at the time of the accident. Jason advised he didn't wear any glasses or contacts and had no previous head injuries or any injuries from the accident he was just in. I advised Jason that I was going to have him complete a few field sobriety field tasks to which he agreed to do. I then explained the Horizontal Gaze Nystagmus(HGN). Jason had equal tracking and pupil size with no resting nystagmus. Jason then reaffirmed that he had no previous head injuries or had a head injury from the accident. I explained that I needed him to follow the tip of my pen with his eyes only, Jason verbally stated he understood the directions I gave him. Jason moved his head the first two times I tried to perform the test on him. Jason had lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation in both eyes, and onset of nystagmus prior to 45 degrees in both eyes. Jason also showed all 6 clues, 3 in each eye. I then had Jason stand on one-leg with his arms by his side and count to 30. I asked Jason if he understood the directions and he replied that he did understand. During the one leg stand Jason was unable to maintain his balance, put his foot down repeatedly, also stepped to the side to catch himself multiple times, miscounted as well as skipped a few numbers in the 20's. Jason didn't finish the task and just stopped and started the phrase just do what you are going to do. Jason was then tested on the walk and turn, myself and Sgt Barry both demonstrated how we wanted Jason to perform the test. We asked Jason to take nine steps. Touching heel to toe each step with his hands down at his side, then to walk back nine steps the same way. We both asked if he understood how to do the test and he advised that he understood. Jason was using his arms to attempt to balance himself, he was unable to maintain his balance, couldn't finish the test, didn't walk heel to toe and was starting before he was instructed to do so several times. Jason kept saying do what you are going do and take me to jail. Jason's wife arrived on scene and spoke with Jason briefly about what bail bondman to get.

I placed Jason in custody for DWI and placed him in the back seat of my patrol vehicle. I opened the DIC-24 on my computer and asked Jason if he could see my computer screen, Jason advised that he could. I read the DIC-24 to him and asked if he would give a specimen of blood. Jason volunteered to give a specimen. I transported Jason to Memorial Hermann where his blood specimen was taken. While at Memorial Hermann I observed Nurse Debra Myers draw blood from Jason left arm at 2148 hours. When Nurse Myers filled both vials with blood, I observed her invert the tubes more than ten times each. The blood draw kit was boxed back up and sealed. While we were at Memorial Hermann, Jason was medically cleared to leave the hospital and be taken to CJC. Jason was then transported to Conroe for Male booking. A copy of the DIC-24 and DIC-25 was placed into Jason's property bag. Jason's truck was towed by CFM Towing to 6307 Big Oaks, Jason's wife was given the tow information at the scene. The blood draw kit was transported back to Oak Ridge North PD where it was placed into evidence along with open beer bottle found in the vehicle.

On 02/02/2018 at approximately 1647 hours, I Officer Duenas and Officer Teske observed a black Pontiac 2 door passenger car, displaying TXLP#CHW8724, traveling on Lane Ln near Westwood Dr. I ran the TXLP# through my MDT and the return showed the vehicle registration expired July 2017. I stopped the vehicle at Wickwood Dr at Westwood Dr. I made contact with the driver who identified herself by TXDL# X as Izabella Faye Mendoza w/f DOB X. While I was speaking with Mendoza I could smell an odor of burnt marijuana emitting from the vehicle. I asked Mendoza if there was anything else in the vehicle and she stated that there wasn't. Officer Teske made contact with the front right passenger who identified himself by name and DOB as Travon Dante Barnes b/m DOB X. Officer Teske observed an open 24 oz blue Steel Reserve Blue Razz alcoholic beverage between Barnes feet and he admitted to drinking it. While I was searching the vehicle I located in the center console cup holder a white container that contained pieces of burnt marijuana. I did not locate a usable amount in the vehicle. While searching the rest of the vehicle I did not locate any other contraband in the vehicle. Mendoza was issued ORNPD Citation# 52000785 for Display Expired License Plate. Barnes was issued ORNPD Citation# 52000786 for Open Container Alcoholic Beverage in Vehicle. Mendoza and Barnes were both released from the scene.

On 02-03-2018 at approximately 0825 hours I, Officer Helton, was traveling East on Robinson Rd approaching Maplewood. I observed a white Chevy pickup turning South on Maplewood from Robinson Rd. As I passed the Chevy pickup, I observed that the Registration on the vehicle showed March 2016. I turned around on the vehicle and caught up to the vehicle at Maplewood and Alana, the vehicle was bearing Texas license plate CYZ2848. I turned on my emergency red/blue lights on and conducted a traffic stop on the vehicle. I exited the patrol vehicle and walked up to the driver side window, the driver was identified as Nester Rodriguez Hispanic male date of birth X. The male said that he thought he might have warrants out of Montgomery County and gave me his Texas ID, while running Rodriguez through The Montgomery County Sheriff Office Dispatch, I was advised that Rodriguez showed to have two active warrants out of MCSO. I confirmed on the warrants and placed Rodriguez in custody and placed him in the back of my patrol vehicle without incident. I called for the first Oak Ridge North wrecker to my location for traffic hazard, the vehicle was towed by AW Towing to 18901 Main St. A tow slip was completed and left with Rodriguez's property at the jail. I transported Rodriguez to Montgomery South County jail, located in The Woodlands where the warrants were served. Rodriguez was also issued citation 1100402, for Displaying Expired License Plates and Driving While License Invalid. A copy of the two warrants were placed with this report.

On 02-03-2018 at approximately 1719 hours I, Officer Helton, was traveling East on Robinson Rd approaching Maplewood. I observed a black Dodge Neon turning South on Maplewood from Robinson Rd. As I passed the Chevy pickup, the vehicle was bearing Texas license plate CM5Y799. I ran the license plate on my mobile data computer and the return showed that the insurance was unconfirmed 45 days which means that there has been a lapse in coverage. I turned on my emergency red/blue lights on and conducted a traffic stop on the vehicle. I exited the patrol vehicle and walked up to the driver side window, the driver was identified as Matthew Bickham white male date of birth X. The male said that he thought he might have warrants out of Montgomery County and gave me his Texas DL, while running Bickham through The Montgomery County Sheriff Office Dispatch, I was advised that Bickham showed to have one active warrant out of MCSO. I confirmed on the warrant and placed Bickham in custody and placed him in the back of my patrol vehicle without incident, I searched the

vehicle after placing Bickham in custody and found a mult colored glass pipe and a gold grinder with debris of marijuana in both the pipe and the grinder. The grinder and the pipe were found in the center console in the vehicle, nothing else was found. Bickham requested that his friend, who arrived on location to take care and custody of the vehicle. The friend was identified as Justin Phelps white male date of birth X. Officer Richards transported Bickham to Montgomery South County jail, located in The Woodlands where the warrant were served. Bickham was also issued citation 1100409, for No Poof Of Financial Responsibility and Possession Of Drug Paraphernalia. A copy of the warrant was placed with this report. The grinder and the pipe were placed in the Oak Ridge North evidence locker.

On Saturday 02/03/2018, at approximately 2142 hours, I, Officer Valdez was patrolling near the 27000 block of the IH 45 North Feeder. I observed a vehicle displaying LP # KBD2071, so I ran the plate on my MDT and the return showed the vehicle to have the vehicle unconfirmed for more than 45 days. I then turned on my red and blue emergency lights and conducted a traffic stop. The vehicle came to a stop at the 27700 IH 4 5 North Feeder in the Pappas parking lot. I made contact with the driver of the vehicle and identified her by TX DL # X, as Brittany Victoria Walden, B/F, DOB X. There was also a passenger in the vehicle who I identified by name and DOB as, James Osricc Lockett, B/M, DOB X. I walked back to my patrol vehicle and ran both subjects on my MDT, and my return for Walden showed her to be wanted out of Montgomery County for Failure To Appear. Lockett's return showed him to be clear. I advised MCSO 2 Dispatch to confirm the warrant on Walden, and they did at approximately 2156 hours. I advised Walden that she was wanted and took custody of her at approximately 2203 hours. I then transported Walden to female booking at approximately 2207 hours and booked her in for the following warrant: #578504 - Failure To Appear -\$410.00 Waldens vehicle was released to Lockett after he provided a valid DL. Paper work, including a copy of the warrant will be turned in at the ORNPD for further review.
