

On 05/28/18 at approximately 1650 hours I, Officer Kennerly, was dispatched to a theft past, located at 26660 Interstate 45 North Feeder, Rooms To Go parking lot. Upon my arrival, I met with the reportee and victim, Sherah Beasley, white female, date of birth x. Beasley advised me that between the hours of 1515 and 1545 on 03/28/18, her husband was putting their stroller in the back of the Lexus carry all, Texas license plate KPS5506. The stroller had her wallet in one of the compartments. The wallet fell out of the stroller and onto the parking lot. Her husband did not know it at the time. The vehicle was parked facing westbound, next to the feeder road and close to the south Rooms To Go entry doors.

Approximately an hour had passed when I received the call. The wallet was a brown Michael Kors wallet, valued at \$200.00 and contained the following:

Texas driver's license number x  
Compass Business card with account info on it  
Compass business debit card  
Spark Capital One business credit card  
Woodforest personal debit card  
Chase personal credit card  
possibly a Best Buy credit card  
and some misc. reward cards.

The Texas driver's license was entered as stolen through TCIC/NCIC. I received NIC number A884953234, entered by Brand (Z1005), at 1736 hours.

I checked with Rooms To Go management to possibly get surveillance video. I was advised that they would have to go through lost prevention and it might take a couple of days.

I advised Beasley that if she could possibly get the debit card numbers for each debit card then I could also enter those in as stolen through TCIC/NCIC as well. A written statement was provided by Beasley.

On 06/02/18 at approximately 1215 hours I, Officer Kennerly, contacted Beasley to see if she had possibly found her wallet or if she had any debit card information

that could be entered in as stolen. Beasley advised she received a call from a lady stating that she found her wallet in the parking lot of Rooms To Go. Beasley advised she got the wallet back and nothing was missing. I advised Beasley that I would remove the driver's license from TCIC/NCIC as stolen.

On 06/01/18 at approximately 1245 hours I, Officer Kennerly, was dispatched to a theft past call, located at 26824 IH 45 North, Arlan's Grocery. I was sitting north of that location on the Feeder Road when I observed a white female walking northbound away from the grocery store. I asked Montgomery County Dispatch if they had a description of the female and was advised no. I called the store manager, Karol Medina, and she gave the exact description of the female that I was watching. I attempted to make contact with the female but she started walking faster and went into the Sears appliance store, located at 26824 IH 45 N. I went in to get her and she had gone into the women's restroom. I waited for her to come out for about 3 or 4 minutes and then advised her to come out or I would come in. She finally came out, was detained, and taken back to Arlan's.

She was identified by the manager, Karol Medina. The female was carrying two black purses, one of which contained two cartons of cigarettes that she wrote a hot check for last night, 05/31/18 at 2108 hours, among several other items. The other purse contained only her personal belongings. The female identified herself as Haylee Smith, with a date of birth of x. Smith told me that she was from Austin. Smith had no identification on her, so I had Montgomery County Dispatch sent me a driver's license photo for that name and date of birth. The TDL photo resembled the female I was dealing with. I showed the photo to the female and she told me that the photo was of her before she got all of her tattoos.

The check that was written last night was for \$246.49 and the signature is "Enrique Jaquez". The only stolen property that she had on her today was two cartons of Marlboro cigarettes and a pack of lighters from the night before. Medina provided an itemized receipt and the check that was written on 05/31/18. A property release form was filled out and the cigarettes and lighters were released back to Arlan's.

Medina advised that Smith tried to use another check just before Medina called 911. Medina advised her that she needed to pay cash and that her check was no good. Smith then ran out of the store. I never found a checkbook or check with

her property though. Arlan's wanted to press charges on Smith. I spoke with Montgomery County ADA, Pekkala, and she advised she would accept the charges. I placed Smith in custody and transported her to Female Booking in Conroe. Medina completed a written statement and is in the process of getting surveillance video of Smith signing the check.

At approximately 1830 hours, I received a phone call from Montgomery County Dispatch. They advised me that the female that I arrested, Haylee Smith, was fingerprinted, put on AFIS, and came back with a different name. At that point I was off duty. I contacted Oak Ridge North Sergeant Barry and advised him of the situation. Sgt. Barry told me he would go up to the jail, re-file the charges under the correct name, and add the charge of Fail to ID - Fugitive. Brandy Trawick, white female, date of birth x, was the true identity of the female that I arrested. Smith is one of the many alias that Trawick uses. Trawick showed to have a felony warrant out of the City of Rockdale. Warrant number 7000302 was for Forgery Financial Instrument Issued. The warrant was confirmed and sent over to the Montgomery County Jail. The charge for Fail To ID - Fugitive was also added.

On 06/01/18 at approximately 0529 hours, I received an e-mail from Montgomery County ADA Harris in reference to the original theft by check charge.

The actual e-mail from Harris reads:

"I have serious concerns about this case and charging it as a theft. The owner of the account listed on the check is Enrique Jaquez, but there is no indication in the arrest record as to who that is and why this woman had his checks. She signs the check as him, which likely makes it a state jail felony forgery if this Enrique Jaquez is a real person. If he's not real, then she has committed Fraudulent Use/Possession of Identifying Information.

There is also no information in the arrest record regarding whether or not this woman knew her bank account lacked funds necessary to cover this check. Theft cases involving hot checks are very hard to prove as it relates to intent, especially here where the check was written on someone else's account.

There is no indication in the arrest record as to why the person who accepted the check did so, when it was plainly apparent that this woman's name isn't Enrique Jaquez.

I am refusing the theft pending further investigation, as this is likely a much better forgery or fraud use ID info if we can figure out who this Enrique Jaquez individual is. She is still being held on the fail to ID fugitive and the out-of-county warrant."

While on patrol at approx. 9:50 pm on 06-01-2018 I, Sgt. Barry, saw a silver 2016 Toyota Corolla with Texas license plate JDW9856. This vehicle was eastbound in the 27200 block of Robinson Rd. with an expired motor vehicle registration sticker, Feb. 2018. I ran the license plate and confirmed the registration was expired Feb. 2018. I stopped the vehicle in the 27300 block of Robinson Rd. I approached the vehicle and noticed all the windows were rolled down. I identified the driver by her Texas driver's license #x as Frankee Michelle Boyd, w/f, dob x. As I was talking to Boyd, I could smell the odor of marihuana coming from the vehicle. I returned to my patrol car and asked Officer Richard to come to my location.

When Officer Richard arrived, I asked him to go ask Boyd for her phone number for the citation. Officer Richard returned and advised that he could also smell the odor of marihuana coming from Boyd's car. I asked Officer Richard and Officer Young to have the three occupants exit the vehicle and identify the two male passengers. The front right passenger was identified by his Kansas driver's license # x as Rash Devin Lee, w/m, dob x. The left rear passenger was identified by his Texas driver's license # x as Mason Jeffrey Ford, w/m, dob x.

Ford had a red backpack between his feet on the rear floorboard. Ford was asked if the backpack was his. Ford stated the backpack was not his but what was inside was. I asked Ford how long he has been using the backpack and he stated a few days. Boyd gave consent to search the vehicle. Ford stated the he had smoked marihuana today when they were asked why the vehicle smelled like marihuana. Officer Richard saw the red backpack on the left rear floorboard, advised that it was open, and that he could see a plastic bag containing a green substance. Officer Richard removed the backpack and found a plastic bag containing a green leafy substance I know to be marihuana, from law enforcement training and experience. Ford stated that it was his marihuana and was placed in handcuffs. Also inside the backpack was a small digital scale that is used to measure drugs.

The green leafy substance tested positive for marihuana using a NIK field test kit. The marihuana was weighed on Ford's scale at 18.2 grams.

I contacted the ADA on call and he accepted the charge of possession of marihuana on Ford. Ford was placed in the rear seat of my patrol unit.

Boyd was issued Oak Ridge North citation # 890852 for display expired license plate (reg). Boyd and Lee were released with the vehicle.

Ford was transported to CJC. I then returned to the Oak Ridge North Police Dept. where the marihuana was weighed on a triple beam scale at 18.5 grams. The marihuana was placed into the evidence locker.

On 06/01/2018 at about 1805 hours I, Officer H. Richard, received a non-emergency call from the Oak Ridge North PD phone of a theft past, at 145 Robinson Rd, the Valero Gas station. As I walked in the store, I observed the cashier counter is on the east side and faces west. I met with the reportee. She was identified by her TX DL number x, as Malva Nieves Longoria, DOB x, white female. Longoria is an employee of the store. Longoria advised an unknown hispanic male stole her phone. Longoria advised she left her phone on the counter by the soft drink machine and the trident gum display, while she went to take care of other store duties.

I asked Longoria if I could see the surveillance video. At about 12:37 pm the store's surveillance video shows a light blue Ram 1500 pick-up truck driving into the parking lot from Patsy. The truck parked in the second parking spot from Patsy in front of the store. A hispanic male exits the vehicle and walks into the store. The hispanic male was wearing blue jeans, grey shirt, a black baseball cap, and dark shoes. The hispanic male then walks to the ice machine and grabs a bag of ice. After that he walked to the soft drink dispenser and pours an unknown beverage.

The hispanic male picks up the reportee's pink and white phone with his right hand and walks toward the cashier counter. The hispanic male places the pink and white phone in his back right pocket. He then purchases the ice and soft drink and

walks out of the store. I was able to look at the height marker on the front exit door as he exits. The male is about 5 feet 5 inches tall, about 35 to 40 years old. His weight is about 220 pounds. The video from the store was not clear enough to see the license plate of the vehicle. At this time the suspect is unknown.

Longoria stated her phone cost about \$500.00. It was a pink and white Galaxy phone by T-Mobile. Longoria stated that when she gets home she will call the Oak Ridge North PD to advise the serial number of her phone.

On 06/02/2018 at about 0140 hours I, Officer H. Richard (2722), was patrolling south on Patsy Ln when I observed a grey SUV parked in the moving lane of traffic on Patsy at Kane Ln. I checked TX license plate number, JNZ7560, of the SUV through my Mobile Data Computer (MDC). The vehicle came back with unconfirmed insurance for more than 45 days. The registration was also expired since 05/2018. I made contact with the driver and asked for his license and insurance. The driver was identified by his TX DL number x as Richard Galvan Santiago, DOB x, Hispanic male. I asked Santiago if he had any alcoholic beverages to drink. Santiago stated that he had two beers, unknown what kind. I did not smell an alcoholic beverage coming from his breath. I asked Santiago to step out of the vehicle. I patted him down for Officer safety. I asked Santiago if I could check his eyes to make sure he is safe to drive. I conducted the Horizontal Gaze Nystagmus (HGN) and did not find any indication that he was intoxicated.

I asked Santiago if I could search his vehicle. Santiago would not give consent to search. I looked through the window of his vehicle and observed, in plain sight, a white powdery substance in a clear air tight baggie and what appeared to be mushrooms, in a separate clear baggie, on the passenger's floorboard. I asked Santiago what was in the clear baggies. Santiago stated the white powdery substance is cocaine and the other baggie is mushrooms. I tested the white powdery substance on a cocaine wipe and it turned blue, indicating positive for cocaine. The on-duty ADA asked that the mushrooms be sent to a lab to be tested. I weighed the cocaine with an Ohaus Dial-O-Gram Scale and the weight showed to be 2.2 grams. I also weighed the mushrooms on an Ohaus Dial-O-Gram scale and the weight showed to be 13.3 grams.

Santiago's vehicle was towed by Keith's Towing and stored at 27714 Robinson Rd, in fair condition.

I called the on-duty ADA and he accepted charges on Santiago for PCS PG1, >=1G<4G for the cocaine and PCS PG2, >=4G<400G for the mushrooms.

I placed Santiago in custody at 0145 hours. I transported Santiago to the South Montgomery County Jail for booking. The cocaine and the mushrooms were placed in the Oak Ridge North PD evidence room.

While on patrol at approx. 7:12 pm on 06-02-2018 I, Sgt. Barry, was in the 26400 block of the IH-45 E. Feeder Rd. watching traffic. I saw a vehicle pass me at a high rate of speed. I confirmed the speed using a Pro 4 Lidar at 62 MPH, where the highest posted speed limit is 45 MPH. I caught up to the vehicle identifying it as a silver 2012 Ford F150 with Texas license plates JXW9528. I ran the license plate on my mobile data terminal and saw the vehicle had a valid motor vehicle registration, August 2018, and the insurance was confirmed. I activated my emergency red and blue lights to make a traffic stop in the 27000 block of the IH-45 E. Feeder Rd.

The driver continued northbound on the feeder road at no more than 45 MPH. I could see in the Ford's view mirror the driver kept looking back at me. I activated my emergency siren and left the siren on as we were passing Woodson Rd. As the driver approached Tamina Rd., I advised Montgomery County Dispatch that the vehicle was not stopping. The driver came up to a red light northbound IH-45 E. Feeder Rd. at Tamina. The driver stopped for the red light behind other vehicles. When the light turned green and the traffic moved in front of her vehicle, she continued northbound at speeds of approx. 45 MPH. Once we cleared Tamina Rd., Shenandoah Officer Reade, Unit # 2842, pulled in behind my unit in a marked police patrol unit with emergency lights and siren on. The driver continued northbound without stopping. The driver then took the U-turn at Hwy 242 to head southbound. I saw traffic ahead of her vehicle and she had not been driving aggressively. I drove past her vehicle on the driver's side and pulled my patrol unit in front of her vehicle. The driver came to a stop behind my unit. I exited and approached the driver with my gun out, advising her to exit her car. The driver did not comply but did roll down the window and then unlocked the car door when told to do so.

The driver was removed from the vehicle. When I was trying to handcuff her she was pulling away and trying to get back to the vehicle. She was saying my baby, my baby. I asked her what about her baby, thinking maybe there was a medical emergency. She did not speak English. She identified herself as Kelly Orrellana, h/f, dob x. I ran the name given but did not find a driver's license. Several Officers had arrived to assist. One of the Officers who spoke Spanish, advised she said she did not stop because she got scared and had a bad encounter with Police from Mexico. She didn't say anything more about her baby. Kelly identified the three children in the back seat as Xoschilt, dob x; Sandra, dob x; and Justin, dob 12-24-x. I thought she stated they were all her kids and the last name of the children was Orrellana, as is her last name. Later I was told she was the baby sitter and they were not her kids. I failed to get the correct last names of the children.

I contacted the ADA and he accepted the charge of evading in a motor vehicle. Kelly was arrested. We learned she was on her way to her husband, who was on the side of the roadway on IH-45 southbound at Lake Woodlands, with a flat tire. I sent Officer Young to the husband's location so he could bring him to my location to take the vehicle and children. Officer Young returned with a h/m, identified by his Texas driver's license # x as Deyber Josue Pineda Andrade, dob x. Deyber stated he was Kelly's cousin and he came because he had a valid driver's license. Kelly stated he could take custody of the children and the vehicle. Deyber was then released with the vehicle and children.

Kelly was transported to the Montgomery County Jail.

I later went and checked the distance we travelled at 3.5 miles from beginning to end.

On 06/03/2018 at about 2232 hours I, Officer H. Richard, was dispatched by Montgomery County Sheriff's Office to a welfare check at 28264 Nancy Ln. MCSO Dispatch advised the reportee was calling 9-1-1 concerning Amy Fisher. MCSO Dispatch advised Amy Fisher was at the reportee's door and was having a panic attack. I arrived on scene and met with the reportee. The reportee was identified as Gaeten Alexandre Jones, DOB x, white male. Jones advised that Amy Fisher came to his house and was having a panic attack. He asked Amy Fisher if she



wanted him to call EMS. Jones called EMS and advised to have Oak Ridge North PD to come as well. I met with the subject and I identified her as Amy Fisher, DOB x, white female, from my previous encounters with her. Amy stated that she wants EMS to check on her. Myself and Officer Young, with the Oak Ridge North PD, checked Amy Fisher's house to see if her kids were at home. Amy Fisher's kids were not on location. Medic 25 arrived on scene and transported Fisher to Methodist Hospital without further incident.

On 06/03/2018 at approximately 1907 hours I, Officer Young, was on routine patrol when I received a public service call about a Natural Death call at 231 Ridgewood Drive. The address of 231 Ridgewood Dr, Oak Ridge North, Texas 77385, is a Hospice facility. The reportee, who is also an employee at the facility, was identified by TX DL # x as Deshauniqua Conner (B/F: DOB x). She called to notify the Police that Evelyn Rourke (W/F: DOB x: 90 years of age) passed away that evening from natural causes. Conner advised that the deceased was in bedroom #2, which is located in the southwest corner of the facility. When I entered into the room, I observed the deceased female laying on her back in the bed. Her body was covered with a blanket and only her head was exposed. The reportee explained to me that Rourke had been in this facility for 10 years. Rourke had been diagnosed with Alzheimer's and that is when she was placed in the hospice facility so she could receive constant care. Rourke's condition began to worsen a week ago as a result of her age and the Alzheimer's advancement. Conner advised she was in the room with Rourke when she passed. Conner advised she passed at 1815 hours and notified the RN working at the facility. The reportee contacted the family, who arrived at the facility shortly after. The family advised they would have her body transported back to Louisiana for the funeral. The Hospice facility arranged for Kirk Mortuary to come pick up Rourke and transport her to their facility at 2017 Airline Dr., Houston, TX 77009. Kirk Mortuary then will be transporting Rourke to Gossen Funeral Home at 504 N. Polk Street, Rayne, LA 70578.

I advised Dispatch of the deceased person and advised them to page the Justice of the Peace. I received a public service from Judge Metts at 2033 hours. I advised Judge Metts of the details of the natural death and he advised that he would be signing off on releasing the deceased to the family. Judge Metts also advised he would be sending someone out to Oak Ridge North Police Department to get a

copy of the report, on 06/04/2018, for his records. Sgt Barry and Lt. Libby, with the Oak Ridge North PD, were made aware of the call.

I made contact with Berry Thomas (W/M: DOB x) who is an RN at the Hospice facility. Berry released Rourke's medications to me and gave me a copy of all medications that Rourke was taking. Thomas also gave me a copy of a detailed count of the remaining doses left in her medications. I took those medications and the lists back to the Oak Ridge North Police Department where Officer Richard (2722) and I counted the contents released to us. All of the doses matched, and all medications were accounted for. The medications were placed into a sealed property bag and placed into Oak Ridge North PD evidence locker. I attached the list of medications and the copy of the dosage list to this report.

On 06/03/2018 at about 1843 hours I, Officer Young, was dispatched to a Medical call at 28264 Nancy Ln. MCSO Dispatch advised that a female was at the reportee's door and was having a panic attack. I arrived on scene and met with the reportee, who was identified by TX DL # x as Gaeten Alexandre Jones (W/M; DOB x). Jones advised that his neighbor, Amy Fisher, came to his house and was having another panic attack. Officer Richard and I were dispatched to the same house the previous night on a call involving Amy Fisher. The female who was having the panic attack was identified as Amy Fisher (W/F; DOB x). I know this to be Amy from my previous encounters with her. Amy stated that she was scared and had been drinking. Officer Richard went to Amy's residence next door to see if anyone was home. He checked the house to see if Fisher's kids were home. Amy Fisher's kids were not on location. Officer Richard made contact with Amy's mother. The mother advised that she was the one who provided Amy with the alcohol. Medic 23 arrived on scene and transported Fisher to Methodist Hospital, without further incident.

On 06/04/2018 at approximately 1124 hours I, Officer Teske, was advised by MCSO Dispatch of a welfare check call at 26826 Nancy Lane. Dispatch advised that Melinda Diesen (w/f, dob x) called 911 in reference to her daughter, Amy Fisher (w/f, dob x). Dispatch advised that Diesen said that Fisher was having alcohol withdrawal symptoms, that Fisher took her keys, and would not give them back. Diesen advised Dispatch that Fisher was also begging for alcohol. I arrived

on scene and met with Diesen. She stated that everything was okay because Fisher gave her the keys back. Diesen stated that Fisher went away for about three weeks and when Fisher arrived back home, she (Diesen) gave her alcohol. Diesen now appeared to realize that was a bad idea and Fisher was begging for more alcohol because she wouldn't get her more. I met with Fisher in her upstairs bedroom and observed there were empty vodka bottles strewn throughout the room. Fisher confirmed that she was trying to get her mother to get her more alcohol and she was irritated because she wouldn't get her more. She advised her kids were currently with their father and she was not allowed to see them. Fisher appeared sober and did not appear to be in any immediate danger, while I was on location. I then returned to service.

On 06/04/2018 at approximately 2043 hours I, Officer Duenas, observed a blue Dodge Neon, displaying TX LP # BFJ4364, at the intersection of Hanna Rd and Robinson Rd with the third brake light out. I stopped the vehicle at Harlan Ln and Robinson Rd. I made contact with the driver, who identified himself by TX DL # x as Darren Keith Coleman II, white male, DOB x. I asked Coleman if he had anything illegal in the vehicle. Coleman stated he had a vape pen that contained marijuana - THC Oil. I had Coleman step out of the vehicle and I detained him. I asked Coleman where the vape pen was at and he stated it was in his front right pocket. I removed the vape pen from his pocket. I tested the liquid inside using a NIK Test Kit which tested positive for marijuana. Coleman stated that he had an empty cartridge of the marijuana - THC Oil inside a box inside his backpack located on the front right passenger seat. I searched the backpack and located the box with the empty cartridge. The box that contained the empty cartridge had writing on it stating "Ingredients 500mg of pure cannabis oil". I made contact with the Montgomery County on call ADA and they advised he would accept the charge of Possession of Controlled Substance, PG 2 < 1 gram. I placed Coleman in custody for Possession of Controlled Substance, PG 2 < 1 gram. The vehicle was towed by CFM Towing to 6317 Big Oaks. Coleman was issued ORNPD citation # 1100932 for Fail to Report Change of Address. I transported Coleman to the South County Jail for booking.

The cartridge that contained the THC Oil was transported to the ORNPD. The THC Oil was weighed at 9.5 grams using an Ohaus Triple Beam scale. The cartridge that contained the THC Oil, the empty cartridge, and the box were placed in the ORNPD evidence locker.

On Tuesday, 06/05/2018, at approximately 0114 hours I, Officer Valdez, was dispatched to a medical call at 28264 Nancy Ln. The call was about Amy Fisher, W/F, DOB x. The reportee was Fisher's neighbor, who I identified by TX DL # x as Alex Jones, W/M, DOB x. When I arrived on scene, Jones advised that Fisher came to his home at two in the morning wanting to talk and would not let him and his family sleep. Jones advised that Fisher stated that she had been drinking alcohol prior to her contact with Jones. I made contact with Fisher and she smelled like alcohol. I asked Fisher if she had been drinking any kind of alcoholic beverage prior to her contact with Jones. Fisher advised that she had a large cup of vodka. Jones advised that Fisher has been making a habit of coming to his home late at night and disrupting his peace. I then placed Fisher in custody for Public intoxication and transported her to the Conroe Jail.

Fisher was issued a citation for Public Intoxication. The citation # is 16900683.

Fisher was also issued a trespass warning on Thursday, 06/05/2018. The trespass warning forbids Fisher from going to her neighbor's home at 28264 Nancy Ln. I explained to Fisher what the trespass warning was for and I then asked her to sign the warning, Fisher signed the trespass warning and was given a copy of the warning to keep for her own personal records.

The booking paperwork along with the citation issued to Fisher will be turned into the ORNPD for further review.

On 06/05/2018 at approximately 1853 hours I, Officer Duenas, observed a white Buick traveling north in the 27900 block of the IH 45 North Feeder. A check through my MDT showed the vehicle insurance to be Unconfirmed- last match not within 45 days. I stopped the vehicle at 19445 IH 45 North Feeder. I made contact with the driver who identified himself by TX DL x as Tyrene Terrell Wall,

black male, DOB x. Upon contact with Wall, I could smell a strong odor of burnt marijuana emitting from the vehicle. I asked Wall to step out of the vehicle and move to the rear of his vehicle. Wall did not cooperate with my commands. I asked Wall several times to step to the back of the vehicle, which he did not comply. I then asked Wall to turn around and place his hands behind his back so I could detain him for my safety. Wall refused to comply with my commands to place his hands behind his back. I then applied force to try to detain Wall, which Wall started to refuse. I felt Wall apply pressure off his trunk and pushed off his vehicle. I then took a step away from Wall, drew my Taser at Wall, and advised him to get on the ground. I asked Wall several times to get on the ground, which he refused to do. Wall then made a sudden movement and took off running west from 19445 IH 45 North Feeder. I advised dispatch that I had one running and I made chase after Wall running south of Lupe Tortilla toward Main Event. Wall began to take off his black barber coat and red "do-rag" and threw it on the ground. While Wall was taking off his do-rag, he tripped over a curb and landed face first into the ground. I then pointed my Taser at Wall and told him to stay on the ground or he was going to be tazed. Wall complied with my commands and stayed on the ground. Officer Valdez arrived on location shortly after and detained Wall. I then relocated back to the traffic stop location. I asked Wall if he had anything illegal in the vehicle, and Wall stated he had a little marijuana blunt in the center console cup holder. Upon searching the vehicle, I located the marijuana blunt where Wall stated it would be. I did not located any other illegal contraband in the vehicle. I checked TX DL # x through my MDT and it showed Wall to be Not Eligible due to No Insurance. I made contact with the Montgomery County on call ADA and they advised they would accept the charge of Evading Arrest or Detention. I then placed Wall in custody for Evading Arrest or Detention. The vehicle was towed by Aggressive Towing to 1607 Rayford Rd. Wall was issued ORNPd citation # 1100942 for DWLI, and No Insurance. I then transported Wall to the MCSO Jail for booking.

On 06/06/18 at approximately 0915 hours I, Officer Kennerly, was sitting stationary checking speeds with a Kustom Pro Laser III Lidar in the 26700 block of the Interstate 45 North Feeder Road. I observed a black Mercedes, bearing Texas dealer plate LKQTX, traveling 64 MPH in a 45 MPH posted zone. I stopped the vehicle in the 26800 block of the Interstate 45 North Feeder, in the Arlan's parking lot. I made contact with the driver, later identified as Andrew Fincher, white male, date of birth x. I advised Fincher of his speed and asked for his driver's license and proof of insurance. Fincher provided both. I checked Fincher on my mobile data computer and he showed to have a felony warrant out of Nevada. I checked with Montgomery County Dispatch and they showed the same information. The warrant was for Fraud - Insufficient Funds Check. OCA number 1609018094 and NIC number W342157731 were confirmed. I placed Fincher in custody and transported him to Male Booking in Conroe. Fincher's vehicle was released to his wife, Dixie Fincher, white female, date of birth x.

On 06/07/2018 at approximately 2243 hours I, Officer Young, was patrolling the I-45 North Feeder near Woodson Rd, when I observed a grey Chrysler 300 driving in front of me. I checked the vehicles plates through my MDT and it showed the vehicles registration to be expired as of 07/2017. I conducted a traffic stop at Pine Manor/ IH-45 North Feeder. I confirmed the expired registration shortly after stopping the vehicle. I made contact with a female driver and sole occupant, she was identified by TX DL # x as Justine Osina (W/F; DOB: x). During my first contact with Justine, I noticed that she was very nervous and moving around a lot. I asked for identification and returned to my patrol vehicle. Upon running Justine through my MDT, it showed that she had been previously handled for PCS and marijuana. I then returned to Justine's vehicle and Justine was still very nervous and became defensive when I asked if she would give consent to search the vehicle. Justine advised that she would not give consent and felt we had no probable cause to search the vehicle.

I asked dispatch to air for any available K9 unit to check by. MCSO Deputy R. Jackson (K9003) advised he would be en route to our location from 45/Sawdust. Justine was asked to step out of the vehicle and stand in front of my patrol car until K9003 arrived on scene. K9003 arrived on scene approximately seven minutes following my call and took his dog around the vehicle, at one point the dog alerted on Justine's vehicle. At this point I had probable cause to enter the

vehicle and search it. Officer Richard (2722) and I, Officer Young conducted a search of the vehicle, Officer Richard noticed that the coin holder next to the gear shifter was elevated out of place. Officer Richard pulled the coin holder up, as it came off, Officer Richard advised that he observed a clear small plastic bag containing a white powdery substance in the void under where the coin holder should be. The clear plastic bag was removed, I tested the white powdery substance with a NIC cocaine swab. The swab turned blue upon contact, which indicated a positive result for cocaine. When I was testing the cocaine, Officer Richard was searching the trunk and found a marijuana pipe along with a clear plastic bag containing a green leafy substance in a purse that Justine confirmed to be hers. I knew through my experience and training as a Texas Peace Officer, that the green leafy substance was marijuana. I called the on duty ADA and advised of what I had, the ADA accepted charges for PCS PG1 (cocaine) <1G but denied the marijuana charge. I took Justine into custody and transported her to The MCSO Female booking. The total amount of the cocaine found weighed approximately 0.3g and the marijuana weighed approximately 1.6g.

Justine's vehicle was towed by Rickey's wrecker to 9131 Hwy 242. A copy of the tow information was placed in her property. A citation #520226 was issued for Expired Registration, a copy of the citation was also placed in her property. The cocaine and marijuana were seized and transported to the Oak Ridge North PD, where they were placed in a sealed evidence bag. That evidence bag was then placed in the Oak Ridge North PD evidence locker.

On 06/08/2018 at approximately 1257 hours, ORNPD Officer Stafford stopped a green Honda Civic, displaying TXLP# JCX3930, in the 27900 block of IH 45 North Feeder Road for Unconfirmed Insurance. The insurance, State Farm policy 33599238K2053B002 showed expired 01/03/2018 - Last Match Not Within 45 Days. I, Officer Teske, checked by with Officer Stafford shortly thereafter. Officer Stafford advised me that he smelled an odor of marijuana emitting from the vehicle and asked that I speak with the driver. I made contact with the driver, identified by TDL# x as Mario Bermea w/m dob x. Bermea was sitting in the driver seat and I made contact with him from the open front passenger window. I observed marijuana debris on the center console area between the two front seats and smelled an odor of burnt marijuana emitting from the vehicle. He stated that he was going to Oak Ridge High School to sandblast sports equipment. I

asked if there was anything illegal in the vehicle and he stated that there was not. He further stated that I could look in the vehicle if I wanted to. I went around to the driver side of the vehicle and had Bermea step outside. I patted him down and felt a bulge in his front left pocket. I asked what it was and he stated that it might be money. I asked him to empty the pocket and he complied and when he removed his hand from the pocket I observed several dollar bills, I also observed a clear plastic bag containing marijuana fall to the ground. I placed Bermea into handcuffs and retrieved the bag, containing a usable amount of marijuana. I tested the marijuana using an NIC Test kit and the kit showed a positive result for marijuana. Less. The vehicle was towed by Aggressive Towing and was stored at 1607 Rayford. Bermea was issued citation #41242 for the offenses of No Insurance and DLR Restriction Violation. I transported Bermea to the MCSO Male Intake for booking.

After leaving the jail, I took the marijuana to the ORNPD where it was weighed using a Ohaus Dial O Gram scale. The marijuana weighed 3.0 grams. The marijuana was placed into evidence at the ORNPD.
