On 04/29/19 at approximately 1020 hours, Lt. Hubbard, Lt. Barry, Det. Rogers, and me (Sgt. Nation) checked out at xx., Conroe, TX., in reference to a Felony Warrant service on Alfredo Lares Medina, w/m, dob xx. Det. Rogers and I made contact with Mr. Lares at his front door and he identified himself to me by name to be the defendant. I detained Mr. Lares and Montgomery County Sheriff's Communications confirmed the following warrant: # 19-04-05734 - Fraudulent Use and Possession of Identifying Information (\$1,500 Bond). While waiting for warrant confirmation from communications, Det. Rogers conducted an interview with Mr. Lares. (See Det. Rogers' Supplement.) Lt. Hubbard and I transported Mr. Lares to the South Montgomery County Jail. Upon our arrival to the jail, Mr. Lares was booked in on the warrant and released to jail staff without incident.

On 04/30/2019 at approximately 0030 hours I, Sergeant Teske, was advised by MCSO Dispatch of a warrant service call on the IH 45 North main lanes near FM 1488. Dispatch advised me that DPS Trooper Jackson (2C905) was currently out with Alvaro Magana (W/M; DOB xx) and Magana was showing active warrants through the Oak Ridge North Municipal Court. I confirmed the following 2 warrants: #4173001 for Expired Registration (fine \$266.00). #41730F01 for Failure to Appear/Bail Jumping (fine \$348.00). The total fine amount was \$614.00.

I met with Trooper Jackson on the IH 45 North main lanes near FM 1488, at 0044 hours. Trooper Jackson advised me that he had Magana in custody for DWI and he would also book him on the Oak Ridge North warrants. I left the warrants with Trooper Jackson and returned to service.

On 04/30/2019 at approximately 0050 hours I, Officer Jared Young, was contacted by MCSO Dispatch to confirm warrants on Angelina Johnson (W/F; DOB xx). DPS Trooper R. Askew, Unit #2C901, had Johnson detained during a traffic stop in the 17700 block of the IH-45 South main lanes. At 0058 hours, I was able to confirm two outstanding Oak Ridge North warrants on Johnson. Sgt. M. Teske, Unit #2704, had already made the scene with Trooper Askew. Sgt. Teske took Johnson into custody and met me at 19153 IH-45 North Feeder. I took Johnson into custody from Sgt. Teske and I transported Johnson to female booking at #1 Criminal Justice Drive. I booked the subject and executed the warrants at the jail under booking #69087.

The warrants were as follows:

#520692 01 - Speeding 70 MPH in a 45 MPH Zone. The fine amount for this warrant is \$312.00.

#520692V 01 - Violate Promise to Appear. The fine amount for this warrant is \$374.00.

The total fine amount for all warrants is \$686.00.

After Johnson was booked on the warrants, Sgt. C. Nation was notified of the warrant arrest.

On May 01, 2019 at approximately 1150 hours I, Office Saulter (Unit 2734), was contacted on my cell phone by Trooper Jackson (2C905), with the Texas Department of Public Safety, and asked to confirm warrants on Shawn Keith Goodin, W/M, DOB xx, TX ID # xx. After arriving at the PD, I located two active ORN warrants on Shawn. The warrants were for No Proof of Financial Responsibility - UVFR - #1163608701, fine \$468.00 and Failure To Appear/Bail Jumping - #11636087F1, fine \$348.00. The total fine amount for the active warrants is \$816.00. After locating the warrants, I met Trooper Jackson and Shawn at the MCSO South County Jail. I asked Shawn if he was able to pay the fines and he stated that he could not. I then booked Shawn into the MCSO South County Jail without incident.

On 05/02/2019 at approximately 0052 hours I, Officer Durham, stopped a white Jeep Compass, displaying TX LP # xx, for No License Plate Light. I stopped the vehicle at Robinson and Blueberry Hill Dr. The driver was identified as Charles Collins (W/M; DOB xx) by his TX ID #xx. I asked Collins if he had insurance. Collins stated his insurance was expired. I asked Collins if he had a driver's license. Collins stated he did not have his TX DL with him and that it was suspended. A check on my MDT showed that Collins had a TX DL #xx. Collins' TX DL was Not Eligible due to the following:

Collins also had a previous conviction for Driving While License Invalid:

A search on my MDT revealed Collins had an outstanding Oak Ridge North Municipal Capias Pro Fine Warrant for the following: #253442 01 - Possession of Drug Paraphernalia - fine \$410.00. Collins was unable to pay the fine amount of \$410.00. Due to the active suspensions and the previous conviction for DWLI, Collins was arrested for the offense of Driving While License Invalid enhanced with previous conviction, and the ORNPD Capias Pro Fine Warrant.

The Compass was towed by Rickey's Wrecker to 9131 Hwy 242. I transported Collins to the MCSO South County Jail for booking. He was also issued ORNPD citation # 72582 for the offense of no insurance and no LP light.

While on patrol at approximately 2250 hours on 05-01-2019 I, Sgt. Straight, was traveling westbound on Woodson Rd. approaching Harlan Ln. I observed a silver 2010 Hyundai traveling eastbound on Woodson Rd. approaching Harlan Ln. The vehicle failed to dim its bright lights for oncoming traffic. After the vehicle passed by me, I turned around at the intersection of Woodson Rd. and Harlan Ln. and heard the vehicle accelerate away from me. I confirmed the vehicle's speed with my LIDAR. The vehicle was traveling 47 mph in a posted 30 mph

zone. The roadway was wet, and it had been raining. I stopped the Hyundai, displaying TX LP # xx, and made contact with the driver.

As I spoke to the driver, I could smell the odor of what I know to be raw marijuana coming from inside of the vehicle. The driver was identified as Leija, Zhyra, b/f, DOB xx, TX DL # xx; front right passenger was identified as Hill, Shannon Matthew, b/m, DOB xx, TX ID # xx; and the left rear passenger was identified as Domenech, Sergio Miguel, h/m, DOB xx. All occupants were taken out of the vehicle and a search of the vehicle was conducted. A small black make-up bag was located on the floor of the front right passenger area. Inside of the bag were three zip lock quart size bags, containing suspected marijuana and loose cash. A small hand gun (High Point serial #xx) was located on the front right passenger floor and another hand gun (Jimenz Arms serial #xx) was in the door of the front right passenger door. Both handguns were loaded, with a round in the chamber. All three subjects were Mirandized (CCP Art. 38.22) and stated they understood their rights. Hill stated on camera (Unit #77) that the marijuana was his.

Both hand guns were checked through MCSO Dispatch and both were showing not to be stolen at this time. The suspected marijuana was tested with a NIK field test kit and tested positive for marijuana. The marijuana was weighed on the Ohaus triple beam balance scale and weighs approximately 83.1 grams (2.93 ounces). I contacted ADA Dudley and ADA Dudley accepted charges for Possession of Marijuana and Unlawful Carry of a Firearm. Hill was taken into custody for possession of marijuana, 4oz > 2oz, and UCW and transported to the South Montgomery County Jail.

The marijuana was placed into the evidence locker at the Oak Ridge North P.D.

The High Point 9mm handgun, serial number xx, was secured and placed into the evidence gun locker at the Oak Ridge North P.D.

The Jimenz Arms 9mm handgun, serial number xx, was secured and placed into the evidence gun locker at the Oak Ridge North P.D.

The \$287.00 in cash was placed into the evidence locker at the Oak Ridge North P.D.

On Thursday, 05/02/19, at approximately 0955 hrs, I, Det. James Kipness, arrived at MCSO Central Jail Records to serve 3 ORN municipal warrants on Fisher, Ashley Kay, w/f, dob xx. Ms. Fisher was already in custody at the jail. The ORN warrants were for Expired Registration (#25223901, fine \$535.81), Motor Vehicle Inspection Violation (#25223902, fine \$591.58), and FTA/ Bail Jumping (#252239F01, fine \$699.74). The total fine amount was \$1,827.13. After serving the warrants, I returned to service. End of narrative.

On 05/02/2019 at approximately 0905 hours I, Officer Saulter, was contacted by Detective Rogers (Unit 2715) in regard to a resident, at xx Susan, calling in about a truck parked in front of his residence possibly by an ORHS student. Upon arriving to the location, I observed a black Ford F150, displaying TX LP #xx, parked on Susan Lane. The vehicle was parked facing W/B along the curb line. Signs posted throughout the Oak-10 neighborhood inform drivers that vehicles that are parked on the roadway between 0630 hours and 1130 hours must display a valid parking permit. The signs also inform drivers that vehicles without a permit are subject to being towed. As I passed by the Ford, I observed there was no Oak Ridge North resident parking permit or visitor hang tag displayed on or inside the vehicle. The registered owner of the vehicle is Domony W. McClintock III, xx, Spring, Texas 77386. Because the vehicle had no permit or hang tag displayed during the designated hours, the vehicle was towed by Keith's Towing and stored at 27714 Robinson Road.

On 05/02/2019 at approximately 1821 hours Sgt. Straight (2703) and I, Officer Durham (2728) were waved down by a female driving a black passenger car at the intersection of Hanna Rd and Robinson Rd. I asked the female to relocate to the parking lot of TADA Dance Studio, located at 26803 Hanna Rd. The female identified herself as Medina

Dioselina (H/F; DOB xx) by her TX DL #xx. Dioselina stated her son, Hector Borras (H/M; DOB xx), was sleeping at her house located at 28711 Robinson Rd. Dioselina stated Borras had warrants for his arrest and had been hiding from the police. Dioselina stated Borras told her he had been involved in a stabbing that took place a few days ago at an apartment complex. I ask Dioselina if Borras told her what complex. Dioselina stated the apartments near IH 45 South and Rayford. Dioselina stated that Borras had told her that he and his girlfriend, Hannah Stephens (W/F; DOB xx), were at a club before the stabbing. Dioselina stated Borras said the kidnapping had taken place at a club before they arrived at the apartment complex. Dioselina mentioned Stephens had been selling meth recently and did not know if the kidnapping was related. Dioselina stated she did not want Borras to find out that she was the one that told the Police. I advised MCSO Dispatch and asked for a MCSO Deputy to check by my location. I spoke with Deputy Perez (2P1030) and advised him of the call. Deputy Perez, Deputy McCarty (2P1004), and Deputy Ellis (2P1022) arrived at 28711 Robinson Rd. and took custody of Borras without incident. Deputy Perez asked me to get a voluntary statement from Dioselina concerning the information she told me and any other information she may know. I asked Dioselina to complete the voluntary statement form. Dioselina told me that the information she gave me earlier was wrong. Dioselina told me I had heard the information wrong and she would not complete the form. Dioselina stated she did not want to write the information down she heard from Borras because it could be wrong information. I advised her the information she was told would be a help to detectives in determining what happened in the case. Dioselina denied stating what she had said prior to Borras' arrest. Dioselina stated she was afraid her son would find out that she told the Police. Dioselina then stated the information she told me was from a text message. I asked Dioselina who sent the messages. Dioselina stated they were from one of Borras' friends. Dioselina stated she was unsure about the friend's name and his number. Dioselina did not state to what phone the messages were sent to. Dioselina was released and drove away.

I advised Deputy Perez that Dioselina refused to complete the voluntary statement form.

On 05/04/2019 at about 0030 hours I, Officer H. Richard (2722), observed a black Jeep Cherokee, displaying TX LP number xx, in front of me in the 27300 block of Woodson Rd. A check through MCSO Dispatch showed the license plate expired 05/2017. Sgt. Teske and I made a traffic stop at Jack-in-the-Box, located at 1250 Lake Woodlands. The driver was identified as Joseph Buel Chatham, DOB xx, white male. I also observed a young boy in the back-right passenger seat. The young boy was identified as JUVENILE. Chatham stated that JUVENILE was his son. I observed the registration sticker on the front window displayed license plate number xx. xx showed to be registered to a 2008 Mercedes Benz, registered to a Travis Lee Thompson.

A check through MCSO Dispatch showed that Chatham had three outstanding warrants. One warrant was through the Gregg County Sheriff's Office. Two warrants were through the Oak Ridge North PD. MCSO confirmed warrant number W836176691 for Theft of Property, \$100 < \$750, through Gregg County SO.

Officer Jared Young, with the Oak Ridge North PD, confirmed 2 outstanding warrants: warrant number 1163632601 for Expired Registration, with a fine amount of \$266.00 and warrant number 11636326F1 for Failure to Appear/Bail Jumping, with a fine amount of \$348.00. The total Oak Ridge North PD fine amount is \$614.00. Chatham called a friend to come and pick up his son. The friend was identified as Branden Kyle Cassidy, DOB xx, white male. After Cassidy took custody of JUVENILE, Chatham was placed in custody at 0044 hours. Chatham was also issued citation number 1696363 for Display Expired License Plates (REG), Driving While License Invalid, Wrong Registration, and Fail to Maintain Financial Responsibility. Chatham was transported to the Montgomery County Jail in Conroe for booking.

On 05/04/2019 at approximately 1601 hours I, Sergeant Teske, was checking vehicle speeds on the IH 45 North Feeder Rd, using a Kustom Pro Laser 4. I observed a silver Dodge Dart, displaying TX LP # KRB3344, traveling at a high rate of speed in the center lane. The Lidar indicated the vehicle was traveling 66 mph and the highest posted speed is 45 mph. I stopped the vehicle in the 26700 block of the IH 45 North Feeder Rd. The driver was identified by name and date of birth as Cecilia Molina (W/F; DOB xx). She was unable to provide a valid insurance card for the vehicle. My MDT showed the insurance, Infinity County Mutual, policy #xx, expired on 12/04/2018. A check with MCSO Dispatch revealed that Molina's TDL, # xx, was Not Eligible due to the following:

Due to the active suspensions and no liability insurance, Molina was arrested for the offense of Driving While License Invalid (enhanced with no insurance).

The front right passenger was identified by name and date of birth as Gabriella Valdez (W/F; DOB xx). A check with MCSO Dispatch revealed that she was only issued a TX ID card, #xx, and the status of her ID card was Not Eligible. Valdez was released from the scene on foot. The vehicle was towed by Rickey's Wrecker and was stored at 9131 SH 242. Molina was issued ORNPD citation #11001767 for the offenses of Speeding 66/45 and No Insurance. Molina was transported to the MCSO Female Intake for booking.

On 05/04/2019 I, Officer Jared Young, was contacted by MCSO Dispatch to confirm warrants on Tyler Shelton (W/M; DOB xx). Shenandoah Officer C. Duenas, Unit #2841, had the male detained on a traffic stop at 500 Thornwood Drive. I was able to confirm five outstanding Oak Ridge North warrants on this subject at 2100 hours. Officer Duenas took Tyler into custody on the Oak Ridge North Warrants. Tyler also had warrants out of MCSO and he was taken into custody for those warrants as well. Officer Duenas booked Tyler and executed the ORN warrants at the jail.

The warrants were as follows:

#1100153601 - Driving While License Invalid. The fine amount is \$326.00.

#1100153602 - Fail to Maintain Financial Responsibility. The fine amount is \$468.00.

#11001536F1 - Failure to Appear/Bail Jumping. The fine amount is 348.00.

The total fine amount is \$1,756.00 for all five warrants. After the subject was booked on the warrants, Sgt. C. Nation was notified of the warrants being executed.

On 05/05/2019 at approximately 0530 hours I, Officer Jared Young, was patrolling the business complex at 26797 Hanna Road. I observed the front glass door to Simon's Barber Shop was shattered. I did not observe any suspects when I arrived on scene. There was no alarm sounding at the business. I entered the business through the broken glass door to search for any suspects and I did not observe any suspects while clearing the building. I did not observe any object in the barber shop or in the parking lot that could have been used to shatter the glass.

The scene consisted of a bench seating along the north wall of the shop and six barber chairs with desks on the south wall of the barber shop. The middle area between the barber chairs and the benches was an open area. I observed several desk drawers were open and several electric clippers laying on the floor along the bottom of the barber chairs. I observed the power cord to a Wall brand electric clipper had been cut, at the second barber chair. I did not observe the cords to any of the other barber chairs to be cut. I did not observe any other damage to the business, other than the front door and the electric clippers.

I made contact with the business owner, James Simon (W/M; DOB xx), by phone. I advised James of what had happened and that I would need him to make the scene. James arrived on scene shortly thereafter. I asked James when the last time someone was at the barber shop. James replied that he closed the barber shop around 1815 hours on 05/03/2019. I asked James to look around and see if he saw anything that had been taken from the business. After looking around, James stated that nothing was missing. I asked James if there had been any disgruntled customers, employees, or former employees. James replied that there have not been any issues with anybody at the barber shop. I advised James that the power cord to the electric clippers at the second chair was cut but all the other cords at the other barber chairs were not. I asked James for the value of the clippers and the glass front door. James advised that the clippers were valued at \$80.00 and the front glass door was estimated to be \$700.00.

I asked James if there were any security cameras at the barber shop and he advised that there were no cameras. I asked James if there was an alarm system at the location and he advised that there was not.

I did not observe any security cameras around the other businesses located by the barber shop.

I gave James a contact card with a case number. I advised James to call if any suspicious behavior occurs during business hours or if he discovers any new information. Currently the suspect in the offense is unknown.

On 05/05/2019 at approximately 2230 hours I, Sergeant Teske, was advised by MCSO Dispatch of a warrant service call. Dispatch advised me that MCSO Deputy Montes (5P1007) was currently en route to the MCSO Jail with Amanda Sivil (W/F; DOB xx) and Amanda was showing active warrants through the Oak Ridge North Municipal Court. Dispatch advised that Deputy Montes had Amanda in custody on other charges as well. I confirmed the following 4 active warrants:

#4145001 for Expired Registration (fine \$266.00).
#4145002 for Expired Operator's License (fine \$272.00).
#4145003 for Fail to Maintain Financial Responsibility (fine \$468.00).
#41450F01 for Failure to Appear/Bail Jumping (fine \$348.00).
The total fine amount was \$1,354.00.

I arrived at the MCSO Jail, located at #1 Criminal Justice Drive, and met with Deputy Montes. He advised that he add the Oak Ridge North warrants to his booking sheet. I left the warrants with Deputy Montes and returned to service.

On Friday 5/3/19 at approximately 16:55 hrs, I, Det. James Kipness, arrived at MCSO Central Jail Records to serve an Order of Commitment on Jordan, Jeremy Michael w/m dob xx. Mr. Jordan was already in custody at the jail on other charges. The ORN municipal warrants were for Fail to Maintain Financial Responsibility (#1100770, \$349.00) and Expired Registration (#110077002, \$291.00), for a total fine amount of \$640.00. After serving the warrants, I returned to service. End of narrative.

On Friday 5/3/19 at approximately 16:55 hrs, I, Det. James Kipness, arrived at the MCSO Central Jail Records to serve an Order of Commitment on Russell, Elijah Eli b/m dob xx. Mr. Russell was already in custody at the jail on other charges. The Oak Ridge North municipal warrants were for Expired Registration (#80488401, \$395.80), Violate DL Restriction (#80488402, \$397.10), Turned Right from Wrong Lane (#80488403, \$477.70), and FTA/ Bail Jumping (#804884F01, \$502.40). The total fine amount was \$1,773.00. After serving the warrants, I returned to service. End of narrative.

On May 06, 2019 at approximately 0900 hours, I Officer Saulter was leaving the parking lot of Oak Ridge North Police Department approaching Robinson Rd. when Officer Stafford and I observed two white males in a white Ford E250 van heading eastbound towards Hanna Rd not wearing their seatbelts. I pulled behind the van and activated my emergency lights and stopped the vehicle in the parking lot of the Montgomery County Community Center located at Robinson I exited my patrol car and approached the van on the and Hanna. left driver's side. The driver was identified as Andrew R. Hart (W/M DOB xx) from his Texas driver's license and the passenger was identified as Walter A. Cordova (H/M DOB xx) from his Texas Identification card. After speaking with the occupants of the vehicle, I returned to my patrol vehicle and ran them both through MCSO database. The driver showed to have a not eligible license due to a suspension for no insurance and the passenger showed to have an active warrant out of County Court of Law #1 in Montgomery County. Once I discovered this, I approached the passenger and asked him to exit the vehicle and I explained to him what I was about to arrest him for and take him to jail. I did a pat down and placed Walter in custody and he advised me that he understand why he is going to iail. He explained to me he was taking care of the issues and had court on 05/07/2019 in Willis, TX at Judge Wayne Mack's court (MCSO Pct 1). Due to me talking to the driver, the suspect told my partner (Officer Stafford) that he had a little bit of marijuana under the passenger seat in a black box. Officer Stafford located the black box under the passenger seat where Walter stated that it was. Officer Stafford handed the marijuana to me so I could place it into evidence. The marijuana was tested using a NIK test kit and had a positive test I then transported Walter to the MCSO South County Jail for result. booking without incident. Walter was issued an ORNPD citation #2840088 for no seat belt - passenger. After placing Walter into MCSO custody, I came back to the ORNPD office and Officer Stafford weighed the marijuana using an Ohaus triple beam balance and had an in-bag weight of 4 grams. The marijuana was placed into evidence.
