# **GENERAL RULES AND ELIGIBILITY**

#### THE HIGHLANDS SEASON PASS

One pass, three great mountains! The Highlands Pass offers unlimited skiing and snowboarding at Seven Springs Mountain Resort, Hidden Valley Resort, and Laurel Mountain. This is the best offer for snowsports enthusiasts in the area. That's THREE mountains of winter fun in the Laurel Highlands!

With this pass you can ski and snowboard on:

- 79 slopes and trails.
- More than 465 acres of skiable terrain.
- 9 terrain parks.
- More than 100 terrain park features.

# **GENERAL RULES**

- The pass is non-transferable.
- Laurel Mountain reserves the right to refuse any application.
- The Midweek Pass is valid Monday Thursday except December 25-28, 2017 and January 1, 2018.
- The Midweek Pass will be valid every session after March 5, 2018 through the end of the season.

### SKI AND SNOWBOARD ELIGIBILITY

- To qualify for the college pass you must be a full time student, ages 18-24, enrolled with at least 12 credit hours for the fall semester of 2017 and/or the spring semester of 2018. College students must supply a current college ID, a copy of their class schedule showing at least 12 credit hours for the fall semester of 2017 and/or the spring semester of 2018 and a current vaid drivers license at the time they pick up their pass. Not available for students in online or web-based universities.
- Junior rates apply to children who are between and including the ages of 12-17 at the time their pass is purchased.
- Child rates apply to children who are between and including the ages of 6-11 at the time their pass is purchased.
- Senior rates apply to individuals who are between and including ages of 65-69 when they purchase their pass.
- The Super Senior Pass is available to individuals who are between and including ages of 70-79 when they purchase their pass.
- The \$39 pass rate for Full Ski and Snowboard Season Pass and \$69 Highlands Season Pass Rate is available to children ages 5 and under and adults ages 80 and older at the time they purchase their pass.

# SKI AND SNOWBOARD PASS RULES

- Ski and Snowboard passes may be picked up starting November 25, 2017, weekends only 12p.m. to 4p.m.
- Once ski season begins, Skier Services will be open during slope operating hours.
- Your photo will be taken when you pick up your pass. YOU
  MUST HAVE PROPER IDENTIFICATION WITH YOU
  AT THAT TIME. There is no charge for the photo. DO NOT
  SEND PHOTOS.
- Season passes will not be issued until all information provided on this application is verified by the Laurel Mountain Skier Services staff and the waiver is signed.
- Laurel Mountain will not be responsible for contents of seasonal lockers.
- For everyone's safety, all skiers and snowboarders must obey
   Your Responsibility Code and Laurel Mountain's area policies.
- Laurel Mountain reserves the right to suspend or revoke any ski and snowboard pass for violation of area policies without refund.
- Pass must be visible and identifiable when entering the lift line.
   You must show pass when asked by Laurel Mountain staff.
- Defacement of season pass is prohibited.
- Pass is valid November 17, 2017 through the close of the season.
- Whoever would falsify, forge, counterfeit, alter or tamper with this Season Pass, or willfully allow any other person to have or to use it, or whoever impersonates the lawful person hereon shall be subject to local, state and federal laws.
- If your pass is lost or stolen, notify Skier Services immediately.
- Please protect your pass as you would your cash or credit cards.
- Replacement allowed one time only, at our discretion, at a charge of \$25.
- The Platinum Pass is transferable, but may be used by only one person on the slopes at a time.

#### SEASON PASS RELEASE AND WAIVER AGREEMENT

#### **ALL PASS PURCHASERS MUST SIGN BELOW**

In consideration for a season pass for use of slopes, trails, lifts, terrain areas, and other facilities related to downhill skiing or riding issued by Seven Springs Mountain Resort, Inc., dba Laurel Mountain Resort, its owners, officers, employees, agents, representatives, parents, and affiliates (hereinafter, "Laurel Mountain"), I agree:

- (1) that I understand that there is a risk of serious injury or death if I participate in skiing or snowboarding. It would be impractical to list all the risks. Some of the risks include, falls caused by bare spots, variations in surface and subsurface snow an ice conditions, variations in terrain and terrain area features (table tops, ramps, half-pipes, rails, etc.), bumps, moguls, stumps, rocks, other forms of forest growth and debris. Risks also include collisions with other persons, lift towers, poles, cables, snow making equipment, snowmobiles, grooming machines, fences, barriers, and other natural and manmade obstacles on and/or off of trails. Another risk is falls and collisions caused by the negligence of others, including Laurel Mountain. I acknowledge that it is my responsibility to follow Your Responsibility Code, Smart Style and all rules regarding terrain park use, all other instructions, rules and directions provided by Laurel Mountain, and to exercise caution and remain in control while participating.
- to accept all risks, whether specifically listed in paragraph (1) above or not, which arise out of or are related to the use of my season pass to ski or snowboard at Laurel Mountain.
- (3) that my season pass may be suspended or revoked, without reimbursement to me. if I do not follow the rules, instructions and directions of Laurel Mountain.
- (4) to waive my right to bring any claims against Laurel Mountain that arise out of or relate to my use of my season pass to ski or snowboard at Laurel Mountain, and to release Laurel Mountain from liability for any such claims. This waiver and release includes, but is not limited to, claims based upon allegations of negligence on the part of Laurel Mountain. I further agree that I will indemnify, hold harmless, and reimburse Laurel Mountain for all losses (including attorneys' fees and costs) from any claims brought by any persons or entities arising out of or relating to my use of my season pass to ski or snowboard at Laurel Mountain.
- (5) That the terms of this Agreement shall be binding on my heirs, executors, administrators and assigns, and shall be governed by the laws of the Commonwealth of Pennsylvania. I agree that all disputes arising under this Agreement shall be litigated in the Court of Common Pleas of Somerset County, Pennsylvania.
- (6) I grant Laurel Mountain permission to use photographic and/or video images of me for the purpose of marketing, publicizing and promoting the resort operations. I waive any right to be compensated for the use of my image and release Laurel Mountain from liability for any claims, where such claims arise out of or relate to Laurel Mountain's use of my image.
