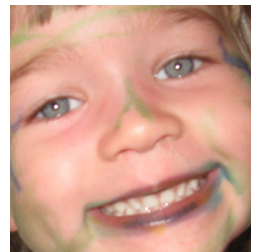

# Important

## Overview

Since July 2009 Rainbows United, Inc. has downsized from seven locations to three, sold two buildings, reduced staff by 45 percent, started repaying creditors, including the IRS withholding repayment, at 100 percent, and has a balanced budgeting plan for a solid future, all the while providing services to more than **3,000** children with special needs or at risk and their families in our community.

- **July 14, 2009** Executive Committee notified of financial irregularities and concerns
- **July 30, 2009** Rainbows United files Chapter 11 with US Bankruptcy Court
- **August 10, 2009** Hale Ritchie donates his time to Rainbows as Chief Restructuring Officer with Board approval
- **November 23, 2009** Kere Noel, CPA, hired by Board of Directors as Chief Financial Officer; Noel was hired by Rainbows in July as Financial Consultant
- **November 24, 2009** Business Ethics Policy adopted by Board of Directors
- **February 1, 2010** Restructuring Plan filed with US Bankruptcy Court
- **February 23, 2010** 18-month audit (January 2007 – June 2008) approved by Rainbows' Board of Directors confirmed no money left Rainbows and operating loss of \$2 million
- **March 1, 2010** Deb Voth named President
- **March 24, 2010** US Bankruptcy Court approves restructuring plan
- **March 30, 2010** FY 2009 (July 2008 – June 2009) audit approved by Rainbows' Board of Directors, confirms no money left Rainbows and operating loss of \$2.2 million
- **May 8, 2010** Warehouse auction of surplus items nets \$15,000
- **July 30, 2010** Rainbows emerges from US Bankruptcy court in less than one year
- **June 17, 2010** A NEW DAY campaign launched for \$2 million
