Annual Meeting - The AAA annual meeting is the largest gathering of anthropologists in the world with more than 6,000 participants. In addition to paper sessions there are roundtables, poster sessions and public policy forums, networking opportunities, a job fair, graduate school fair and an exhibition with approximately 100 booths.
