The following is a letter-from Student Council to Mr. Hargadon requesting a formal channel of communications. between the Admissions policy committee and SASS.

From: Student Council

Re: The status of policy relating to Black admissions

Both Student Council and SASS have cummunicated to you their belief that it is essential that SASS, in some formal and organized way such as through their college relations committee, be consulted in questions of policy with respect to Black admissions. Would you please inform us as to the status of these deliberations in your committee, of any plans you have for including SASS in these considerations, and of the timetable under which you are operating on these metters.

Student Council has been informed that the Dean of Admissions has been approached and asked to speak to two outside people well-versed in problems of Black admissions, and that he declined the offer. These two individuals are Harriet Michel from the National Scholarship Service Fund for Negro Students and William Adams, the assistant dean at the University of Pennsylvania. We feel that both of these people might be able to offer helpful insights into our own situation at Swarthmore and that it would be useful for them to speak to the Admissions Committee as well as to interested students. A meeting could be arranged, if you are willing.

We would appreciate hearing from you on each of these questions as soon as possible. Thank you very much for your attention.

Concerning your letter inquiring about the status of policy relating to the admission of Negro students to Swarthmore College, the following can be said at this time:

- 1) The Committee will be meeting next week to make final revisions in a tentative statement of policy recommendations to be submitted to the faculty for discussion. It is anticipated that such a discussion will take place immediately after the return from Christmas vacation. After having ascertained faculty views on the matter, we intend to distribute the tentative recommendations to all Negro students in order to ascertain their views on the subject. Hopefully a final policy statement would then be forthcoming within a week or so after that. This timetable would allow us to take such policy into consideration before making admissions decisions for this year.
- 2) The reasons why it has taken nearly a full semester to bring forth policy recommendations should be clear to anyone who has read the Phoenix during that period of time.
- 3) The Committee has (and will continue to do so) consulted all Negro students--including SASS and its members--on matters relating to the admission of Negro students. However, since all of us on the Committee carry other responsibilities in the College, we have had to bring our efforts to a conclusion as best we could within the limited time and resources available to us. We have patiently waited for replies to inquiries made in a letter sent to all Negro students last October 21st, but as yet have received not a single reply. (See especially the last two pages of the attached letter; please also not that this letter preceded your Council meeting of Nov. 6 by fifteen days.)

- 4. The Consitted met to bear the views of the College Relations
 Committee of SASS on November 3rd, at which time we discussed
 their ideas on recruitment and enrollment (later submitted to
 us in a memorandum.)
- 5. The Committee has sought the views of other colleges and universities regarding the matter at hand where their experiences seemed appropriate ones for us to draw upon. We have also consulted with various programs, e.g. the ABC and Transitional Year programs for information on programs of that nature. We have found in our consulting that it is very easy to gain great nembers of subjective opinions, and extremely difficult to gather any hardnesed information was facts concerning progress with risk programs, degree of difficulty of such programs, especially from colleges similar in their academic program to Swarthmore. We have written to an Assistant Dean of Admissions at Ponn, at the suggestion of SASS, and are expecting his reply with whatever pertinent information he has gathered on the subject. As for the NSSFNS' person recommended by SASS, I have spoken with her and suggested that we could more appropriately draw on her expertise at NSSFNS after Swarthmore itself, through its faculty, decided the order and degree of its priorities. (NSSFNS is a clearing house operation for Negro students throughout the country.)
- 6. The tentative recommendations being drawn up by the Committee will be in three parts: (A) recommendations concerning the recruitment and enrollment of Negro students at Swarthmore; (B) recommendations concerning certain 'student life" aspects of the experiences of Negro students in the College; and (C) recommendations concerning the contributions which the College might appropriately make toward enhancing the opportunities for Negro students to attend college in general.
- 7. I would emphasize that the recommendations the Committee is now working on will be tentative and none will be adopted without the provision of opportunities for full discussion by the Negro students already here.

From: Fred Hargadon, Chairman of the Admissions Policy Committee Re: Possible student representation of the Admissions Committee

Due to the press of other business, the Committee has not had time to fully explore the question of whether it whould have student members, or, if so, under what conditions. We briefly discussed the matter of student representation at the first meeting of the year, and while generally favorably disposed, came to no conclusion on the matter. Since the procedure for placing students on faculty committees subsequently underwent a change, the Committee will certainly wish to explore the question more fully when the opportunity presents itself. Given the timetable for getting out our recommendations on Negro student recruitment, I doubt whether we will get to the matter of student representation before second semester.

Dear Mr. Hargadon and members of the Admissions Committee,

Student Council has considered your tentative plans for presenting your proposals telating to black admissions and would like to express its conviction that an alternative plan might be more appropriate. It seems essential to us that students, especially black students, have an opportunity to make clear their positions on the tentative proposals before the faculty meets to discuss these proposals.

SASS and other black studentshave not been involved in formulating policy to any significant extent up to this point. We feel that it is important that they participate in making policy; their role should not be limited to that of commentators after the fact. Furthermore, it is entirely possible that these students would not reach the same conclusions on these matters as the range of opinions be clear to the faculty from the beginning. There is no reason for the faculty to have to spend extra time on these discussions because it was not initially aware of the opinions of all those people concerned.

Student Council hopes that you will seriously consider its proposal and move to make your tentative report known to all members of the community as soon as possible. Thank you for your consideration.
