The weighted average will be scaled to grades A (90-100), B (80-89), C (70-79), D (60-69), and F (0-59) and further used to differentiate all public schools.

TEA uses the Closing the Gaps domain to identify campuses that have consistently underperforming student groups. Any campus not identified for comprehensive support and improvement that has at least one consistently underperforming student group is identified for targeted support and improvement.
