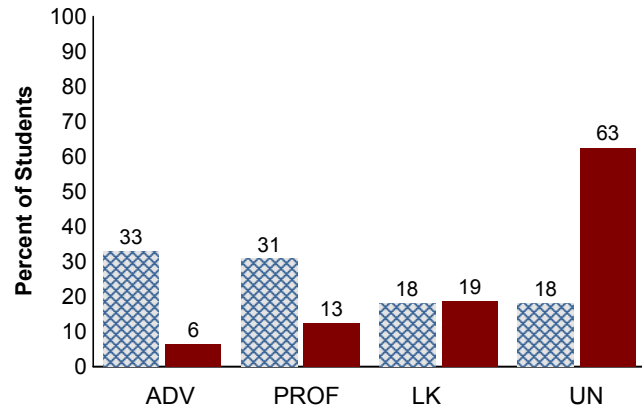
State and District Reading Results
