TRANSFER TRUCK SCALE

The transfer truck scale that is under the shoot at the Transfer Station building is in need of replacement. It was installed in 1995 when the building was built. It has rust issues that are standard for the kind of use we have. There are parts of the scale that have rusted clear through. Some places have sunken as much as 6 inches. Our operators have placed a metal plate over areas where the holes are so when the truck tires cross the area they don't fall through. One spot that is about to give out completely will drop the truck 2 feet when it breaks. There are also 3 bad load cells that would cost \$1300 each to replace. Estimates for a scale replacement are included in this packet. Our truck scale is inside of the building and therefore we have more issues to consider. If we were to choose a concrete deck scale, the crane used to reach into the building at an angle would have to be much larger and would incur more costs. A steel deck cuts down on the cure time from 10 days to 3 days. While the scale concrete is curing, the station will have to be closed.

1000 POUND RULE

There have been some questions concerning the 1000 pound rule. The rule was established in February 2015 and states that each individual/account receives 1000 pounds per month free. This is with the idea that each household that pays sales tax is entitled to use the Transfer Station for no fee on their normal household trash. However it remains to be seen exactly how much trash a "normal" household produces. After almost a year of data, it has been considered to up the amount to 2000 pounds. Using data in the billing system, the following information was gathered.

Total Accounts: 324

Total Accounts with over 1000 pounds but under 2000 pounds: 66

Total Tipping Fees as of November 1, 2015: \$234,793.56

Total Tipping Fees for accounts over 1000 but under 2000 pounds: \$559.95

TIRE MONOFILL

Solid Waste Site #2 (Effingham) has a Tire Monofill located on site. Questions have arisen concerning the use of the site. In 1994 when the MSW Landfill closed a large empty trench remained. Atchison County requested permission from KDHE to use the site as a tire monofill as opposed to purchasing dirt to fill in the trench. KDHE issued permit #233 (which now also includes the Transfer Station there), as a waste tire monofill. As of August 1997 records show approximately 70,000 tires had been deposited in the trench. An Operational Report approved by the state on August 18, 1997 states that the remaining volume would allow for 100,000-150,000 tires. Our records indicate roughly 5000 tires per year dumped at the site. It is impossible to estimate the length of time it will take to fill the trench.
