Regular Board Meeting  
July 18, 2013

The Harmony Grove School Board met in regular session Thursday, July 18 at 7:30 p.m. in the board room of the superintendent's office on the Harmony Grove School Campus.

Mr. Givens made a motion to approve SPA as the new speech therapy service provider. Mr. McCann seconded the motion. The motion carried 6-0.

Mr. Givens made a motion to approve Radio Works to broadcast football games for the 2013 season. Mr. McCann seconded the motion. The motion carried 6-0.

Mr. McCann made a motion to approve the use of the football field, field house, and practice field for pee-wee football. Mr. Bearden seconded the motion. The motion carried 6-0.
