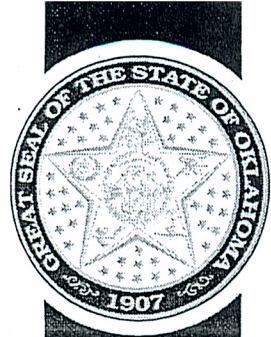
The school report card is a guide for us to use in planning for each year's academic skills. We will strive to improve the areas that are a challenge and celebrate the accomplishments our students achieved.

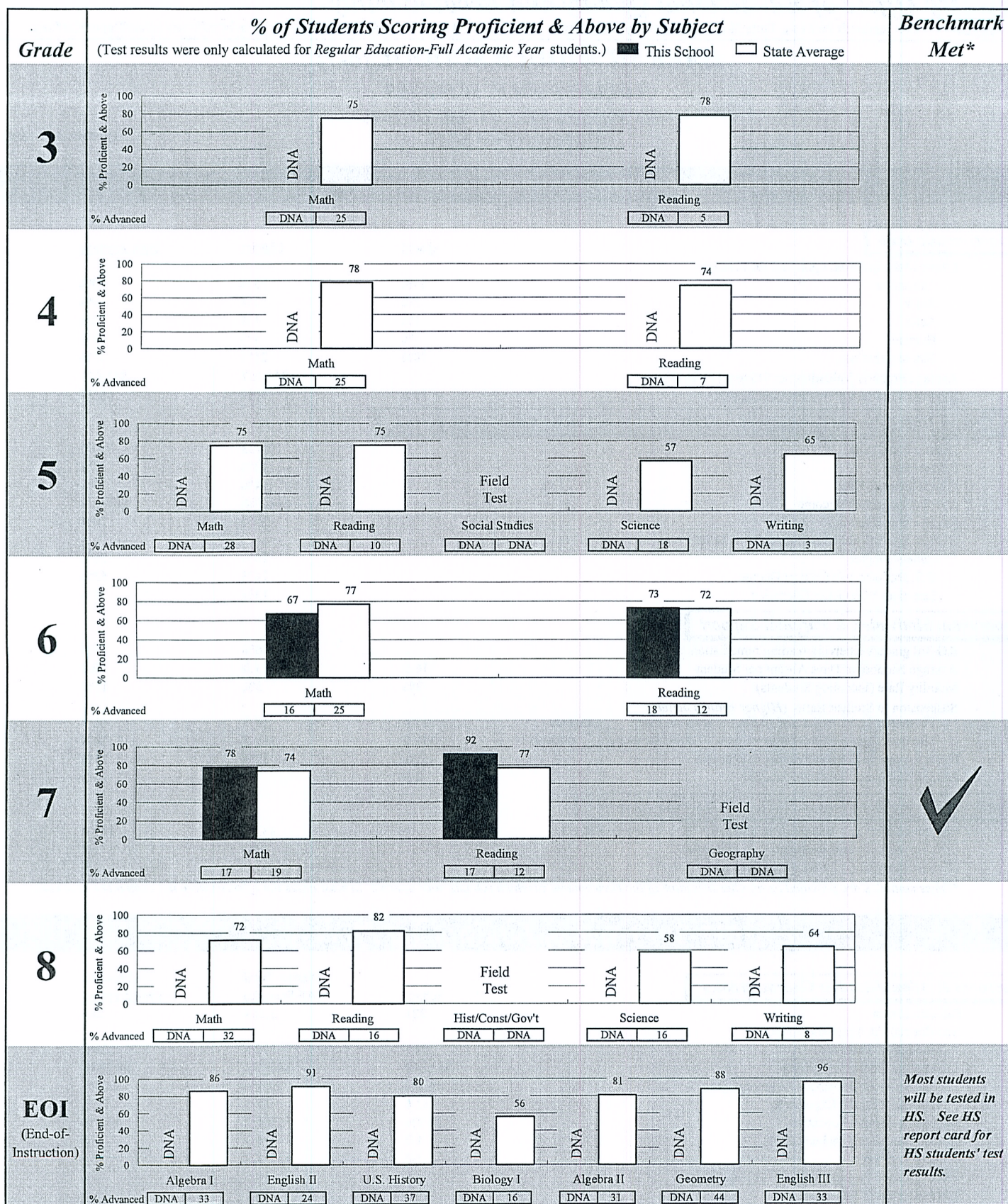

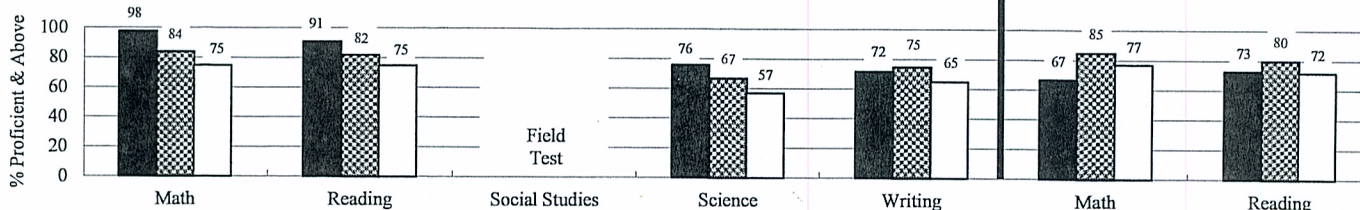
3rd Grade Tests*



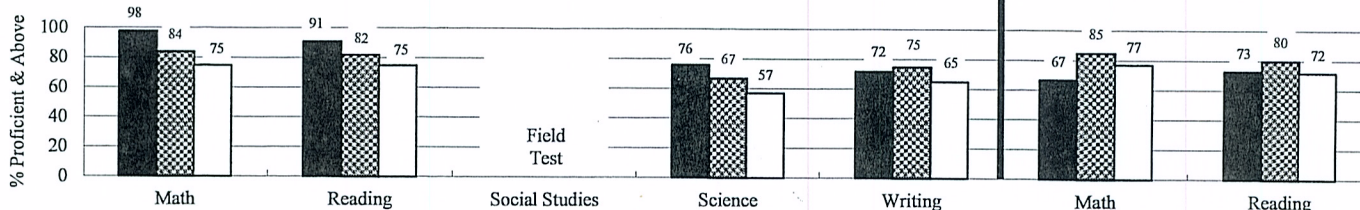
4th Grade Tests*



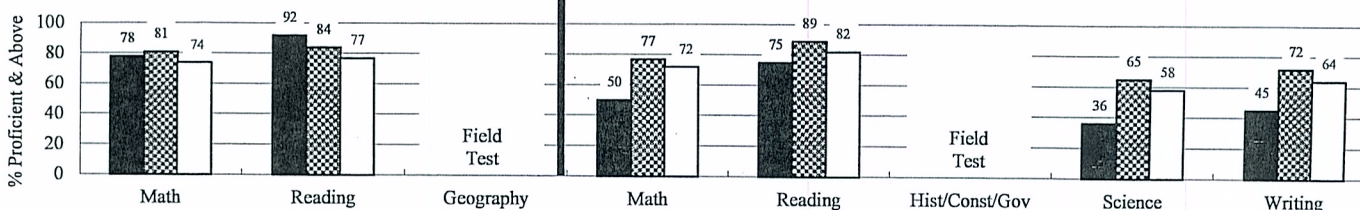
5th Grade Tests*



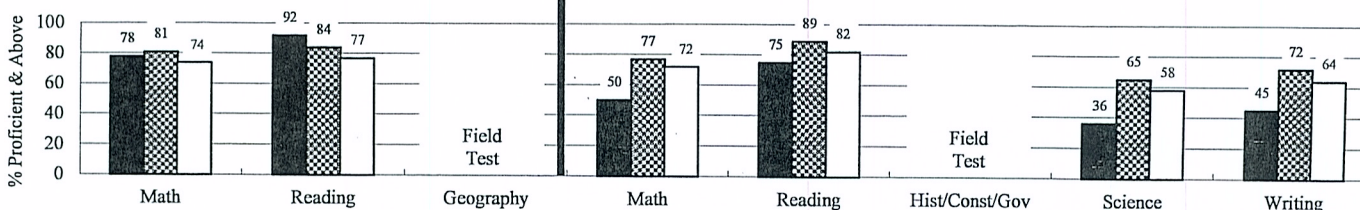
6th Grade Tests*



7th Grade Tests*

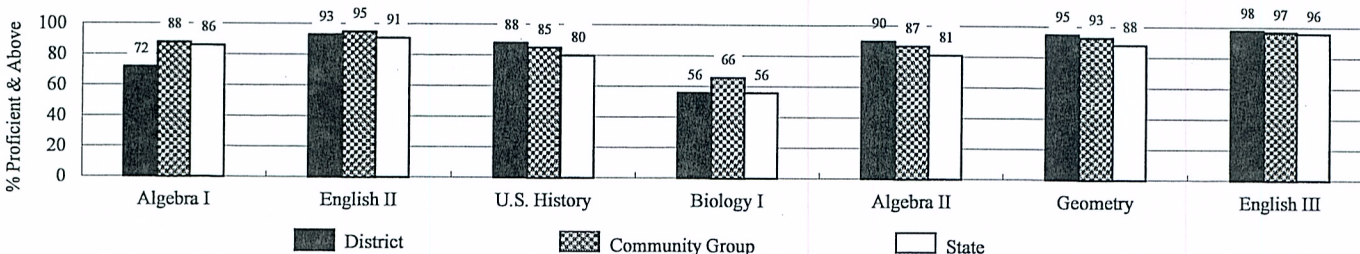


8th Grade Tests*
