

**LIS Parent & Family

PART I GENERAL EXPECTATIONS

The **Levelland Intermediate School** agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will work to ensure that the required school level parental involvement policies meet the requirements of section 1118 of the ESEA, and each include, as a component, a school-parent compact consistent with section 1118(d) of the ESEA. **(See Enclosure)**

1. The **Levelland Intermediate School** will take the following actions to involve parents in the joint development of its school parental involvement plan under section 1118 of the ESEA:

4. The **Levelland Intermediate School** will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:

All materials needed will be listed on school website and available for print upon request at the start of school.

5. The **Levelland Intermediate School** will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:

6. The **Levelland Intermediate School** will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:

Mailed report within 10 days of school receiving information.

7. The **Levelland Intermediate School** will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not certified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2002) by:

A written notice will be mailed to the families involved.

8. The **Levelland Intermediate School** will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph –

- the state's academic content standards,
- the state's student academic achievement standards,

- the state and local academic assessments including alternate assessments,
- the requirements of Part A,
- how to monitor their child's progress, and
- how to work with educators:

Gifted & Talented (GT), University Interscholastic League (UIL), Destination Imagination (DI), and Student Council.

9. The **Levelland Intermediate School** will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

Email/send home links to apps that are available through the textbook companies that we have adopted that are available for parents to download to help with student's work.

10. The **Levelland Intermediate School** will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

11. The **Levelland Intermediate School** will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Migrant, Bilingual/ESL, etc. (See Fed'l Program listing).
