**SUMMER SCHOOL 2020
COVID-19 SCREENING & HEALTH
GUIDELINES**

OVERVIEW

Redwater Independent School District has developed a plan for an in-person, on-campus summer school program for 9th-12th grade students. The program will be held at the Jr. High campus in the technology lab (7th grade building). All RISD staff and students participating in the summer school program will be subject to a COVID-19 screening each day of attendance.

PRIMARY GOALS

- Mitigate COVID-19 spread based in the practices and requirements in TEA guidance for Summer Instruction, Activities, and School Visits
- Maintain a safe and healthy environment for summer school students and staff
- Limit the risk of exposure by maintaining social distancing among students and staff
- Emphasize personal hygiene such as hand washing and use of hand sanitizer before, during, and after activities
- Implement routine and enhanced cleaning and sanitization of technology equipment, desks, chairs, and restroom facilities
- Plan and communicate safe access to the summer school learning environment that minimizes personal interaction in an effort to promote social distancing
- Require a daily health screening for all summer school students and staff

SCREENING REQUIREMENTS

Upon arrival each day of the summer school program, students and staff will be required to complete an online COVID-19 screening to ensure each individual in attendance is free of symptoms. Students and staff will use their personal device to complete the screening in efforts to minimize contact and to maintain a 6ft. distance. Students who do not own a personal device will be assigned a specific computer to access the online screening.

STUDENT REQUIREMENTS

1. Students will complete the required health screening prior to beginning the summer school program each day.
2. Physical Contact - Limit contact with others. No handshakes, high-fives, hugs, fist bumps, etc.
3. 6-Foot Rule - A space of 6 feet must be maintained between students and staff at all times.
4. Sanitization - Students must sanitize their hands before, during, and after the summer school program each day.
5. Students will bring their own, individually labeled, snack and/or drink that may not be shared with staff or other students.

STAFF REQUIREMENTS

1. Staff will complete the required health screening prior to beginning the summer school program each day.
2. Physical Contact - Limit contact with others. No handshakes, high-fives, hugs, fist bumps, etc.
3. 6-Foot Rule - A space of 6 feet must be maintained between students and staff at all times.
4. Sanitization - Staff must sanitize their hands before, during, and after the summer school program each day.
5. Staff will bring their own, individually labeled, snack and/or drink that may not be shared with other staff or students.
6. Staff will thoroughly inform students of summer school safety and health guidelines, and provide regular reminders of the expectations.

CUSTODIAL STAFF REQUIREMENTS

- Clean and sanitize restrooms before, during, and after summer school sessions
- Ensure hand sanitizer is available in restroom, in addition to cleaning solutions already in place
- Daily clean and sanitize technology lab in which summer school sessions are held

COVID-19 SYMPTOMS, TESTING, FOLLOW-UP

1. **When a staff member or student tests positive** - the group to which that staff or student was assigned and in contact with must be removed from the summer school sessions. **Students will be required to complete their summer school assignments through the At-Home Learning Format if this occurs.**
2. **When a staff member or student has any symptoms of COVID-19 or is diagnosed with COVID-19**, they should self-isolate and complete the remaining summer school assignments through the At-Home Online Learning Format.
3. **When a staff member or student is living with someone who experiences any of the symptoms of COVID** (whether they have a positive COVID test or not), they should self-isolate for two weeks and complete the remaining summer school assignments through the At-Home Online Learning Format.

PARENT/GUARDIAN COMMUNICATION

1. Information will be provided to all parents/guardians outlining the arrival and dismissal plan, as well as safety measures that will be in place.
2. Summer School Staff will make themselves available via email or phone call for questions related to the safety plan.
3. Parents will be updated immediately if any changes are made to the summer school guidelines related to COVID-19.

EDUCATION & TRAINING FOR SUMMER SCHOOL STAFF

- All summer school staff will be provided with safety and health guidelines prior to the start date of June 15th.
- District Administration will remain available throughout the duration of the summer school program to assist staff with questions or concerns related to the guidelines in place.
