Eufaula Virtual School follows the Eufaula Public School District Calendar.

Students enrolling in a virtual class for first time credit must complete all virtual coursework outside of the regular 7 period school day and must be enrolled in 7 class periods during the school day, in addition to the virtual class.

Students must enroll in virtual classes no later than the first full week of each semester.

Eligibility for virtual classes taken for first time credit or taken during the 7 period school day will run at 3:00 pm every Friday, or at the end of the school week. Students whose “Actual Grade” is below 60% will be marked as ineligible for the following week and will adhere to OSSAA eligibility guidelines for participation in extracurricular activities.

Virtual classes must be completed by set end date or students will receive a letter grade of “F” on his or her transcript.

Students who fail or do not complete a virtual class will not be eligible to enroll in further virtual classes without a parent/student/administrative meeting.
