**Goal 1:** 6th Grade Academy will utilize various communication strategies to provide additional information to parents and to increase Parent and Family Engagement in supporting classroom instruction.

# Strategies for reaching goal:

- The school will distribute a monthly newsletter to parents that is developed with participation of the parent-school organization, principal, staff and parent volunteers. It includes school news, a calendar of school activities, and parenting tips related to school achievement such as homework tips, organizational skills, and study skills.
- The school will create a Web site to house classroom Web sites for each teacher. Homework assignments and pertinent classroom information will be available on classroom Web sites. Also, parents can access their child's grades using a PIN number they received at the beginning of the school year. Parents may use e-mail to communicate with members of the school staff.
- The school will provide to parents reports/report cards every four weeks with information regarding their child's academic progress and upcoming classroom and school events.
- Teachers call parents twice within each nine weeks grading period. Phone logs are completed and submitted to the principal.
- The school will use the student handbook, school Web site, signage at the school entrance, and parent orientation meetings about the Schoolwide Title I Plan and how to get a copy upon request.

Goal 2: 6th Grade Academy will host parent meeting, conferences and activities regularly throughout this year, offering flexible meeting times, to increase Parent and

Family Engagement and build staff and parent capacity to engage in these types of efforts.

# Strategies for reaching goal:

- Teachers will hold conferences individually with parents of children in their classrooms. Parents will also be given suggestions for coordinating school-parent efforts and explanations of homework and grading procedures.
- Meetings will include parent training sessions to help parents understand how to enhance their child's education. They will include a Literacy Night and a Math Night.
- The school will offer parents a special workshop each year to provide an explanation of the statewide assessment system, standards, and other accountability measures.

# Description of the supports to be provided to engage parents and community in the school's Turnaround Efforts and Parent and Family Engagement Analysis:

One important aspect of Turnaround Efforts is partnering with parents. Parents will be provided materials, strategies, data analysis, and homework support in order to assist students with best practices that will lead to proficiency.

# **Support for Parents of Non-Proficient Students**

Parents will be provided the 2018-2019 ACT Aspire individualized reports for their children. After each Interim assessment, parents will be informed of their child's progress and areas that need to be strengthened. Categories will disaggregated into Reporting Categories: Exceeding, Ready, Close, and Needs Support. Parents will also be provided seminars and resources that will support ELA, Math, and Science proficiency. Parents will have an opportunity to have their child enrolled in the 6th Grade Academy Afterschool Program. Students will be provided differentiated support in literacy and math. They will also be given a meal and transportation home. Parents will receive professional development with technology in areas such as interactive websites, kindles, google classroom, and Chrome Books. These tools will be utilized to increase proficiency and support parents.

# **Support for Parents of Proficient Students**

In order to support parents of proficient students, parents will be introduced to strategies that will provide enrichment. Parents will be given materials such as books for book studies, flash cards, examples of ACT Test formatted questions, and writing samples. The Power Reading Intervention Program will also be utilized to reinforce enrichment of literacy through technology. Parents will engage in seminars that will give them a testing experience that mirrors what their children will experience for the spring ACT Aspire summative testing. In addition, parents will also be enlightened of the keyboarding expectation.

Data analysis will be afforded to parents to emphasize the challenge of not only remaining proficient, but reaching to the Exceeding Reporting Level category.

# **Community Support for Turnaround Efforts**

External stakeholders such as the public library, EEOC, and the Great Rivers Coop collaborate with the school staff to provide literacy support for parents. Community stakeholders offer classes that will support math proficiency in programs such as real estate and banking seminars. Four high school seniors also provide tutoring assistance and small group guided math instruction in the areas of literacy and math. Volunteers will provide materials and hands on activities that will give students real world application of math strategies and standards that they have learned in their math classes. The 4 H Club Volunteers provide outdoor science activities that integrate classroom and laboratory experiences for the children. Students also design an outdoor garden that they have the opportunity to utilize science hands on learning.

**Goal 4:** 6th Grade Academywill work with parents to create a School-Parent-Compact.

#### Strategies for reaching goal:

School staff, parents, and students will develop a school-parent-student compact. This compact will outline how parents, school staff, and students share the responsibility for improving student academic achievement and the means by which the school and parents will build and develop a partnership to help children achieve the state's high academic standards. All stakeholders will sign the compact. This compact was revised to include all teachers that the students have for all content areas (literacy, math, science, and social studies).
