Active member of the American Welding Society North Texas Section where he served in many local and national positions.

Purpose

This endowment was made possible through the American Welding Society North Texas Section. Many friends and colleagues of Tim E. Hatten wish to continue his legacy.

Eligibility

- 1. Applicant must be a citizen of the United States and a member in good standing in the North Texas Section.
- 2. Applicant must meet all AWS requirements to become a CWI.
- 3. Applicant must provide a personal statement or written paragraph which is designed to include how they intend to use their CWI in the future.
- 4. Documentation of previous hands on welding experience or engineering experience.
- 5. Applicant must submit all required application information.
- 6. Proof of financial need is required to qualify.
- 7. Applicant will be asked to participate in an interview.
- 8. Applicants may reapply.

AWS does not discriminate by age, race, color, national origin, disability, creed or gender.

Selection

Scholarship applicants will be evaluated by a committee consisting of no less than 3 people. The Tim Hatten Memorial Scholarship committee shall consist of AWS North Texas Section Board members.

Every year the Committee will also consist of as many Hatten family members as wish to participate.

The top five (5) scholarship applicants will be given the opportunity to interview with the Committee in person, on the telephone, by Skype, video conference or whatever technology is available for use at the time.

Awards

The committee will decide on top applicants in any quantity between one and five. The money may be divided among those candidates in any way the committee sees fit. As one option, a dollar figure may be assigned to each point. The point values shown below represent the maximum points that each committee member can award the applicant. However, any lesser value can be assigned, including zero, where the applicant does not satisfactorily meet the scholarship criteria.

The funds will only pay for the actual testing fees charged by AWS at time the applicant is taking the exam. Any expenses for hotel fees, travel and meals will be the responsibility of the applicant. If the applicant represents the North Texas Section during the one-week seminar prior to the exam, the one-week seminar is free of charge to the applicant.

Recipient is required to submit a 5 x 7 head and shoulders color photograph for publicity purposes.

Applicant participated in interview.	4
Participates in civic or charity events in the spirit of giving their time. This could be participating in AWS meetings and section activities, church or other civic organizations.	3

Applicant must submit the following:

- 1. Application (form)
- 2. Documentation of previous hands-on welding experience or engineering experience.
- 3. Personal statement or biography documenting your ambitions, goals, leadership and any other factors to assist the committee in judging your eligibility.
- 4. Statement of financial need.
- 5. Proof of current membership (copy of current membership card)
- 6. Letter from church or charity organization to document involvement in charity events.
- 7. Proof of registration for AWS CWI Exam (before funds will be paid to applicant).
