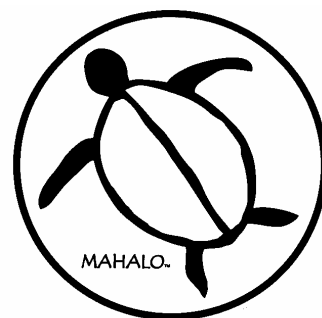

## 6 mile ocean swim

### Sunday, July 11, 2010

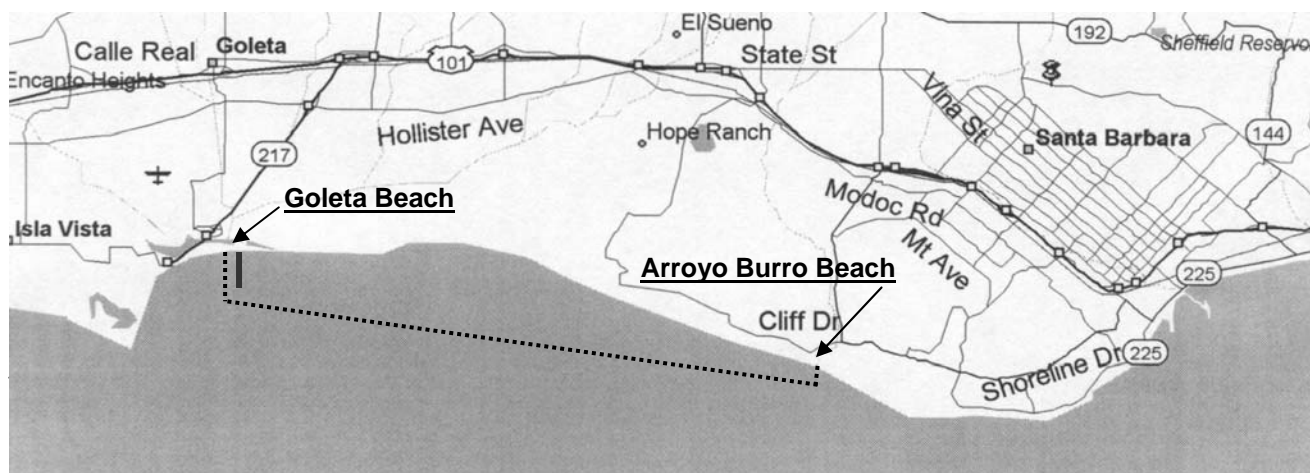
Sanctioned by SPMA for USMS # 330-022

- COURSE:** Goleta Beach to Arroyo Burro Beach **FOR EXPERIENCED SWIMMERS ONLY**  
Start on the west side of Goleta pier. Swim to the end of the pier, turn east, and swim down coast ~6 miles to a buoy off of Arroyo Burro beach. Round buoy and swim to shore.
- TIME:** Race starts at 9:00am. Check in starts at 7:30am.
- RULES:** USMS Open Water Swimming rules govern.  
All swimmers must have 2010 USMS number.  
\*\*Participants must bring paddler and board/kayak to accompany them in the ocean swim.  
NO EXCEPTIONS.
- ENTRY** \$40.00 **No beach entries.** All entries must be received by July 2, 2010
- FEE:** Food and beverages provided at the finish.  
Custom long sleeve t-shirt: \$15.00
- AWARDS:** Places 1<sup>st</sup>- 5<sup>th</sup>, men & women  
Hand crafted, custom awards  
Awards ceremony immediately after the last swimmer finishes.
- OTHER:** Water temperature varies from 58° to 65° in June and July.  
There is no charge for parking at either Goleta County Beach Park or Arroyo Burro Beach.  
Course and distance to be altered subject to conditions at time of race.

\*\*\*"As in the tradition of open water swimming, the use of wet-suits or other non-porous attire, kickboards, gold chains, booties, paddles, swim buoys, body suits, triathlon suits, fins, gloves, or other wimpy contraband will not be allowed. No exceptions!!"\*\*\* circa 1982, before the new open water rules.
