Dear Chief Hickman,

I want to take this opportunity to express my interest in filling the empty seat on the Montecito Fire Protection District Board of Directors. For the past two and a half years, I have regularly attended the Board meetings as well as many sub-committee meetings. During this process, I have closely followed the Financial Analysis and Standards of Cover / Risk Assessment studies along with the Tea Fire rebuild issues.

I personally experienced our neighborhood burning in the Tea Fire and know first hand the devastation that it brings to all of those affected; not just the event itself but the many years after that it takes to rebuild an entire community with hundreds of homes.

Having attended the Fire District's Board meetings on a regular basis, I feel that I have learned a great deal about the Fire District and what it's Board members are tasked with; this would allow me to transition to the Board with a minimal learning curve. I am confident that I can contribute to the Board with an informed perspective going forward and bring the diversity that is important to all organizations. My focus would be to work collaboratively with the Board to ensure that the residents of Montecito receive equitable emergency services across the entire community, that our first rate emergency personnel continue to receive the training that is required to maintain the high level of service that they bring to our community, and that the Fire District remains fiscally strong. Finally, I want to ensure that the excellent vegetation mitigation program and funding sources for that program remain a priority for protection of the community.

The knowledge I have gained by attending the Board meetings for nearly three years has made me very familiar with the issues and studies conducted by the District. MARSHA R. ST. CLAIR RESUME 7/15/15

St. Clair graduated with a Bachelor of Science Degree from the University of Wisconsin in 1960 with two majors: one in Psychology and another in Correctional Administration (i.e. Prison Administration, Probation, Parole).

She worked as a plain-clothes Policewoman for the city of Madison, Wisconsin from 1960-1962 and then for the city of Bloomington, Minnesota as a Detective from 1962-1965.

From 1965-1968 she worked for Elgin State Hospital, Elgin, Illinois as a Social Worker and therapist, preparing patients for re-entry into their communities.

From 1968-1978 St. Clair worked opening and managing restaurants in Kansas City, Missouri, owning her own from 1973 until selling in 1978.

In 1978 she was trained by and worked for Merrill Lynch as a registered stock broker and money manager. In 1983 she left Merrill to join the Southgate Bank and Trust Company where she managed the trust company's individual trust portfolios, the bank bond portfolio, three trust company mutual funds (equity, income and money market), and performed asset/liability management for the bank. As portfolio manager of the mutual funds in the trust company, St. Clair consistently ranked in the top 5% of income funds and the top 10% of equity funds across the country.

When the bank was sold in 1993, St. Clair retired as President and Chief Investment Officer of the Trust Company and Vice Chairman of the Bank Holding Company and moved to Montecito.

Upon moving to California, St. Clair incorporated in 1995 (St. John Premium Investing, Inc.), became licensed by the SEC and the State of California as an Investment Advisor, and began managing private and corporate equity portfolios in 1996. Her three-year average annualized return on the managed equity portfolios was 21.72% (1997, 1998, 1999).

In 2000 she semi-retired, managing only the portfolios of family members.

Since moving to Montecito in 1993 St. Clair has been active in several charitable organizations, the main ones being Girls, Inc. of Santa Barbara, the Council on Alcohol and Drug Abuse, and Join-Up International, Inc. She was previously a board member for the first two and remains a board member of Join-Up International, Inc.
