



OFFICIAL RETURN OF LEASE

- This form is a legal document and all sections must be fully completed, signed and witnessed before the Lease will be accepted.
Under no circumstances will The Arabian Horse Society of Australia Ltd. (hereafter called The AHSA Ltd.) enter into any dispute between the parties involved.
If ANY section of the document has been altered or deleted The AHSA Ltd. has the right to not accept the document.
The correct fee (as described on the current Scale of Fees on our website www.ahsa.asn.au) must accompany this Return of Lease to The AHSA Ltd.
The Original Registration Certificate must also accompany this Return of Lease to The AHSA Ltd. If the Original Registration Certificate is lost, a letter from the current registered owner must be provided with this Return of Lease stating the facts of the loss and quoting the name and registration number of the horse. If this is necessary then a fee of \$15.00 is required for the duplicate certificate.
Lessees and Lessors of Stallions must be Ordinary, Overseas, Company or Life Members of The AHSA Ltd. Lessees and Lessors of Fillies or Mares must be Ordinary, Overseas, Company, Life or Junior Members of The AHSA Ltd. Lessees and Lessors of Geldings must be current financial Ordinary, Overseas, Company, Life, Junior or Associate Members of The AHSA Ltd.
Foal Recorded Colts cannot be leased. Colts must be adult registered prior to leasing.
Where Lessees or Lessors comprises more than one person, all parties must sign the Return of Lease unless a Form Of Authority has previously been lodged with The AHSA Ltd. authorising it to accept any other signature or combination of signatures.
Please ensure your application is fully completed and correct as a \$20.00 requisition fee will be enforced for paperwork which is lodged incorrectly.

We hereby certify that the horse was leased for the above mentioned period or until earlier termination of the lease by virtue of the death of the horse, mutual agreement or expiration of the term of the lease. We forward herewith the original certificate of registration of the horse and authorise and request The AHSA Ltd. to retain this until the expiry or earlier termination of the lease and in the meantime to issue us respectively with a "Lessor's Copy" and a "Lessee's Copy" of such certificate bearing the lease expiry date. In the event of early termination of the lease for any reason, we each respectively agree to notify the Society in writing thereof within 30 days of termination and (if the horse is a mare) in such notification to advise if any unregistered or expected foal (whether born or "in utero") is to be registered as the property of either the lessor, the lessee or the lessor and lessee jointly.

+ As the horse leased is a mare then if it foals one or more live foals during the currency of the lease, we hereby authorise and request the Society to record the registration thereof as the property of: THE LESSOR\* THE LESSEE\* THE LESSOR AND LESSEE JOINTLY\* subject to them making the requisite application and paying the requisite fee. NOTE: Lessees cannot use mares for Embryo Transfer without written consent from the owner being lodged with the Society.

+ As the horse leased is a stallion then if it is used to serve mares during the currency of the lease we hereby authorise and request the Society to accept as sufficient for its purposes the signatures of: THE LESSOR\* THE LESSEE\* THE LESSOR AND LESSEE JOINTLY\* on the relevant Breeding Documentation, Service Certificates and Returns wherever they are required to be supplied or lodged. NOTE: Lessees cannot freeze and store semen without written consent from the owner being lodged with the Society.

In the event that the said lease is renewed or extended we hereby agree that we will duly renew this lease and we understand that if we do not renew this lease before the expiry date of the lease, full fees will be required to be paid to the Society to renew after the expiry date. We hereby indemnify and hold blameless The AHSA Ltd. in respect of all claims, suits, costs, damages and expenses whatsoever which might be brought against or claimed from The AHSA Ltd. by any person, firm or corporation related to or arising out of such lease of the horse described.
