All Arabian stallions or colts which were born on or after 1/8/2000 must have carrier test results for SCID, CA & LFS recorded with AHSAR Ltd in order to be nominated for use at stud from 1/8/2015.

* Arabian stallions or colts which were born prior to 1/8/2000 must have carrier test results for SCID, CA & LFS recorded with AHSAR Ltd in order to nominate for use at stud as from 1/8/2015 only if they are used to serve Arabian mares or fillies not owned or leased by the owner or lessee of the stallion at the time of service.

STALLION BREEDING DOCUMENTS 2017/2018 TO ALL MEMBERS/BREEDERS 1/8/2017 – 31/07/2018

Prices quoted on this document include GST

1. There is a \$15.00 nomination fee which is non-refundable for each stallion to be used for natural service for the 2017/2018 Season.
In addition there is an extra \$15.00 nomination fee (non-refundable) for each stallion to be used for artificial insemination (AI) in the 2017/2018 season.
Members must specify whether their stallion is to be used for natural service, AI or both. Members contemplating AI service are advised to refer to the Society's Regulations for conditions of use or contact the Society.
2. Service certificates will be available from the Society at a cost of \$20.00 each.
For applications for registration received by the Society as from 1st August 2010 no service certificate is required if the **“owner/lessee of the stallion at the time of service = owner/lessee of the mare at the time of foaling”**.
3. AI Transported (Chilled) or Stored (Frozen) Service Certificates are available for \$20.00 each to be used when semen is transported, or has been stored. Please note lessees of stallions may only store semen & purchase Stored Semen Service Certificates with written permission from the stallion owner.
4. As from 1/8/2011 all Arabian fillies, mares, stallions & colts (to be adult registered) conceived using frozen semen (either domestic or imported) must be tested for SCID, LFS & CA prior to their registration being completed. Carrier foals will still be registered. Foal Recorded colts must supply SCID, LFS & CA results before being fully registered as a stallion.
5. Service certificates not used will be refunded or can be used for the next breeding season. If a refund is required they must be returned in mint condition. Service certificates on which the stallion/mare details have been altered will not be accepted for the purpose of registration of foals.
6. All Arabian stallions must have a DNA result on record with the Society before they will be approved for use at stud.
7. As from 1/8/2011 any Arabian stallion to be used at stud for the first time must be tested for SCID, LFS & CA prior to the nomination being accepted. Carrier stallions will still be approved for use at stud.
8. **Derivative Stallions born after 1/8/2000 MUST have DNA results on file.**
9. The following relates to Purebred Arabian Stallions & Colts which are resident in Australia and alive as at 1/8/2014 in order to be nominated for use at stud.
 - All Arabian stallions or colts which were born on or after 1/8/2000 need to have carrier test results for SCID, CA & LFS recorded with AHSA Ltd in order to be nominated for use at stud from 1/8/2015.
 - Arabian stallions or colts which were born prior to 1/8/2000 need to have carrier test results for SCID, CA & LFS recorded with AHSA Ltd in order to nominate for use at stud as from 1/8/2015 **only** if they are used to serve Arabian mares or fillies not owned or leased by the owner or lessee of the stallion at the time of service.Carrier test results will be recorded by the Society where the stallion has been tested, is clear by parentage or is a carrier by offspring.
10. If you have supplied the Society with SCID, LFS & CA results for your stallion that you agreed to have published the nomination fee will be waived once for the first season results are supplied.
11. No nomination fee is required for stallions 25 years of age or older, however they must still be nominated and service certificates must be completed if required.
