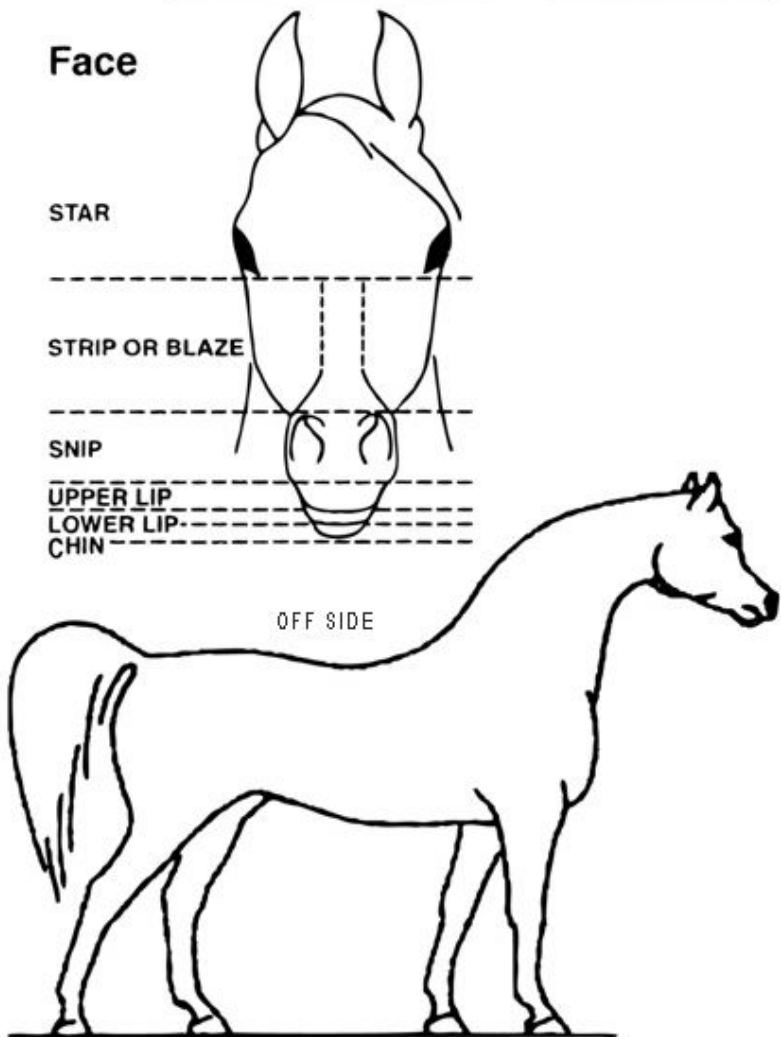
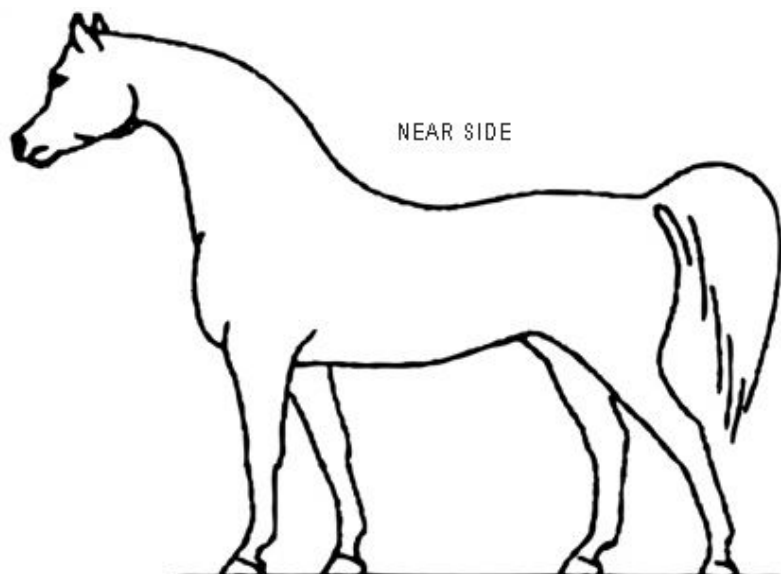




**MARKINGS**

- THESE DIAGRAMS WILL BE REPRODUCED ON REGISTRATION CERTIFICATES
- DRAW NEATLY AND CLEARLY but do not draw or write around diagrams.
- All white markings and any brands must be drawn and coloured in using a dark coloured pen or felt tip pen.
- All pink skin MUST be drawn.
- Faint facial markings without pink skin may also be recorded on non-greys.
- If horse is grey, only markings with underlying pink skin are required.
- BOTH SIDES of horse must be shown (ie, leg markings must be drawn from both inside and outside views).
- If markings are incorrect, the form will be returned.
