This agreement is entered into this _____ day of _____, 2021 by **SOUTHERN BELLE BREEDERS** a division of the **OQHA** hereinafter referred to as Show Management and _____, hereinafter referred to as Stallion Owner, and owner of Stallion _____, with Registration # _____ for the 2021 Southern Belle Breeder's Program. This stallion is registered with the following organizations: _____, _____, _____, _____.

Stallion Owner states above referenced stallion will stand for an advertised breeding fee or private treaty of \$ _____. The advertised breeding fee is the amount that the Stallion Owner expects to collect in U. S. dollars for the Stallion's service. This fee is not inclusive of chute fees, office fees, mare care etc., which the Stallion Owner may charge to all mare owners. Owners are encouraged to state these additional fees so that the mare owner may have complete knowledge.

The Southern Belle Breeder's will not accept breeding fees or private treaties under \$500. In the event that an invitation is extended to a stallion with an advertised breeding fee of \$500 or a private treaty of \$500 or less, the Southern Belle Breeder's price for that stallion will be no less than \$500 plus \$100 office fee.

Stallion Owner agrees to allow The Southern Belle Breeder's to collect one breeding fee at ½ the advertised fee plus \$100 office fee and for such monies to be paid directly to The Southern Belle Breeder's Program. In the event that an advertised breeding fee or private treaty is \$500 or less, The Southern Belle Invitation will sell the breeding at \$500 plus \$100 office fee. Stallion services sales will be sold from October 1, 2020 to June 1, 2021.

Stallion Owner agrees that in the event this donated breeding has not sold for ½ the advertised breeding fee or private treaty plus \$100 office fee by June 1, 2021, the Stallion Owner may pay up the Stallion for ½ the advertised breeding fee plus \$100 office fee.

Stallion Owner acknowledges that by **signing this document he/she does not forfeit any rights to collect from mare owner fees that may be attributed to services for mare care, chute fee, and or shipping fees, etc.**, that the Stallion Owner would normally charge individuals using the Stallions service. The Stallion Owner declares at this time that other applicable charges may include but not be limited to (and are subject to change at the Breeder's discretion):

Stallion Owner understands that by donating this breeding to be sold by The Southern Belle Breeder's Program for the 2021 season, the offspring of the above referenced Stallion will be eligible for Breeder's Classes held during the 2021 show season. Failure of the Stallion Owner to pay up his/her Stallion by June 1, 2021 will result in the Stallion Owner being excluded from the 2021 Breeder's Classes and will not be allowed to be reinstated in future Southern Belle Breeder's Programs until past years stallion fees are paid in full. Stallion Owner understands that once the donated breeding sells for ½ the advertised breeding fee plus \$100 office fee by June 1, 2021 or is paid up by the Stallion Owner for ½ the breeding fee plus \$100 office fee, that the Stallion Owner will receive 20% of the winnings of the Southern Belle Breeder's eligible entries. Stallion Owners receive 20% of all prize money earned by eligible offspring. Premier Breeder's Classes will payback 10%. Stallion Owner's not paying up a stallion service by June 1, 2021, will forfeit the 20% Breeder's winnings. Individuals other than the Stallion Owner's may elect to pay up a stallion into the program, to make an offspring eligible.

This document constitutes the entire agreement and any legal proceedings will be held in Ohio where The Ohio Quarter Horse Association is incorporated. The Southern Belle Breeder's reserves the right to make amendments, additions and/or changes as is indicated to comply with legal requirements recommended by counsel and for the purpose of improving and enhancing the breeder's program.

The Breeder is asked to display Southern Belle Breeder's Logo on all advertisements to indicate to exhibitors and potential purchasers that your stallion's offspring are eligible for Breeder's winnings through Southern Belle Breeders. The logo can be provided to you by us at our website, www.oqha.com.

Stallion Owner's signature/designated agent's signature, on this contract obligates Stallion Owner to allow Southern Belle Breeder's to sell one breeding to the above registered Stallion for the 2021 breeding season.

Southern Belle Breeder's enrolled stallions will be recognized by name in the Congress Souvenir Program. Additionally, Southern Belle Breeder's enrolled stallions may advertise in the Southern Belle Breeder's section of the Congress Souvenir program at a 50% discounted rate.
