The application of Plaintiff Marcela Balquinta, et al for temporary restraining order upon their Original Verified Petition for Declaratory and Injunctive Relief, was presented to me on the 28th day of December, 2012, with notice to counsel for Defendants Texas Department of State Health Services ("DSHS") and Kyle Janek, in his official capacity as Executive Commissioner of the Texas Health and Human Services Commission; Defendants have accepted service of the Petition. Counsel for all parties appeared before me on this date to present argument.

The Court does not find that an immediate, concrete and irreparable injury, loss or damage will likely result to the Planned Parenthood Plaintiffs before a temporary injunction hearing can be held.
