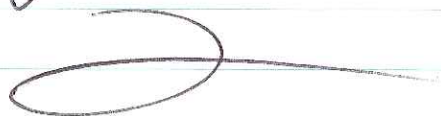

I keep thinking about things that I need to tell you and clarify for you so I return my pen to paper and hope to enlighten you as dawn breaks through my bared window once again. I'm a severely Brittle Juvenile Type 1 insulin dependent Diabetic with the Somogyi Effect! The Somogyi Effect which I suffer from is a rare but deadly and very hard to control form of severe brittle Diabetes which is caused by a stress hormone routinely released in my sleep during dream activity. And the acute but extremely rare Somogyi Effect causes my blood glucose to spike to extraordinary high levels and simultaneously causes my blood sugar to plummet into the teens and single digits ^{without warning.} These dangerous Hyperglycemic and Hypoglycemic episodes are very detrimental to my health and the over all longevity of my life! And subsequently the primitive and barbaric nature of the penal setting hampers my ability to properly, adequately, and efficiently care for my rare Diabetic condition!

Some times in my dreams I can still hear my spurs clicking against the mexican bank tile floor as I walked in the big double doors with my saddle bags hanging prestigiously over my right shoulder with one-hundred dollar ^{bills} poking out while my 44 revolvers hung in hand tooled swedish leather holsters at my hips!

Just so you know I was housed at even the Polunsky Unit in Livingston Texas where death-row is housed, last year. And remember I'm a State Jail Inmate! I'm not legally supposed to be housed with institutional division offenders or aggravated violent offenders who committed hideous crimes against society! I'm a first time Non-Violent inmate sentenced to State Jail! "The truth is

on my side and has always been my number one virtue and in the end that's all that truly matters without regard to what the Reprobate Texas Courts decide!" My ^{Grand Father} ~~Grand Father~~ once told me something I'll never forget when I was 4 years old while feeding the chickens! He said to me Quote "Roddy you have to stand for something other wise you will fall for any thing!" Well I'm standing, I'm standing strong and firm while fighting for what I believe in. And I'll never back down!

Because some birds just weren't meant to be caged, and some broncos just weren't meant to be broke!

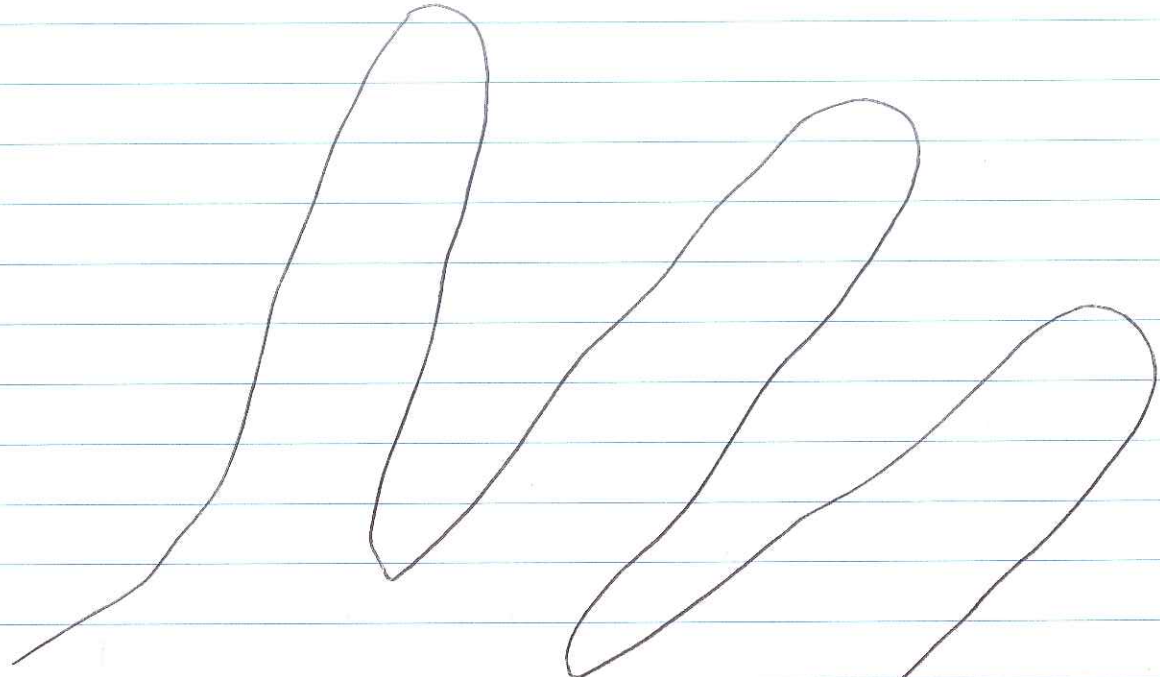
The reason that I excepted the four consecutive two year state jail sentences is because the then Distict Attorney Dan Mike Bird threatened to stop giving me insulin, medical attention, and all medication, and he told me Quote "Mr. Pippin if you don't sign the plea agreement for these four two year state jail sentences I'll see to it that you die in this solitary cell and immediately stop getting your insulin shots." End Quote Dan Mike Bird is now the district Judge in Hardeman County. He and other Hardeman and Wilbarger County authorities threatened vicious retaliation and retribution against me physically and judicially!

I was hospitalized habitually over and over again due to complications with my Diabetes including hypoglycemic and hyperglycemic episodes and Diabetic Ketoacidosis! I was found on my cell floor numerous times close to death and life-less having Low Blood Sugars in the single digits! I'm honestly surprised that I survived county jail in Vernon and Quanah Texas! But I did and I'm still alive to tell "The Rest of the Story" as the late Paul Harvey would say! I feared for my Life therefore I regretably excepted D.A. Dan Mike Bird's ultimatum in order to save my Life and now here I sit being forced to serve even more time than I was illegally sentenced to serve!
