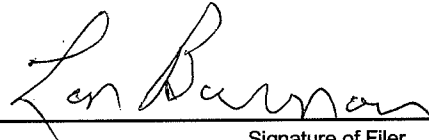

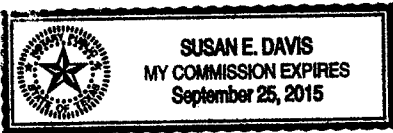
PERSONAL FINANCIAL STATEMENT AFFIDAVIT
