  1. No abusive language or cursing
  2. No smoking in or around the playing area prior to or during games.
  3. No consumption of alcoholic beverages, or other controlled substances in or around the playing area.
  4. No verbal or physical objections to an umpires ruling, although you may request a private discussion.
  5. No unsportsmanlike conduct such as berating opponents, failure to shake hands or participate in other after game ceremonies, derogatory comments about players, coaches, umpires, or any other actions deemed by the leagues Board of Directors as a violation.
  6. I will be responsible for the behavior and conduct of my assistants.
  7. Failure to abide by league rules and conducts can result in dismissal from this organization.

## Coach's Code of Conduct

I understand that my responsibilities as a youth coach are of great importance and that my actions have the potential to significantly influence the youth athletes I coach. Therefore, I promise to uphold the following rights of young athletes to the best of my ability:

- The right to have fun.
- The right to participate at a level commensurate with each child's maturity and ability.
- The right to have qualified adult leadership.
- The right to play as a child and not as an adult.
- The right to participate in safe and healthy environments.
- The right to proper preparation for participation.
- The right to be treated with dignity.

I also promise to conduct myself in accordance with the following:

- Treat all athletes, coaches, officials, parents and administrators with respect and dignity.
- Learn the fundamentals, skills, teaching, evaluation techniques and strategies.
- Become familiar with the rules, guidelines and objectives and communicate them to my athletes.
- Respect the authority, rules and decisions of administrators, league and game officials.
- Conduct practices and games so all athletes have the opportunity to achieve success.
- Communicate to my athletes and parents their rights and responsibilities.
- Ensure athletes, parents and spectators follow all park rules and regulations.
- Ensure athletes, parents and spectators conduct themselves with good sportsmanship.
- Provide an environment that is free of tobacco, alcohol and drugs.
- Will treat each athlete as an individual with respect to their ability.
- Will not tolerate any form of child abuse, be it physical, emotional, ethical or sexual and will report any such abuse to the youth programs administrators or proper authorities.
