I refer to your e-mail dated 12 November2018, which was acknowledged on the 13 November 2018.

We are treating your e-mail as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your e-mail you requested the following information:

- "1. Whether the police service/force 'the service' pays any external organisations to advertise vacant police officer and police staff roles on their website.
- 2. For a list of websites / organisations the service uses to advertise police officer and staff roles (excel format) and how much each website/organisation received from the service in the three most recent financial years

2016/17

2017/18

If no money was paid to advertise the roles, please indicate this on the spreadsheet.

3. For an email address and contact information for the HR department or relevant department responsible for publishing and promoting vacancies within the service. Note: Everything in this FOI relates to the financial years 2015/16 to 2017/18. If the cost limit exceeds that which is allotted, then start from 2017/18 and work backwards."

A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do hold information in scope of your request.

On occasion, the Ministry of Defence Police does pay external organisations to advertise police officer vacancies. Police staff vacancies are advertised through the Civil Service jobs website.

2. For a list of websites/organisations the service uses to advertise police officer and staff roles (excel format) and how much each website/organisation received from the service in the three most recent financial years: 2015/16, 2016/17 and 2017/18. If no money was paid to advertise the roles, please indicate this on the spreadsheet.
