Thank you for your email of 2 March in which you requested the following information:

I am requesting information about the medical process that entry's go through during the selection process of becoming an army officer and general medical questions, that may not seem clear or understandle for myself and others. The following questions to which I hope can be answered by yourselves are:

1. If you have red/green colour deficiency which job roles and regiments will this exclude you from joining.

2. When you go to an medical assessment what is the full iterinary for the day/what is the process that entry's will go through, is possible a detailed explaination will be great thanks.

I am treating your correspondence as a request for information under the Freedom of Information Act (FOIA) 2000.

A search for the information has now been completed within the Ministry of Defence, and I can confirm information in scope of your request is held.

The minimum colour perception (CP) entry standard for an Officer is Standard 4 (CP 4) as detailed in Section 3, Annex G Assessment of Red/Green Colour Perception (CP), Joint Service Publication 950, Medical Policy, Part 1, Leaflet 6-7-7 (Joint Service Manual of Medical Fitness).

However, certain Officer roles require a higher standard. Those in the Maritime Cadre of the Royal Logistics Corps require a standard of Standard 1 (CP 1). The Intelligence Corps require a standard of Standard 2 (CP 2). Army Air Corps Direct Entry Ground Officer, Adjutant General Corps: Royal Military Police and Military Provost Service and Royal Logistics Corps (bar the Maritime Cadre) all require a standard of Standard 3 (CP 3).

Whilst the MOD holds information in relation to which tests are carried out as part of a medical assessments, it does not hold a set itinerary of which order these are carried out in. However, under Section 16 of the Act (Advice and Assistance) you may find it helpful to note that;
