Complete Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement ("Agreement") – MINOR Driving Participant, Teen Driver

IN CONSIDERATION of the minor child whose name and signature appear below ("Minor") being permitted to complete, observe, work for, or participate in any way in any Motor Vehicle Event (defined as any riding, instruction, touring, or any activities involving a motor vehicle that are offered or sponsored by any BMW Group entity or contractor) or participating in any manner in any other motor vehicle functions, whether testing, recreational, instructional or competitive, or any activity requiring special authorization, credentials, or permission to enter any area to which admission by the general public is restricted or prohibited (collectively, "Motor Vehicle Events"), THE UNDERSIGNED PARENT OR LEGAL GUARDIAN, for himself and Minor, and their personal representatives, heirs, and next of kin, contracts and states as follows:

1. This Motor Vehicle Event requires physical stamina, adequate motor coordination, and mental alertness. The roads and off-road areas on the BMW Performance Center, and the roads, off-road areas, and highways offsite on which Minor will be riding, including both public and private roads, streets, highways, paved and unpaved surfaces, are challenging, potentially dangerous, are subject to varying weather, surface and traffic conditions beyond BMW Group's or Minor's control, and present a significant risk of accident, injury or death to Minor and/or others, and damage to property owned by myself, Minor or others.

2. Minor is solely and completely responsible for the safe operation of the motor vehicle provided by any BMW Group entity, including compliance with all traffic laws, motor vehicle safety instructions and regulations, and that the BMW Group entities are not responsible for Minor's actions in any way. Complete Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement (“Agreement”)

IN CONSIDERATION for being permitted to complete, observe, work for, or participate in any way in any Motor Vehicle Event (defined as any riding, instruction, touring, or any activities involving a motor vehicle that are offered or sponsored by any BMW Group entity or contractor) or participating in any manner in any other motor vehicle functions, whether testing, recreational, instructional or competitive, or any activity requiring special authorization, credentials, or permission to enter any area to which admission by the general public is restricted or prohibited (collectively, "Motor Vehicle Events"), THE UNDERSIGNED, for himself and his personal representatives, heirs, and next of kin, contracts and states as follows:
