We are in receipt of your letter to Roger Ailes dated January 20, 2011 which we received this morning via messenger. We note the letter was publicly disseminated yesterday attached to a related press release. Therefore, we doubt this is a sincere effort on your part to stop hostile public speech, but rather an attempt to create ill will for our company. In fact, most of your letter concerns posts made on theblaze.com, a website having nothing at all to do with Fox News.

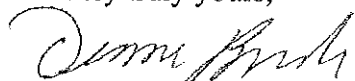
That said, we did look into the items made in your letter insofar as they relate to Mr. Beck's services for Fox News. There were only two such entries, i.e. portions of the January 12th and January 17th program. On many episodes of Mr. Beck's program, including the January 12th episode, we note that Mr. Beck specifically denounces violence, regardless of ideological motivations, and has steadfastly defended everyone's right to freedom of speech, including Ms. Piven.

You should also know that Mr. Beck has been covering Ms. Piven's teachings, writings, and pronouncements for many months. Ms. Piven is a prominent political activist and scholar, and Mr. Beck uses Ms. Piven's own words, taken from articles, speeches and video clips, where she explains her theories and teachings.

With regard to theblaze.com, please contact Christopher Balfe, the CEO of Mr. Beck's company, Mercury Radio Arts. With regard to your quotes from September 13th, we could not find those on Mr. Beck's television program. Mr. Balfe can address issues concerning Mr. Beck's radio program. Fox News neither owns nor has control over Mr. Beck's radio show.
