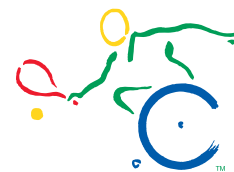

Airports:	LaGuardia International Airport (LGA), John F. Kennedy International Airport (JFK).
Meals:	All meals will be served at the tournament site, Banquet TBD.
Banquet:	June 6 th (Saturday), 7:00 p.m. (location to be announced)
Schedule of Play:	TBA (will be posted at the tournament desk and the tournament hotel)
Draw Sizes:	According to ITF regulations for the Open Main and Second Divisions.
Prize Money:	\$10,000, breakdown of individual prizes will be posted at the tournament and tournament hotel.
Competition Courts:	Surface Type: Deco Turf II, 2 indoor courts for Quad Divisions and 10 outdoor courts including Arthur Ashe Stadium.
Practice Courts:	Available upon request. Limited availability, sign-up at the tournament desk.
Wheelchair Storage:	Available at the tournament desk.
Stringing:	Available at the onsite proshop for a fee.
Waiver of Claims:	All players entering ITF sanctioned wheelchair tennis events, including the Wheelchair Tennis Tour, agree, as a condition of their entry, that no claims are brought against the ITF and the National Association sanctioning such events, with respect to any injuries, however caused, or any losses incurred, if any, while travelling to and from, or participating in, any Wheelchair Tennis Tour events. It is therefore required that all players have adequate medical insurance coverage.
Transportation:	A shuttle will be available between the LaGuardia Plaza Hotel and the Billie Jean King USTA National Tennis Center. The shuttle schedule will be posted at the tournament and the tournament hotel. Transportation between the tournament hotel and the airports in the City of New York (LaGuardia International Airport and John F. Kennedy International Airport) will be available (please call ahead with specific flight information). <u>Please note:</u> Transportation from Newark International Airport will be at the player's expense.

All necessary fees must accompany entry application. No refund after draw has been made.
