## 2017 US Open Player Legal Consent Waiver

Each Player is required to sign the 2017 US Open Player Legal Consent Waiver before the player is allowed to compete in the 2017 US Open.

Please note that players under the age of 18 will need to submit a hard copy of the 2017 US Open Player Legal Consent Waiver via scan/email to usopenentries@usta.com and require the signature of a parent or legal guardian.

In consideration of the acceptance of my entry, I acknowledge the risks associated with participating in the 2017 US Open Tennis Championships and/ or any event staged in connection therewith (collectively, the "2017 US Open"), accept those risks voluntarily and hereby for myself and on behalf of my heirs and legal representatives release and discharge United States Tennis Association Incorporated ("USTA"), USTA National Tennis Center Incorporated, the City of New York, and each of their respective officers, directors, employees, volunteers and representatives (collectively, the "Released Parties"), of and from any and all claims and demands of every kind, nature and character for any loss, injury, damage, which I may suffer or sustain, by negligence or otherwise, to the fullest extent permitted by law in connection with any aspect of the 2017 US Open, including but not limited to any action and/or decision taken regarding the conduct of any matches.

In consideration of the acceptance of my entry, I hereby agree to abide by all applicable rules, regulations and codes of the USTA, Grand Slam Board, ITF, ATP World Tour or WTA, and the 2017 US Open including but not limited to the following: (1) Every player must be dressed in a professional manner for all matches. Clean and customary tennis attire must be worn. The Referee will have the authority to order the player to change his/her attire immediately if, in his opinion, it is not acceptable. Failure of a player to comply with such order may result in immediate default, and the player will be fined according to the Grand Slam Code of Conduct; (2) At all times while on-site at the 2017 US Open (both on-court and off-court including press conferences), no commercial identification shall be displayed by player other than as specifically permitted by the 2017 Official Grand Slam Rule Book; (3) Other than where approved in advance in writing by the USTA, players are strictly forbidden from taking and/or transmitting any motion pictures, still pictures, sound recordings and/or other audio-visual content at the US Open in accordance with the terms and conditions set forth in the 2017 US Open Player Handbook and Credential application; and (4) Players shall not continuously collect, disseminate, transmit, publish or release from the US Open grounds any match scores or related statistical data ("Statistical Data") during match play (from the commencement of a match through its conclusion) for any commercial, betting, or gambling purpose. In particular, players shall not use any communication device (including, without limitation, a mobile telephone. tablet or laptop) to transmit Statistical Data to a third party in connection with the placing of a bet or for any improper, corrupt, fraudulent or otherwise unlawful purpose whatsoever. As between the parties, the USTA remains the sole and exclusive owner of the Statistical Data. I am aware of and accept that: (1) The Referee will have the authority to take any action he deems necessary in the interests of the US Open, including but not limited to defaulting a player, without any resulting liability for any of the Released Parties; (2) I am strictly prohibited from requesting a 2017 US Open Credential and/or player ticket for any person(s) other than my coach, trainer, family members and bona fide guests whose attendance is directly related to my participation in the 2017 US Open. 2017 US Open Player Guest Credentials and player tickets, if available, may only be used for legitimate player guests (no resale or transfer by player guest), and player may not receive any direct financial or other benefit as consideration. The USTA will hold me responsible for any sale, purchase or transfer of my 2017 US Open Coach/Trainer/Player Guest Credentials and/or player tickets under the Grand Slam Code of Conduct and may also revoke my coach/trainer/player guest credential and/or player ticket privileges in the future; and (4) The USTA will hold me responsible under the Grand Slam Code of Conduct for the behavior of anyone receiving a 2017 US Open Credential and/or player ticket at my request. In addition, I am aware of and accept that: (1) I am strictly prohibited, directly or indirectly through others, from wagering anything of value in connection with the

2017 US Open; (2) I am strictly prohibited, directly or indirectly through others, from offering or receiving anything of value to or from any person with the intent to influence any player's efforts in the 2017 US Open; (3) I will strictly adhere to the Uniform Tennis Anti-Corruption Program; and (4) Any violation of these regulations will subject me to severe financial penalties as well as a maximum penalty of permanent suspension from play in all Grand Slams.

I hereby authorize a physician, dentist, emergency medical technician or other medical personnel to provide medical or dental treatment or diagnostic services (including but not limited to x-rays, MRIs, other diagnostic examinations, and the disbursement of medication) to me in the event that I become ill or sustain an injury. I am aware of and accept that: (1) I may be required to undergo anti-doping testing imposed upon the 2017 US Open by authorities outside its control and/or the governing bodies of the sport; (2) I authorize any entity responsible for such anti-doping testing to notify the USTA should it be determined that I have violated the Tennis Anti-Doping Program and/or any other applicable anti-doping regulations; and (3) I may be required to forfeit all 2017 US Open prize money, if any, that I earn in connection with the 2017 US Open should it be determined that I have violated the Tennis Anti-Doping Program and/or any other applicable anti-doping regulations. I am aware of and accept that: (1) The US Open is subject to extension and/or cancellation (in whole or in part) due to force majeure or other events as determined by the USTA in its sole discretion; and (2) The USTA reserves the right, in its sole discretion, to reduce and/or reallocate prize money in the event the US Open is cancelled in whole or in part, for whatever reason.

In consideration of the acceptance of my entry: (1) I hereby agree that I will not compete in any other tennis tournament or tennis exhibition staged during the 2017 US Open (August 28 - September 10); (2) I hereby agree that I will be respectful of US Open sponsors, television partners, business partners, and all attendees; (3) I acknowledge and agree that all rights in data in any way produced and/or generated during the US Open, including but not limited to statistics, live scoring, player analysis technology data and similar data (collectively, "Data"), vest in USTA and are available to USTA for its use, including licensing, assignment and/or other promotional and commercial purposes. To the extent I have any rights in the Data. I grant and assign those rights irrevocably to USTA without compensation to me, my heirs, executors. administrators or assigns; and (4) I hereby grant to the USTA and its assignees the right to use or authorize the use of my name, voice, likeness, signature and biographical material without additional compensation for the purpose of publicizing, promoting and advertising the USTA and its affiliates including but not limited to the US Open Series and the US Open, and for the televising. broadcasting and filming of the same; and hereby grant and assign to the USTA and its assignees in perpetuity throughout the world the right to make, use, show and reproduce in any way now known or hereafter devised, for commercial and non-commercial purposes without additional compensation, still pictures, motion pictures, sound recordings, posters, live, taped or filmed television taken of me during the 2017 US Open; provided, however, the use of my identification (e.g. name, photograph, likeness, biography, voice, etc.) shall not be identified as or represented to be an endorsement by me of any product, service or company.

I acknowledge and accept that: (1) The player guest boxes in various stadiums may be equipped with microphones and/or cameras and I will advise my guests accordingly; and (2) I am solely responsible for knowing my match time and court location, and failure by the USTA to provide email notifications does not absolve my responsibility.

In further consideration of the acceptance of my entry, and to assist the USTA in its mission to promote and develop the growth of tennis, I hereby agree to: (1) Cooperate with the media in reasonable pre-match interviews, post-match interviews, press conferences (including, if requested, US Open Media Day, interviews on-court and finals ceremonies; (2) Participate, if requested, in Arthur Ashe Kids' Day on Saturday, August 26, 2017, or another reasonable promotional activity (not to exceed 60 minutes) related to the 2017 US Open; (3) Participate, if requested, in the 2018 US Open Draw Ceremony should I win the 2017 US Open; and (4) At the request of USTA and its official broadcast partner, make an appearance immediately following my match at the outdoor/olaza

desk for a post-match interview. In addition, I understand that the men's and women's singles champions at the 2017 US Open are expected to participate in additional promotional activities organized by the USTA (to include media interviews and personal appearances) in and around New York City on Monday, September 11, 2017. My participation in any of the promotional activities outlined herein shall not be identified as or represented to be an endorsement by me of any product, service or company.

I understand that: (1) Entry by my agent or through the ATP World Tour or WTA in no way diminishes the application of the above rules; and (2) I will not be allowed to collect my credential or participate in any competition at the 2017 US Open until this Entry Form has been duly signed by me. This agreement shall be construed in accordance with the laws of the State of New York, USA, without regard to its principles of conflicts of laws. Any dispute arising under this agreement shall be litigated in a federal or state court of competent jurisdiction located within the County of Westchester, State of New York, USA.
