FROM BINGHAMTON AIRPORT TO SITE :

- FOLLOW AIRPORT ROAD TO ROUTE 17W TO EXIT 70S (ROUTE 201S)
- GO 0.4 MILES AND TAKE RIVERSIDE DRIVE EXIT
- AT THE TRAFFIC CIRCLE FOLLOW SIGNS FOR RIVERSIDE DRIVE (SECOND EXIT OFF OF THE CIRCLE)
- FOLLOW RIVERSIDE DRIVE FOR ABOUT 1.9 MILES AND TAKE A LEFT ONTO BEETHOVEN STREET
- SITE IS AT THE CORNER OF SEMINARY AVENUE & BEETHOVEN STREET

FROM HOTEL TO SITE:

- RIGHT ONTO HARRY L DRIVE
- MAKE FIRST LEFT ONTO ROUTE 201 SOUTH
- GO 0.9 MILES AND TAKE RIVERSIDE DRIVE EXIT
- FOLLOW ABOVE DIRECTIONS

FROM I-81 & ROUTE 17 TO SITE :

- TAKE EXIT 4S (ROUTE 7S) TO ROUTE 363S
- CONTINUE ON ROUTE 363 - IT BECOMES RIVERSIDE DRIVE
