DIRECTIONS

FROM AIRPORT TO HOTEL: TAKE I-295 SOUTH TO EXIT 12 SOUTH BLANDING BOULEVARD SOUTH. MERGE ONTO BLANDING BOULEVARD. TURN LEFT ONTO YOUNGERMAN CIRCLE. HOTEL IS ON LEFT. (APPROX. 25 MILES)

FROM AIRPORT TO SITE: TAKE I-95 SOUTH TO I-295 SOUTH THEN ONTO BLANDING BOULEVARD SOUTH, MAKE RIGHT ONTO ARGYLE FORREST BOULEVARD. STAY ON THIS ROAD UNTIL YOU SEE EAGLE LANDING ON YOUR RIGHT (APPROX. 8 MILES).

HOTEL TO SITE: TAKE YOUNGERMAN CIRCLE TOWARD BLANDING BOULEVARD. TURN RIGHT ONTO ARGYLE FORREST BOULEVARD. CONTINUE ONTO OAKLEAF PLANTATION PARKWAY. CONTINUE STRAIGHT AT TRAFFIC CIRCLE. TURN RIGHT INTO EAGLE LANDING. TAKE FIRST LEFT TO GET TO COURTS. (APPROX. 10 MILES)
